Currently, several statutes require a person to donate to a nonprofit organization to qualify for a special license plate. The fee is sometimes set in statute, and sometimes the fee is limited by statute. The bill authorizes the organization to increase by \$10 the minimum donation for the issuance of the plate. Beginning July 1, 2019, this amount may be

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, 42-3-207, **add** (8) as
3 follows:

4 **42-3-207. Special plates - rules - new plates - retirement.**

5 (8) NOTWITHSTANDING ANY OTHER PROVISION OF THIS PART 2, EACH
6 ORGANIZATION THAT ISSUES A CERTIFICATE AUTHORIZING A PERSON TO
7 OBTAIN A GROUP SPECIAL LICENSE PLATE UPON PAYMENT OF A SPECIFIED
8 MINIMUM DONATION MAY INCREASE THAT MINIMUM DONATION BY TEN
9 DOLLARS. BEGINNING JULY 1, 2019, AN ORGANIZATION MAY ANNUALLY
10 ADJUST THE DONATION INCREASE AUTHORIZED BY THIS SUBSECTION (8) TO
11 ACCOUNT FOR A CHANGE IN INFLATION. THE ORGANIZATION SHALL ROUND
12 THE INFLATION ADJUSTMENT UPWARD OR DOWNWARD TO THE NEAREST
13 ONE-DOLLAR INCREMENT.

14 **SECTION 2. Act subject to petition - effective date -**

15 **applicability.** (1) This act takes effect at 12:01 a.m. on the day following
16 the expiration of the ninety-day period after final adjournment of the
17 general assembly (August 8, 2018, if adjournment sine die is on May 9,
18 2018); except that, if a referendum petition is filed pursuant to section 1
19 (3) of article V of the state constitution against this act or an item, section,
20 or part of this act within such period, then the act, item, section, or part
21 will not take effect unless approved by the people at the general election
22 to be held in November 2018 and, in such case, will take effect on the
23 date of the official declaration of the vote thereon by the governor.

24 (2) This act applies to license plates issued or reissued on or after
25 the applicable effective date of this act.
