**A BILL FOR AN ACT**

101    **CONCERNING THE PROVISION OF TRAINING MATERIALS RELATED TO**  
102            **HUMAN TRAFFICKING BY THE DEPARTMENT OF PUBLIC SAFETY,**  
103            **AND, IN CONNECTION THEREWITH, MAKING AN APPROPRIATION.**

**Bill Summary**

The bill requires the division of criminal justice to provide human trafficking training to law enforcement agencies and entities that provide services to human trafficking victims. The training may include:

- !       Train-the-trainer programs;
- !       Direct trainings; and

! Online training programs.  
The training may be provided to law enforcement agencies, organizations that provide direct services to human trafficking victims, school personnel and parents or guardians of students, and any other organization, agency, or group that would benefit from such training. The training must be developed in consultation with the Colorado human trafficking council. When considering requests for training, the division should give priority to requests from areas of the state that have limited access to training resources. Beginning in 2019, the council's annual human trafficking report must include an update on the trainings provided.

1 *Be it enacted by the General Assembly of the State of Colorado:*

3 **SECTION 1.** In Colorado Revised Statutes, **add** 24-33.5-521 as  
4 follows:

5 **24-33.5-521. Human trafficking training.** (1) THE DIVISION  
6 SHALL SERVE AS AN ADDITIONAL RESOURCE TO PROVIDE TRAINING  
7 RELATED TO HUMAN TRAFFICKING. THE TRAINING MAY INCLUDE:

8 (a) TRAIN-THE-TRAINER PROGRAMS;

9 (b) DIRECT TRAININGS; AND

10 (c) ONLINE TRAINING PROGRAMS.

11 (2) UPON REQUEST, THE FOLLOWING ENTITIES MAY RECEIVE  
12 TRAINING FROM THE DIVISION:

13 (a) LAW ENFORCEMENT AGENCIES;

14 (b) ORGANIZATIONS THAT PROVIDE DIRECT SERVICES TO VICTIMS  
15 OF HUMAN TRAFFICKING;

16 (c) SCHOOL PERSONNEL AND PARENTS OR GUARDIANS OF  
17 STUDENTS; AND

18 (d) ANY OTHER ORGANIZATION, AGENCY, OR GROUP THAT WOULD  
19 BENEFIT FROM SUCH TRAINING.

20 (3) TRAINING CURRICULA PROVIDED BY THE DIVISION MUST BE

1 DEVELOPED IN COLLABORATION WITH THE COLORADO HUMAN  
2 TRAFFICKING COUNCIL CREATED IN SECTION 18-3-505.

3 (4) WHEN EVALUATING REQUESTS FOR TRAINING, THE DIVISION  
4 SHALL GIVE PRIORITY TO REQUESTS FROM AREAS OF THE STATE THAT HAVE  
5 LIMITED ACCESS TO OTHER TRAINING RESOURCES.

6 (5) ON OR BEFORE JANUARY 17, 2019, AND EACH YEAR  
7 THEREAFTER, THE DIVISION SHALL INCLUDE AN UPDATE ON TRAININGS  
8 PROVIDED BY THE DIVISION IN THE ANNUAL HUMAN TRAFFICKING REPORT  
9 REQUIRED BY SECTION 18-3-505 (4)(b).

10 (6) THE DIVISION MAY ACCEPT AND EXPEND MONEY, GIFTS,  
11 GRANTS, DONATIONS, SERVICES, AND IN-KIND DONATIONS FROM ANY  
12 PUBLIC OR PRIVATE ENTITY FOR ANY DIRECT OR INDIRECT COSTS  
13 ASSOCIATED WITH THE DUTIES OF THIS SECTION; EXCEPT THAT THE  
14 DIVISION MAY NOT ACCEPT MONEY, GIFTS, GRANTS, DONATIONS, SERVICES,  
15 OR IN-KIND DONATIONS IF ACCEPTANCE IS SUBJECT TO CONDITIONS THAT  
16 ARE INCONSISTENT WITH STATE LAW OR REQUIRES A PREDETERMINED  
17 CONCLUSION OR RESULT FROM THE TASK FORCE. THE DIVISION SHALL  
18 REQUEST THAT THE ENTITY OFFERING THE MONEY, GIFT, GRANT,  
19 DONATION, SERVICES, OR IN-KIND DONATION SUBMIT A LETTER PRIOR TO  
20 THE OFFER SPECIFYING THE AMOUNT OF MONEY, GIFT, GRANT, OR  
21 DONATION OFFERED, OR THE ESTIMATED VALUE OF THE SERVICES OR  
22 IN-KIND DONATION OFFERED, THE PERIOD FOR WHICH THE MONEY, GIFT,  
23 GRANT, DONATION, SERVICES, OR IN-KIND DONATION IS AVAILABLE, AND  
24 THE SPECIFIC PURPOSES FOR WHICH THE MONEY, GIFT, GRANT, DONATION,  
25 SERVICES, OR IN-KIND DONATION IS TO BE USED.

26 **SECTION 2.** In Colorado Revised Statutes, 24-33.5-1801,  
27 **amend** (3)(c); and **add** (2.5), (3)(e), (3)(f), and (3)(g) as follows:

1           **24-33.5-1801. Legislative declaration. (2.5)** THE GENERAL  
2 ASSEMBLY FINDS AND DECLARES THAT:

3           (a) HUMAN TRAFFICKING IS A MATTER OF STATEWIDE CONCERN  
4 AND HAS A DIRECT IMPACT ON LOCAL COMMUNITIES, LAW ENFORCEMENT  
5 AGENCIES, AND ORGANIZATIONS THAT PROVIDE SERVICES TO HUMAN  
6 TRAFFICKING SURVIVORS;

7           (b) ALTHOUGH TRAINING RESOURCES ARE AVAILABLE ON THE  
8 FRONT RANGE, MANY AREAS OF THE STATE HAVE LIMITED TRAINING  
9 RESOURCES PERTAINING TO HUMAN TRAFFICKING THAT ARE EASILY  
10 AVAILABLE OR ACCESSIBLE;

11           (c) LABOR AND SEX TRAFFICKING CAN HAPPEN IN ANY  
12 COMMUNITY. ALL AREAS OF THE STATE SHOULD HAVE ACCESS TO  
13 TRAINING TO HELP IDENTIFY HUMAN TRAFFICKING AND PROVIDE CRITICAL  
14 SERVICES TO HUMAN TRAFFICKING SURVIVORS.

15           (d) TRAFFICKERS TARGET AND RECRUIT CHILDREN IN SCHOOLS IN  
16 COLORADO. IT IS ESSENTIAL TO INCREASE AWARENESS OF SCHOOL STAFF,  
17 PARENTS AND GUARDIANS, AND STUDENTS OF THE DANGERS OF HUMAN  
18 TRAFFICKING. TO ASSIST SCHOOLS, PARENTS, AND CHILDREN, THE  
19 COLORADO SCHOOL SAFETY RESOURCE CENTER SHALL ANNUALLY UPDATE  
20 AND DISSEMINATE A LIST OF AVAILABLE HUMAN TRAFFICKING CURRICULA  
21 TO SCHOOLS, INCLUDING SOME THAT ARE FREE OF CHARGE.

22           (e) THE COLORADO HUMAN TRAFFICKING COUNCIL HAS  
23 DEVELOPED A CURRICULUM AND TRAIN-THE-TRAINER PROGRAM FOR LAW  
24 ENFORCEMENT; AND

25           (f) THE COUNCIL IS CURRENTLY DEVELOPING A CURRICULUM AND  
26 TRAIN-THE-TRAINER PROGRAM FOR ENTITIES THAT PROVIDE SERVICES TO  
27 HUMAN TRAFFICKING SURVIVORS. THE CURRICULUM AND TRAINING

1 PROGRAMS MAY SUPPLEMENT THE EXCELLENT ANTI-TRAFFICKING WORK  
2 BEING DONE BY ADVOCACY AND SERVICE ORGANIZATIONS ACROSS THE  
3 STATE.

4 (3) Now, therefore, the general assembly declares that:

5 (c) Resources are needed to fully develop safety plans and  
6 practices in Colorado's schools, colleges, and universities; and

7 (e) LAW ENFORCEMENT AGENCIES, ORGANIZATIONS THAT PROVIDE  
8 SERVICES TO HUMAN TRAFFICKING SURVIVORS, AND LOCAL COMMUNITIES  
9 WOULD BENEFIT FROM ADDITIONAL TRAINING OPPORTUNITIES RELATED TO  
10 HUMAN TRAFFICKING;

11 (f) THE DIVISION OF CRIMINAL JUSTICE AND THE COLORADO  
12 HUMAN TRAFFICKING COUNCIL ARE WELL PLACED TO DEVELOP HUMAN  
13 TRAFFICKING CURRICULA AND TO HELP PROVIDE TRAINING IN THIS  
14 CRITICAL AREA; AND

15 (g) THE COLORADO SCHOOL SAFETY RESOURCE CENTER IS  
16 COMMITTED TO CONTINUING TO MAKE AVAILABLE HUMAN TRAFFICKING  
17 EDUCATIONAL RESOURCES TO SCHOOLS, PARENTS, AND CHILDREN.

18 **SECTION 3.** In Colorado Revised Statutes, 24-33.5-1803,  
19 **amend** (3)(l) as follows:

20 **24-33.5-1803. School safety resource center - created - duties**  
21 **- repeal.** (3) The center has the following duties:

22 (l) To provide materials and training as described in section  
23 24-33.5-1809 to personnel in school districts and charter schools, parents,  
24 and students regarding the awareness and prevention of child sexual  
25 abuse and assault, INCLUDING HUMAN TRAFFICKING; and

26 **SECTION 4. Appropriation.** For the 2018-19 state fiscal year,  
27 \$69,922 is appropriated to the department of public safety for use by the

1 division of criminal justice. This appropriation is from the general fund  
2 and is based on an assumption that the division will require an additional  
3 0.8 FTE. To implement this act, the division may use this appropriation  
4 for DCJ administrative services.

5           **SECTION 5. Act subject to petition - effective date.** This act  
6 takes effect at 12:01 a.m. on the day following the expiration of the  
7 ninety-day period after final adjournment of the general assembly (August  
8 8, 2018, if adjournment sine die is on May 9, 2018); except that, if a  
9 referendum petition is filed pursuant to section 1 (3) of article V of the  
10 state constitution against this act or an item, section, or part of this act  
11 within such period, then the act, item, section, or part will not take effect  
12 unless approved by the people at the general election to be held in  
13 November 2018 and, in such case, will take effect on the date of the  
14 official declaration of the vote thereon by the governor.
