**A BILL FOR AN ACT**

101 **CONCERNING THE AMOUNT THAT THE DEPARTMENT OF CORRECTIONS**  
102 **IS REQUIRED TO REIMBURSE A COUNTY OR CITY AND COUNTY**  
103 **FOR THE CONFINEMENT AND MAINTENANCE IN A LOCAL JAIL OF**  
104 **ANY PERSON WHO IS SENTENCED TO A TERM OF IMPRISONMENT**  
105 **IN A CORRECTIONAL FACILITY.**

**County Courthouse and County Jail Funding and Overcrowding Solutions Interim Study Committee.** Under current law, the general assembly establishes in its annual general appropriations bill the amount that the department of corrections is required to reimburse any county or city and county for a portion of the expenses and costs incurred by that county or city and county for the confinement and maintenance in a local jail of any person who is sentenced to a term of imprisonment in a correctional facility. The bill establishes this amount in statute as \$108.78 per day.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, 17-1-112, **amend** (1);  
3 **and add** (4) as follows:

4 **17-1-112. Expenses - reimbursement by department - report.**

5 (1) Subject to available appropriations, the department shall reimburse  
6 any county or city and county for a portion of the expenses and costs  
7 incurred by that county or city and county in the confinement and  
8 maintenance in a local jail of any person who is sentenced to a term of  
9 imprisonment in a correctional facility. The general assembly shall  
10 annually establish the amount of reimbursement in the general  
11 appropriations bill, TAKING INTO CONSIDERATION THE INFORMATION  
12 REPORTED PURSUANT TO SUBSECTION (4) OF THIS SECTION. Such  
13 reimbursement shall be IS for each day following seventy-two hours after  
14 such sentence is imposed but prior to the transmittal of the sentenced  
15 inmate to a department facility. Subject to available appropriations, the  
16 department may contract with any county or city and county for the  
17 expenses incurred by that county or city and county in the confinement  
18 and maintenance of any person who is sentenced to a term of  
19 imprisonment pursuant to section 16-11-308.5. ~~C.R.S.~~

20 (4) TO ASSIST THE GENERAL ASSEMBLY IN DETERMINING THE

1 AMOUNT OF REIMBURSEMENT DESCRIBED IN SUBSECTION (1) OF THIS  
2 SECTION, ON OR BEFORE JANUARY 1, 2019, AND ON OR BEFORE JANUARY  
3 1 EACH YEAR THEREAFTER, EACH COUNTY AND EACH CITY AND COUNTY  
4 SHALL REPORT TO THE JOINT BUDGET COMMITTEE THE AVERAGE COST OF  
5 CONFINING AND MAINTAINING PERSONS IN A LOCAL JAIL FOR MORE THAN  
6 SEVENTY-TWO HOURS AFTER EACH SUCH PERSON HAS BEEN SENTENCED TO  
7 THE CUSTODY OF THE DEPARTMENT. ON OR BEFORE SEPTEMBER 1, 2018,  
8 THE JOINT BUDGET COMMITTEE SHALL ESTABLISH GUIDELINES TO ENSURE  
9 THAT EACH COUNTY AND EACH CITY AND COUNTY REPORTS COSTS  
10 PURSUANT TO THIS SUBSECTION (4) IN A UNIFORM MANNER. AT A  
11 MINIMUM, THE GUIDELINES MUST ALLOW EACH COUNTY AND EACH CITY  
12 AND COUNTY TO REPORT COSTS IN THE FOLLOWING CATEGORIES:

- 13 (a) FOOD;
- 14 (b) CLOTHING AND LAUNDRY;
- 15 (c) MEDICAL AND BEHAVIORAL HEALTH CARE COSTS;
- 16 (d) PERSONNEL COSTS, INCLUDING SALARIES AND BENEFITS;
- 17 (e) INMATE TRANSPORTATION COSTS; AND
- 18 (f) VOCATIONAL TRAINING AND EDUCATIONAL COSTS.

19 **SECTION 2. Safety clause.** The general assembly hereby finds,  
20 determines, and declares that this act is necessary for the immediate  
21 preservation of the public peace, health, and safety.
