**Sunset Process - House State, Veterans, and Military Affairs Committee.** The bill implements the recommendations of the department of regulatory agencies in its sunset review and report on the measurement standards law by extending the law for 15 years.

2 **SECTION 1.** In Colorado Revised Statutes, 24-34-104, **repeal**  
3 (14)(a)(III); and **add** (29)(a)(III) as follows:

4 **24-34-104. General assembly review of regulatory agencies**  
5 **and functions for repeal, continuation, or reestablishment - legislative**  
6 **declaration - repeal.** (14) (a) The following agencies, functions, or both,  
7 are scheduled for repeal on July 1, 2018:

18 **SECTION 2.** In Colorado Revised Statutes, **amend** 35-14-134 as

20 **35-14-134. Repeal of sections - review of functions.** Sections  
21 35-14-102 (3), 35-14-121 to 35-14-124.5, 35-14-127, 35-14-129, and  
22 35-14-131 (5)(d), (5)(j), and (5)(m) are repealed, effective ~~July 1, 2018.~~  
23 ~~Prior to such repeal~~ SEPTEMBER 1, 2028. ~~BEFORE THE REPEAL,~~ the
