1 *Be it enacted by the General Assembly of the State of Colorado:*

2           **SECTION 1.** In Colorado Revised Statutes, 24-34-104, **repeal**  
3 (14)(a)(V) as follows:

4           **24-34-104. General assembly review of regulatory agencies**  
5 **and functions for repeal, continuation, or reestablishment - legislative**  
6 **declaration - repeal.** (14) (a) The following agencies, functions, or both,  
7 are scheduled for repeal on July 1, 2018:

8           (V) ~~The regulation by the department of agriculture of home food~~  
9 ~~service plans in accordance with article 33.5 of title 35, C.R.S.;~~

10           **SECTION 2.** In Colorado Revised Statutes, **repeal** article 33.5  
11 of title 35.

12           **SECTION 3. Safety clause.** The general assembly hereby finds,  
13 determines, and declares that this act is necessary for the immediate  
14 preservation of the public peace, health, and safety.
