**A BILL FOR AN ACT**

101 **CONCERNING A REDUCTION IN GREENHOUSE GAS EMISSIONS IN**  
102 **COLORADO, AND, IN CONNECTION THEREWITH, REQUIRING**  
103 **THAT, BY THE YEAR 2050, STATEWIDE GREENHOUSE GAS**  
104 **EMISSIONS BE REDUCED BY EIGHTY PERCENT OF THE LEVELS OF**  
105 **GREENHOUSE GAS EMISSIONS THAT EXISTED IN THE YEAR 2005.**

**Bill Summary**

The bill requires that, by the year 2050, statewide greenhouse gas emissions be reduced by at least 80% of the levels of greenhouse gas

1 *Be it enacted by the General Assembly of the State of Colorado:*

2           **SECTION 1.** In Colorado Revised Statutes, **add** 24-20-111.5 as  
3 follows:

4           **24-20-111.5. Reduce greenhouse gas emissions statewide -**  
5 **legislative declaration - definition.** (1) THE GENERAL ASSEMBLY  
6 HEREBY FINDS, DETERMINES, AND DECLARES THAT:

7           (a) CLIMATE CHANGE IS OCCURRING AND IT IS DUE TO  
8 ANTHROPOGENIC EMISSIONS;

9           (b) CLIMATE CHANGE ADVERSELY AFFECTS COLORADO'S  
10 ECONOMY, PUBLIC HEALTH, AND WAY OF LIFE;

11           (c) WE MUST WORK TOGETHER TO REDUCE COLORADO'S  
12 GREENHOUSE GAS EMISSIONS IN ORDER TO LIMIT THE INCREASE IN THE  
13 GLOBAL AVERAGE TEMPERATURE TO BETWEEN ONE AND ONE-HALF TO  
14 TWODEGREES CELSIUS, WHICH LIMITED INCREASE WOULD SIGNIFICANTLY  
15 REDUCE THE RISKS AND EFFECTS OF CLIMATE CHANGE;

16           (d) BY REDUCING GREENHOUSE GASES, COLORADO WILL ALSO  
17 REDUCE OTHER KEY AIR POLLUTANTS, WHICH WILL, IN TURN, IMPROVE  
18 PUBLIC HEALTH AND THE ENVIRONMENT; AND

19           (e) IN ADDITION TO REDUCING GREENHOUSE GAS EMISSIONS,  
20 CLIMATE POLICIES CAN SPUR INNOVATION, DRIVE INVESTMENTS IN  
21 LESS-POLLUTING TECHNOLOGIES, AND ENABLE A TRANSITION TO A  
22 MODERN, RESILIENT, AND ECONOMICALLY VIBRANT SOCIETY.

23           (2) AS USED IN THIS SECTION, "GREENHOUSE GAS" MEANS THE  
24 GASES THAT MAY BE REPORTED TO THE FEDERAL DEPARTMENT OF ENERGY  
25 PURSUANT TO 10 CFR PART 300.

1           (3) (a) ON OR BEFORE THE YEAR 2050, THE STATEWIDE EMISSIONS  
2 OF GREENHOUSE GASES SHALL BE REDUCED IN COLORADO BY AT LEAST  
3 EIGHTY PERCENT BELOW THE LEVELS OF GREENHOUSE GAS EMISSIONS  
4 THAT EXISTED IN THE YEAR 2005, AND THE REDUCED LEVELS OF  
5 GREENHOUSE GAS EMISSIONS SHALL BE MAINTAINED AT OR BELOW THE  
6 REDUCED LEVELS THEREAFTER.

7           (b) COLORADO SHALL HAVE STATEWIDE PROGRAMS IN PLACE TO  
8 MEET THE GREENHOUSE GAS EMISSIONS TARGET SET FORTH IN SUBSECTION  
9 (3)(a) OF THIS SECTION.

10           **SECTION 2. Act subject to petition - effective date.** This act  
11 takes effect at 12:01 a.m. on the day following the expiration of the  
12 ninety-day period after final adjournment of the general assembly (August  
13 8, 2018, if adjournment sine die is on May 9, 2018); except that, if a  
14 referendum petition is filed pursuant to section 1 (3) of article V of the  
15 state constitution against this act or an item, section, or part of this act  
16 within such period, then the act, item, section, or part will not take effect  
17 unless approved by the people at the general election to be held in  
18 November 2018 and, in such case, will take effect on the date of the  
19 official declaration of the vote thereon by the governor.
