**A BILL FOR AN ACT**

101 **CONCERNING A COMPREHENSIVE PLAN TO PROACTIVELY ADDRESS THE**  
102 **ANTICIPATED IMPACTS ON COLORADO OF GLOBAL CLIMATE**  
103 **CHANGE, AND, IN CONNECTION THEREWITH, MAKING AN**  
104 **APPROPRIATION.**

**Bill Summary**

The bill adopts the following greenhouse gas emission reduction goals:

- ! 26% by 2025 when compared with 2005 levels; and
- ! Carbon dioxide emissions from electrical generation, when compared with 2012 levels, should be reduced by 25% by 2025 and by 30% by 2030.

The Colorado resiliency and recovery office in the division of local government in the department of local affairs is required to, on an ongoing basis:

- ! Collect and analyze data regarding the economic and environmental impacts of not addressing climate change and calculate the economic costs of climate change;
- ! Develop a model to estimate the future impacts of climate change on Colorado;
- ! Analyze the results of the modeling on regional and Colorado-specific climatic conditions currently and the expected future conditions under a variety of climate change scenarios;
- ! Update the Colorado resiliency framework, taking into account the goals, the rules, and the data and analysis; and
- ! Develop tools and resources to support locally led climate resilience initiatives.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2           **SECTION 1.** In Colorado Revised Statutes, **amend** 24-20-111 as  
3 follows:

4           **24-20-111. Climate change - preparedness - adaptation -**  
5 **resiliency - short title - definition - rules - position - report.** (1) THE  
6 SHORT TITLE OF THIS SECTION IS THE "CLIMATE CHANGE PREPAREDNESS,  
7 ADAPTATION, AND RESILIENCY ACT".

8           (2) FOR PURPOSES OF THIS SECTION, "GREENHOUSE GAS" MEANS  
9 ANY OF THE GASES THAT MAY BE REPORTED TO THE FEDERAL DEPARTMENT  
10 OF ENERGY PURSUANT TO 10 CFR 300.

11           (3) TO REDUCE COLORADO'S CONTRIBUTION TO GLOBAL CLIMATE  
12 CHANGE AND TO HELP LIMIT GLOBAL WARMING TO LESS THAN TWO  
13 DEGREES CELSIUS ABOVE PREINDUSTRIAL LEVELS, THE GENERAL  
14 ASSEMBLY HEREBY ADOPTS THE FOLLOWING GREENHOUSE GAS EMISSION

1 REDUCTION GOALS:

2 (a) STATEWIDE GREENHOUSE GAS EMISSIONS SHOULD BE REDUCED  
3 BY TWENTY-SIX PERCENT BY 2025 WHEN COMPARED WITH 2005 LEVELS;  
4 AND

5 (b) CARBON DIOXIDE EMISSIONS FROM ELECTRICAL GENERATION,  
6 WHEN COMPARED WITH 2012 LEVELS, SHOULD BE REDUCED BY:

7 (I) TWENTY-FIVE PERCENT BY 2025; AND

8 (II) THIRTY PERCENT BY 2030.

9 (4) THE COLORADO RESILIENCY AND RECOVERY OFFICE IN THE  
10 DIVISION OF LOCAL GOVERNMENT IN THE DEPARTMENT OF LOCAL AFFAIRS,  
11 OR ANY SUCCESSOR OFFICE, SHALL, ON AN ONGOING BASIS:

12 (a) (I) COLLECT AND ANALYZE DATA TO CALCULATE THE  
13 ECONOMIC COSTS OF CLIMATE CHANGE;

14 (II) COLLECT AND ANALYZE DATA REGARDING THE ECONOMIC AND  
15 ENVIRONMENTAL IMPACTS OF NOT ADDRESSING CLIMATE CHANGE;

16 (III) DEVELOP, IN CONSULTATION WITH INSTITUTIONS OF HIGHER  
17 EDUCATION, THE PRIVATE SECTOR, AND OTHER STATE AND FEDERAL  
18 AGENCIES, A MODEL TO ESTIMATE THE FUTURE IMPACTS OF CLIMATE  
19 CHANGE ON COLORADO, INCLUDING DROUGHT, WILDFIRE, AND FLOODS;  
20 AND

21 (IV) ANALYZE THE RESULTS OF THE MODELING ON REGIONAL AND  
22 COLORADO-SPECIFIC CLIMATIC CONDITIONS CURRENTLY AND THE  
23 EXPECTED FUTURE CONDITIONS UNDER A VARIETY OF CLIMATE CHANGE  
24 SCENARIOS;

25 (b) UPDATE THE COLORADO RESILIENCY FRAMEWORK, TAKING  
26 INTO ACCOUNT THE GOALS ESTABLISHED IN SUBSECTION (3) OF THIS  
27 SECTION AND THE DATA AND ANALYSIS DEVELOPED PURSUANT TO

1 SUBSECTION (4)(a) OF THIS SECTION;

2 (c) DEVELOP TOOLS AND RESOURCES TO SUPPORT LOCALLY LED  
3 CLIMATE RESILIENCE INITIATIVES, INCLUDING:

4 (I) DEVELOPING A RESILIENCE AND CLIMATE ADAPTATION  
5 FINANCING TOOLKIT FOR COMMUNITIES TO IDENTIFY OPPORTUNITIES TO  
6 IMPLEMENT RESILIENCE ACTIONS;

7 (II) PROVIDING GUIDANCE FOR INCORPORATING CLIMATE-RELATED  
8 RISKS INTO COMMUNITY PLANNING EFFORTS, INCLUDING LONG-RANGE  
9 CAPITAL IMPROVEMENTS AND EMERGENCY PLANS;

10 (III) THROUGH GUIDANCE, RESOURCES, AND TECHNICAL  
11 ASSISTANCE, STRENGTHENING THE ABILITY OF LOCAL COMMUNITIES TO  
12 INCORPORATE RESILIENCE AND ADAPTATION INTO VARIOUS PROGRAMS,  
13 PLANS, AND LAND USE POLICIES; AND

14 (IV) BUILDING RESILIENCE AND ADAPTATION CRITERIA INTO  
15 APPROPRIATE STATE GRANT, LOAN, AND ASSET MANAGEMENT PROGRAMS  
16 AND DEVELOPING GUIDANCE FOR LOCAL GOVERNMENTS.

17 ~~(1)~~ (5) (a) ~~There shall be a position created by~~ The governor  
18 SHALL CREATE A POSITION within the executive branch, which position  
19 must include the term "climate change" in its title, to assess climate  
20 change issues in the state.

21 (b) The organizational location of the position created under  
22 ~~paragraph (a) of this subsection~~ ~~(1)~~ (5)(a) of this section shall be IS at the  
23 discretion of the governor and may utilize existing resources as  
24 appropriate. In order to reduce the costs associated with creating the  
25 climate change position, nothing in this section precludes the person  
26 named to the position established under ~~paragraph (a) of this subsection~~  
27 ~~(1)~~ (5)(a) of this section from holding other titles or performing other

1 functions within any department or office of the executive branch.

2 ~~(2)~~ (c) The duties of the position created pursuant to subsection  
3 ~~(1)~~ (5)(a) of this section include, at a minimum:

4 ~~(a)~~ (I) Development and periodic update of a climate action plan  
5 or similar document that sets forth a strategy, including specific policy  
6 recommendations, that the state could use to address climate change and  
7 reduce its greenhouse gas emissions; and

8 ~~(b)~~ (II) Collaboration with other entities regarding climate change  
9 preparedness studies.

10 ~~(3)~~ (6) (a) The governor or his or her designee shall submit an  
11 annual report to the house agriculture, livestock, and natural resources  
12 committee, the house transportation and energy committee, and the senate  
13 agriculture, natural resources, and energy committee, or any successor  
14 committees, on climate change issues generally, the current climate action  
15 plan developed under this section, and the specific ways in which climate  
16 change affects the state. The report may address, as appropriate, the  
17 correlations between climate change and PUBLIC HEALTH, AGRICULTURE,  
18 wildfires, bark beetle infestation, snowpack, water storage, drought, and  
19 statewide emissions of greenhouse gases. The report ~~shall~~ MUST include  
20 information regarding efforts to reduce emissions of GREENHOUSE gases  
21 and to reform practices known to exacerbate climate change effects. The  
22 report ~~shall~~ MUST also include additional prospective proposals to prepare  
23 the state for the effects of climate change and proposals to further reduce  
24 the factors that contribute to climate change within Colorado.

25 (b) The development of a climate action plan in accordance with  
26 this section must take into account previous action plans developed by the  
27 state and goals and directives contained in executive orders issued by the

1 governor.

2 (c) The report required by this subsection ~~(3)~~ (6) is exempt from  
3 the automatic expiration described in section 24-1-136 (11).

4 **SECTION 2. Appropriation.** (1) For the 2018-19 state fiscal  
5 year, \$432,345 is appropriated to the department of local affairs for use  
6 by the division of local government. This appropriation is from the  
7 general fund, and is based on an assumption that the division will require  
8 an additional 1.6 FTE. To implement this act, the division may use this  
9 appropriation for the Colorado resiliency and recovery office.

10 **SECTION 3. Act subject to petition - effective date.** This act  
11 takes effect at 12:01 a.m. on the day following the expiration of the  
12 ninety-day period after final adjournment of the general assembly (August  
13 8, 2018, if adjournment sine die is on May 9, 2018); except that, if a  
14 referendum petition is filed pursuant to section 1 (3) of article V of the  
15 state constitution against this act or an item, section, or part of this act  
16 within such period, then the act, item, section, or part will not take effect  
17 unless approved by the people at the general election to be held in  
18 November 2018 and, in such case, will take effect on the date of the  
19 official declaration of the vote thereon by the governor.
