A BILL FOR AN ACT

101 **CONCERNING A REQUIREMENT FOR A LOCAL JUVENILE SERVICES**
102 **PLANNING COMMITTEE TO DEVISE A PLAN TO MANAGE DUALY**
103 **IDENTIFIED CROSSOVER YOUTH.**

Bill Summary

(Note: This summary applies to this bill as introduced and does not reflect any amendments that may be subsequently adopted. If this bill passes third reading in the house of introduction, a bill summary that applies to the reengrossed version of this bill will be available at <http://leg.colorado.gov>.)

The bill requires local juvenile services planning committees to devise a plan to manage dually identified crossover youth. A dually identified crossover youth is a youth involved in both the juvenile justice system and the child welfare system. The plan must contain descriptions and processes to include the following:

- ! A process for the identification of dually identified crossover youth at the earliest reasonable point of contact;
- ! A method for collaborating and exchanging information with other judicial districts;
- ! A process for promptly communicating information about the youth's crossover status between the child welfare and juvenile justice systems and to notify each other of the new involvement in the respective system or information that may aid in the identification of dually identified crossover youth;
- ! A process for identifying the least restrictive appropriate placement;
- ! A process for sharing and gathering information in accordance with applicable laws and rules;
- ! A process for the development of a single case management plan and identification of the lead agency for case management purposes;
- ! A process that facilitates the sharing of assessments and case planning information;
- ! A process for a multi-disciplinary group of professionals to consider decisions that include: Youth and community safety, placement, provision of needed services, alternatives to detention and commitment, probation, parole, permanency, education stability, and case closure; and
- ! A requirement that dually identified crossover youth placed in a secure detention facility who are deemed eligible for release by the court be placed in the least restrictive setting whenever possible to reduce the disparity between dually identified crossover youth and nondually identified crossover youth in secure detention.

The bill allows marijuana tax cash fund money to be used for the development of local dually identified crossover youth plans and services.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, 19-1-103, **amend**
 3 (34.7); and **add** (34.8) and (44.7) as follows:

4 **19-1-103. Definitions.** As used in this title 19 or in the specified

15 (34.8) "CUSTODIAL ADOPTION", AS USED IN PART 2 OF ARTICLE 5
16 OF THIS TITLE 19, MEANS AN ADOPTION OF A CHILD BY ANY PERSON AND
17 SUCH PERSON'S SPOUSE, AS REQUIRED UNDER SECTION 19-5-202 (3), WHO:

18 (a) HAS BEEN AWARDED CUSTODY OR ALLOCATED PARENTAL
19 RESPONSIBILITIES BY A COURT OF LAW IN A DISSOLUTION OF MARRIAGE,
20 CUSTODY OR ALLOCATION OF PARENTAL RESPONSIBILITIES PROCEEDING,

24 (b) HAS HAD PHYSICAL CUSTODY OF THE CHILD FOR A PERIOD OF

26 (44.7) "DUALY IDENTIFIED CROSSOVER YOUTH" MEANS YOUTH
27 WHO ARE CURRENTLY INVOLVED IN THE JUVENILE JUSTICE SYSTEM AND

1 THE CHILD WELFARE SYSTEM OR HAVE A HISTORY IN THE CHILD WELFARE
2 SYSTEM THAT INCLUDES, BUT IS NOT LIMITED TO, A FAMILY ASSESSMENT
3 RESPONSE SERVICE PLAN OR AN OPEN CASE.

4 **SECTION 2.** In Colorado Revised Statutes, **amend** 19-2-211 as
5 follows:

6 **19-2-211. Local juvenile services planning committee -**
7 **creation - duties - identification and notification of dually identified**
8 **crossover youth.** (1) If all of the boards of commissioners of each
9 county or the city council of each city and county in a judicial district
10 agree, there may be created in the judicial district a local juvenile services
11 planning committee that is appointed by the chief judge of the judicial
12 district or, for the second judicial district, the presiding judge of the
13 Denver juvenile court from persons recommended by the boards of
14 commissioners of each county or the city council of each city and county
15 within the judicial district. The committee, if practicable, must include,
16 but need not be limited to, a representative from the county department
17 of HUMAN OR social services, a local school district, a local law
18 enforcement agency, a local probation department, the division of youth
19 services, private citizens, the district attorney's office, and the public
20 defender's office and a community mental health representative and a
21 representative of the concerns of municipalities. The committee, if
22 created, shall meet as necessary to develop a plan for the allocation of
23 resources for local juvenile services within the judicial district for the
24 fiscal year. The committee is strongly encouraged to consider programs
25 with restorative justice components when developing the plan. The plan
26 must be approved by the department of human services. A local juvenile
27 services planning committee may be consolidated with other local

2 (2) THE PLAN MUST INCLUDE FOR THE MANAGEMENT OF DUALY
3 IDENTIFIED CROSSOVER YOUTH. THE PLAN MUST CONTAIN DESCRIPTIONS
4 AND PROCESSES TO INCLUDE THE FOLLOWING:

5 (a) A PROCESS FOR THE IDENTIFICATION OF DUALY IDENTIFIED
6 CROSSOVER YOUTH AT THE EARLIEST REASONABLE POINT OF CONTACT;

7 (b) A METHOD FOR COLLABORATING AND EXCHANGING
8 INFORMATION WITH OTHER JUDICIAL DISTRICTS, INCLUDING WITH THE
9 COLLABORATIVE MANAGEMENT PROGRAM DESCRIBED IN SECTION
10 24-1.9-102 AND CONSISTENT WITH THE DATA-SHARING POLICIES OF THE
11 COLLABORATIVE MANAGEMENT PROGRAM;

12 (c) A PROCESS FOR PROMPTLY COMMUNICATING INFORMATION
13 ABOUT THE YOUTH'S CROSSOVER STATUS BETWEEN THE CHILD WELFARE
14 AND JUVENILE JUSTICE SYSTEMS AND TO NOTIFY EACH OTHER OF THE NEW
15 INVOLVEMENT IN THE RESPECTIVE SYSTEM OR INFORMATION THAT MAY
16 AID IN THE IDENTIFICATION OF DUALY IDENTIFIED CROSSOVER YOUTH.
17 THE FOLLOWING PARTIES SHOULD BE NOTIFIED OF A JUVENILE'S STATUS AS
18 A DUALY IDENTIFIED CROSSOVER YOUTH IF APPLICABLE: PUBLIC
19 DEFENDERS, DISTRICT ATTORNEYS, LOCAL JUVENILE SERVICES PLANNING
20 COMMITTEE COORDINATORS, HUMAN OR SOCIAL SERVICES
21 REPRESENTATIVES, PROBATION REPRESENTATIVES, JUVENILE COURT
22 REPRESENTATIVES, PARENTS, AND GUARDIANS AD LITEM.

23 (d) A PROCESS FOR IDENTIFYING THE APPROPRIATE SERVICES OR
24 PLACEMENT-BASED ASSESSMENT FOR A DUALY IDENTIFIED CROSSOVER
25 YOUTH;

26 (e) A PROCESS FOR SHARING AND GATHERING INFORMATION IN
27 ACCORDANCE WITH APPLICABLE LAWS, RULES, AND COUNTY POLICY;

1 (f) A PROCESS FOR THE DEVELOPMENT OF A SINGLE CASE
2 MANAGEMENT PLAN AND IDENTIFICATION OF THE LEAD AGENCY FOR CASE
3 MANAGEMENT PURPOSES AND THE ENGAGEMENT OF DUALY IDENTIFIED
4 CROSSOVER YOUTH AND THEIR CAREGIVERS;

5 (g) A PROCESS THAT FACILITATES THE SHARING OF ASSESSMENTS
6 AND CASE PLANNING INFORMATION AND INCLUDES POLICIES AROUND
7 SHARING INFORMATION WITH OTHER JUDICIAL DISTRICTS;

8 (h) A PROCESS FOR A MULTIDISCIPLINARY GROUP OF
9 PROFESSIONALS TO CONSIDER DECISIONS THAT INCLUDE: YOUTH AND
10 COMMUNITY SAFETY, PLACEMENT, PROVISION OF NEEDED SERVICES,
11 ALTERNATIVES TO DETENTION AND COMMITMENT, PROBATION, PAROLE,
12 PERMANENCY, EDUCATION STABILITY, AND CASE CLOSURE; AND

13 (i) A REQUIREMENT THAT DUALY IDENTIFIED CROSSOVER YOUTH
14 PLACED IN A SECURE DETENTION FACILITY WHO ARE DEEMED ELIGIBLE FOR
15 RELEASE BY THE COURT BE PLACED IN THE LEAST RESTRICTIVE SETTING
16 WHENEVER POSSIBLE TO REDUCE THE DISPARITY BETWEEN DUALY
17 IDENTIFIED CROSSOVER YOUTH AND NONDUALY IDENTIFIED CROSSOVER
18 YOUTH IN SECURE DETENTION.

19 **SECTION 3.** In Colorado Revised Statutes, 24-1.9-102, **amend**
20 (1)(e) as follows:

21 **24-1.9-102. Memorandum of understanding - local-level**
22 **interagency oversight groups - individualized service and support**
23 **teams - coordination of services for children and families -**
24 **requirements - waiver.** (1) (e) Nothing shall preclude the agencies
25 specified in paragraphs (a) and (a.5) of this subsection (1) SUBSECTIONS
26 (1)(a) AND (1)(a.5) OF THIS SECTION from including parties in addition to
27 the agencies specified in paragraphs (a) and (a.5) of this subsection (1)

1 SUBSECTIONS (1)(a) AND (1)(a.5) OF THIS SECTION in the memorandums
2 of understanding developed for purposes of this section, AND WHICH MAY
3 INCLUDE THE JUVENILE SERVICES PLANNING COMMITTEE AS DESCRIBED IN
4 SECTION 19-2-211.

5 **SECTION 4.** In Colorado Revised Statutes, 39-28.8-501, **amend**
6 (2)(b)(IV)(M) and (2)(b)(IV)(N); and **add** (2)(b)(IV)(O) as follows:

7 **39-28.8-501. Marijuana tax cash fund - creation - distribution**
8 **- legislative declaration.** (2) (b) (IV) Subject to the limitation in
9 subsection (5) of this section, the general assembly may annually
10 appropriate any money in the fund for any fiscal year following the fiscal
11 year in which it was received by the state for the following purposes:

12 (M) For the expenses of the department of education and the
13 department of public health and environment in developing and
14 maintaining the resource bank for educational materials on marijuana and
15 providing technical assistance as required in section 22-2-127.7; ~~and~~

16 (N) For housing, rental assistance, and supportive services,
17 including reentry services, pursuant to section 24-32-721; AND

18 (O) FOR THE DEVELOPMENT OF LOCAL DUALY IDENTIFIED
19 CROSSOVER YOUTH PLANS AND SERVICES AS DESCRIBED IN SECTION
20 19-2-211 (2).

21 **SECTION 5. Safety clause.** The general assembly hereby finds,
22 determines, and declares that this act is necessary for the immediate
23 preservation of the public peace, health, and safety.
