**A BILL FOR AN ACT**

101 **CONCERNING CHANGES TO THE REQUIREMENTS FOR MEETING DATES**  
102 **FOR THE BOARD OF THE SOUTHWESTERN WATER CONSERVATION**  
103 **DISTRICT.**

**Bill Summary**

*(Note: This summary applies to this bill as introduced and does not reflect any amendments that may be subsequently adopted. The board of the southwestern water conservation district (board) is currently required to meet on the fourth Tuesday of January, April, July, and October. **Section 1** of the bill requires the board to meet once every 3 months and eliminates the specific date requirement. **Section 2** makes conforming amendments to the provisions governing the terms of

1 *Be it enacted by the General Assembly of the State of Colorado:*

2           **SECTION 1.** In Colorado Revised Statutes, **amend** 37-47-108 as  
3 follows:

4           **37-47-108. Principal office - meetings.** The board of directors of  
5 the district shall designate a place within the district where the principal  
6 office is to be maintained and may change such place from time to time.  
7 Regular ~~quarterly~~ meetings of said board shall be held at said office ~~on~~  
8 ~~the fourth Tuesday in the months of January, April, July, and October~~ AT  
9 LEAST ONCE EVERY THREE MONTHS. The board is also empowered to hold  
10 such special meetings as may be required for the proper transaction of  
11 business. All special meetings of the board shall be held at locations  
12 which are within the boundaries of the district or which are within the  
13 boundaries of any county in which the district is located, in whole or in  
14 part, or in any county so long as the meeting location does not exceed  
15 twenty miles from the district boundaries. The provisions of this section  
16 governing the location of meetings may be waived only if the proposed  
17 change of location of a meeting of the board appears on the agenda of a  
18 regular or special meeting of the board and if a resolution is adopted by  
19 the board stating the reason for which a meeting of the board is to be held  
20 in a location other than under the provisions of this section and further  
21 stating the date, time, and place of such meeting. Special meetings may  
22 be called by the president of the board or by any three directors. Meetings  
23 of the board shall be public, and proper minutes of the proceedings of  
24 said board shall be preserved and shall be open to the inspection of any  
25 elector of the district during business hours.

1           **SECTION 2.** In Colorado Revised Statutes, 37-47-104, **amend**  
2 (1) and (2) as follows:

3           **37-47-104. Board of directors.** (1) The southwestern water  
4 conservation district shall be managed and controlled by a board of nine  
5 directors. The members of said board shall hold their office for staggered  
6 terms of three years, with three members appointed each year, and until  
7 their successors are appointed and qualified. One member of said board  
8 shall be selected from each of the respective counties in said water  
9 conservation district and, at the time of his OR HER appointment, shall  
10 have been a resident of said county or, if only a part of a county is  
11 included within the boundaries of said district, a resident of such included  
12 part for at least two years prior to the date of his OR HER appointment and  
13 shall be a freeholder who has paid taxes upon real estate in the county of  
14 his OR HER residence during the calendar year next preceding his OR HER  
15 appointment. ~~He~~ THE MEMBER shall be appointed by the board of county  
16 commissioners of the county in which ~~he~~ THE MEMBER resides. ~~He~~ THE  
17 MEMBER may be a member of the board of county commissioners of such  
18 county. The members of said board shall annually select one of their  
19 number to act as president and presiding officer until the ~~fourth Tuesday~~  
20 ~~in January following his appointment~~ FIRST REGULAR BOARD MEETING OF  
21 THE NEXT CALENDAR YEAR.

22           (2) (a) Immediately upon organization the members of said board  
23 shall be divided by lot or chance into three classes. The term of office of  
24 the members of the first class shall expire on the third Tuesday in January,  
25 1942; the term of office of the members of the second class shall expire  
26 on the third Tuesday in January, 1943; and the term of office of the  
27 members of the third class shall expire on the third Tuesday in January,

1 1944; except that, on and after March 11, 1943, terms of office shall  
2 expire on the fourth Tuesday in January, instead of the third Tuesday in  
3 January, as provided in this subsection (2).

4 (b) NOTWITHSTANDING SUBSECTION (2)(a) OF THIS SECTION, ON  
5 AND AFTER SEPTEMBER 1, 2018, TERMS OF OFFICE EXPIRE ON THE DAY OF  
6 THE FIRST REGULAR BOARD MEETING HELD IN THE FOURTH CALENDAR  
7 YEAR FOLLOWING THE MEMBER'S APPOINTMENT. At the first meeting of the  
8 board of county commissioners held ~~after the second Tuesday~~ in January,  
9 and every three years thereafter, the boards of county commissioners of  
10 the counties of residence of the members whose terms expire shall  
11 appoint successors to take office on the ~~fourth Tuesday in January~~  
12 ~~following~~ DATE OF THE FIRST REGULAR MEETING OF THE BOARD OF THE  
13 SOUTHWESTERN WATER CONSERVATION DISTRICT FOLLOWING SUCH  
14 APPOINTMENTS.

15 **SECTION 3. Act subject to petition - effective date.** This act  
16 takes effect at 12:01 a.m. on the day following the expiration of the  
17 ninety-day period after final adjournment of the general assembly (August  
18 8, 2018, if adjournment sine die is on May 9, 2018); except that, if a  
19 referendum petition is filed pursuant to section 1 (3) of article V of the  
20 state constitution against this act or an item, section, or part of this act  
21 within such period, then the act, item, section, or part will not take effect  
22 unless approved by the people at the general election to be held in  
23 November 2018 and, in such case, will take effect on the date of the  
24 official declaration of the vote thereon by the governor.
