101 CONCERNING CHANGES TO HOUSE RULE 26 TO PROHIBIT THE
102 INTRODUCTION OF RESOLUTIONS IN THE LAST THIRTY DAYS OF
103 A LEGISLATIVE SESSION AND TO DELINEATE WHAT MATTERS
104 HOUSE RESOLUTIONS MAY ADDRESS.

1 *Be It Resolved by the House of Representatives of the Seventy-first*
2 *General Assembly of the State of Colorado:*

3 That in the Rules of the House of Representatives, **amend** Rule
4 No. 26 (a)(2), (a)(3), and (g) as follows:

5 **26. Resolutions and Memorials**

6 (a) Resolutions and memorials originating in the House shall be of the
7 following classes:

8 (2) House joint resolutions, which shall pertain to:

9 (A) The transaction of the business of both the House
10 and the Senate; or

1 (B) The establishment of committees comprised of
2 members of both houses; or

3 (C) The recognition of any individual member of the
4 armed forces of this country who has died while
5 serving in the armed forces or any individual
6 member of any police, sheriff, or fire department
7 who has died while performing duties for the
8 department; or

9 (D) ~~Those matters which shall express the will of both~~
10 ~~houses on any matter not mentioned in Rule 26A.~~
11 THE RECOGNITION OF A NATIONAL HOLIDAY; OR

12 (E) THOSE MATTERS WHICH SHALL EXPRESS THE WILL OF
13 BOTH HOUSES ON ANY MATTER NOT MENTIONED IN
14 RULE 26A.

15 (3) House resolutions, which shall relate to ~~matters specified~~

17 THE FOLLOWING MATTERS and which shall NOT relate solely
18 to matters ~~not~~ mentioned in Rule 26A concerning the
19 House:

20 (A) THE TRANSACTION OF THE BUSINESS OF THE HOUSE;
21 OR

22 (B) THE ESTABLISHMENT OF COMMITTEES COMPRISED OF
23 MEMBERS OF THE HOUSE; OR

24 (C) THE RECOGNITION OF ANY INDIVIDUAL MEMBER OF
25 THE ARMED FORCES OF THIS COUNTRY WHO HAS DIED
26 WHILE SERVING IN THE ARMED FORCES OR ANY
27 INDIVIDUAL MEMBER OF ANY POLICE, SHERIFF, OR
28 FIRE DEPARTMENT WHO HAS DIED WHILE
29 PERFORMING DUTIES FOR THE DEPARTMENT; OR

30 (D) THE RECOGNITION OF A NATIONAL HOLIDAY; OR

31 (E) THOSE MATTERS WHICH SHALL EXPRESS THE WILL OF
32 THE HOUSE ON ANY MATTER NOT MENTIONED IN
33 RULE 26A.

1 (g) A member of the House may not introduce more than two House
2 concurrent resolutions and a combination of two House joint
3 resolutions and House resolutions during any regular or special
4 session unless permission to introduce the resolution is given by
5 the House Committee on Delayed Bills. A joint resolution or
6 resolution must be introduced prior to the last ~~twenty~~ THIRTY
7 legislative days as required in Joint Rule No. 23 (g). This
8 provision shall not apply to a House joint resolution or House
9 resolution pertaining to the close of the session or to the conduct
10 of legislative business.
