Bill Topic: MODIFICATIONS TO GOVERNMENT DATA ADVISORY BOARD

- Summary of Fiscal Impact:**
- State Revenue
 - State Expenditure (*minimal*)

This bill modifies definitions related to and the composition of the Government Data Advisory Board, as well as changing sunset dates related to the board. It decreases workload in the Department of Regulatory Agencies and increases the workload of certain state agencies and the Joint Technology Committee.

Appropriation Summary: No appropriation is required.

Fiscal Note Status: The fiscal note reflects the introduced bill, as recommended by the Joint Technology Committee.

Summary of Legislation

This bill makes changes to the Government Data Advisory Board. First, it modifies the definition of "interdepartmental data protocol" to conform with current practice. It also changes the membership of the board so every Executive Branch agency is represented. Finally, it extends the repeal date for the board from July 1, 2019, to July 1, 2024. The education data subcommittee of the board will still repeal on July 1, 2019. Instead of a sunset review by the Department of Regulatory Agencies (DORA), the board will be reviewed by the Joint Technology Committee (JTC).

Background

The board was created in the Governor's Office of Information Technology (OIT) to advise and provide recommendations to the Chief Information Officer regarding interdepartmental data protocol and best practices in sharing and protecting data in state government.

State Expenditures

The bill does not change the way the board functions. State departments that are not currently represented on the board will see increased workloads to attend meetings; however, any increase is expected to be minimal and can be accomplished within existing appropriations.

Additionally, the bill removes the requirement that DORA conduct a sunset review of the board and places the responsibility for the review with the JTC. For FY 2018-19 and FY 2019-20, the bill will reduce workload for DORA associated with the 2019 sunset review of the board. This reduction does not require a change in appropriations. Similarly, JTC workload will increase in FY 2023-24 and will not require a change in appropriations.

Effective Date

Section 24-37.5-703 (1)(b), enacted in section 2 of the bill, takes effect on July 1, 2019, and the rest of the bill takes effect August 8, 2018, if the General Assembly adjourns on May 9, 2018, as scheduled, and no referendum petition is filed.
