A BILL FOR AN ACT

101 **CONCERNING ANNUAL STIPENDS FOR CERTAIN NATIONALLY CERTIFIED**
102 **SCHOOL PROFESSIONALS.**

Bill Summary

(Note: This summary applies to this bill as introduced and does not reflect any amendments that may be subsequently adopted. The bill adds nationally certified school psychologists as school professionals eligible for annual stipends awarded by the department of education (department) if the school psychologist meets the requirements set forth in the bill.

The bill clarifies that school counselors are school professionals who have been eligible for annual stipends awarded by the department

The bill corrects the name of the national board for professional teaching standards by removing the word "principal" from the title.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, 22-2-504, **amend** (1),
3 (2), and (4) as follows:

4 **22-2-504. National certification compensation - definition -**
5 **study.** (1) Beginning with the 2009-10 school year FOR TEACHERS,
6 SCHOOL COUNSELORS, AND PRINCIPALS WHO HOLD A CERTIFICATION FROM
7 THE NATIONAL BOARD FOR PROFESSIONAL TEACHING STANDARDS, ~~AND~~
8 ~~SCHOOL COUNSELORS WHO HOLD A CERTIFICATION FROM THE NATIONAL~~
9 ~~BOARD FOR CERTIFIED COUNSELORS,~~ AND BEGINNING WITH THE 2019-20
10 SCHOOL YEAR FOR NATIONALLY CERTIFIED SCHOOL PSYCHOLOGISTS WHO
11 HOLD A CERTIFICATION FROM THE NATIONAL ASSOCIATION OF SCHOOL
12 PSYCHOLOGISTS, COLLECTIVELY REFERRED TO IN THIS SECTION AS
13 "SCHOOL PROFESSIONALS", the department, subject to available
14 appropriations, shall award an annual stipend of one thousand six hundred
15 dollars to any ~~teacher or principal~~ SCHOOL PROFESSIONAL who is
16 employed in a school district, a program operated by a board of
17 cooperative services, a charter school authorized by a school district
18 pursuant to part 1 of article 30.5 of this ~~title~~ TITLE 22, or a charter school
19 authorized by the state charter school institute pursuant to part 5 of article
20 30.5 of this ~~title~~, ~~and who holds a certification from the national board for~~
21 ~~professional teaching or principal standards~~ TITLE 22. For any stipends
22 that are awarded, the department shall allocate the stipend ~~moneys~~ MONEY
23 to the school district that employs the ~~teacher or principal~~ SCHOOL
24 PROFESSIONAL who is to receive the stipend, and the school district shall

1 then make payment directly to the eligible ~~teacher or principal~~ SCHOOL
2 PROFESSIONAL. A school district may, at its discretion, withhold any
3 required employer retirement and medicare contributions associated with
4 the stipend pursuant to this section from the one thousand six hundred
5 dollar stipend amount. For any stipends that are awarded, the stipend shall
6 be:

7 (a) Payable on May 1, 2009, and each May 1 thereafter, FOR
8 NATIONALLY CERTIFIED TEACHERS, SCHOOL COUNSELORS, AND
9 PRINCIPALS;

10 (b) PAYABLE ON MAY 1, 2020, AND EACH MAY 1 THEREAFTER,
11 FOR NATIONALLY CERTIFIED SCHOOL PSYCHOLOGISTS;

12 ~~(b)~~ (c) Prorated for less than full-time employment;

13 ~~(c)~~ (d) Considered regular salary ~~under~~ PURSUANT TO section
14 24-51-101 (42)(a); ~~C.R.S.~~; and

15 ~~(d)~~ (e) In addition to, and not in lieu of, any existing compensation
16 being awarded at the local level to a ~~teacher or principal who holds a~~
17 ~~certification from the national board for professional teaching or principal~~
18 ~~standards~~ SCHOOL PROFESSIONAL.

19 (2) Beginning with the 2009-10 school year FOR NATIONALLY
20 CERTIFIED TEACHERS, SCHOOL COUNSELORS, AND PRINCIPALS, AND
21 BEGINNING WITH THE 2019-20 SCHOOL YEAR FOR NATIONALLY CERTIFIED
22 SCHOOL PSYCHOLOGISTS, subject to available appropriations, an additional
23 annual stipend of three thousand two hundred dollars shall be awarded to
24 any ~~teacher or principal~~ SCHOOL PROFESSIONAL who meets the criteria set
25 forth in subsection (1) of this section and who is employed as of May 1
26 in a given school year in a low-performing, high-needs school. Subject to
27 available appropriations, a ~~teacher or principal~~ SCHOOL PROFESSIONAL

1 shall continue to receive the additional stipend award pursuant to this
2 subsection (2) if ~~he or she~~ THE SCHOOL PROFESSIONAL remains employed
3 in a school that was previously a low-performing, high-needs school but
4 improved sufficiently to implement an improvement or performance plan
5 pursuant to section 22-11-210. The additional stipend for ~~such teachers~~
6 ~~and principals shall be~~ A SCHOOL PROFESSIONAL IS subject to the same
7 restrictions and requirements as set forth in subsection (1) of this section.

8 (4) If insufficient funding is available to award a stipend pursuant
9 to subsection (1) of this section to all ~~teachers and principals who hold a~~
10 ~~certification from the national board for professional teaching or principal~~
11 ~~standards~~ SCHOOL PROFESSIONALS, stipends shall be awarded only to
12 those ~~teachers and principals~~ SCHOOL PROFESSIONALS who meet the
13 criteria of subsection (1) of this section and who are employed in a
14 low-performing, high-needs school.

15 **SECTION 2. Act subject to petition - effective date.** This act
16 takes effect at 12:01 a.m. on the day following the expiration of the
17 ninety-day period after final adjournment of the general assembly (August
18 2, 2019, if adjournment sine die is on May 3, 2019); except that, if a
19 referendum petition is filed pursuant to section 1 (3) of article V of the
20 state constitution against this act or an item, section, or part of this act
21 within such period, then the act, item, section, or part will not take effect
22 unless approved by the people at the general election to be held in
23 November 2020 and, in such case, will take effect on the date of the
24 official declaration of the vote thereon by the governor.
