## Bill Summary

*(Note: This summary applies to this bill as introduced and does not reflect any amendments that may be subsequently adopted. If this bill passes third reading in the house of introduction, a bill summary that applies to the reengrossed version of this bill will be available at <http://leg.colorado.gov>.)*

Current law requires the greater of the first \$40 million of state retail marijuana excise tax revenue or 90% of the revenue to be credited to the public school capital construction assistance fund (assistance fund) and limits the maximum total amount of annual lease payments payable by the state under the terms of all outstanding lease-purchase agreements entered into as authorized by the "Building Excellent Schools Today Act" (BEST) to \$100 million. Beginning July 1, 2019, the bill:

- ! Requires all state retail marijuana excise tax revenue to be credited to the assistance fund;
- ! Increases the maximum total amount of BEST annual lease payments to \$105 million for state fiscal year 2019-20 and to \$110 million for state fiscal year 2020-21 and each state fiscal year thereafter;
- ! Changes the percentage of the state retail marijuana excise tax revenue credited to the assistance fund that is further credited to the charter school facilities assistance account of the assistance fund for distribution to charter schools from 12.5% to a percentage equal to the percentage of students included in the statewide funded pupil count who were enrolled in charter schools for the prior school year; and
- ! Changes the total amount of money annually appropriated from the state education fund for charter school capital construction from a flat amount of \$20 million per year to \$20 million per year annually adjusted for changes in the percentage of students included in the statewide funded pupil count who are enrolled in charter schools.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, 22-43.7-104, **amend**  
3 (2)(d) and (3); and **add** (2)(e) as follows:

4 **22-43.7-104. Public school capital construction assistance fund**  
5 **- creation - crediting of money to fund - use of fund - emergency**

1 **reserve - creation - reserve account - creation and use.**

2 ~~(2) (d) Beginning January 1, 2014, and ending June 30, 2018, the state~~  
3 ~~treasurer, as provided in section 39-28.8-305 (1)(a), shall annually credit~~  
4 ~~to the assistance fund the first forty million dollars received and collected~~  
5 ~~from the excise tax on retail marijuana imposed pursuant to part 3 of~~  
6 ~~article 28.8 of title 39. On and after~~ FOR THE STATE FISCAL YEAR  
7 COMMENCING July 1, 2018, the state treasurer, as provided in section  
8 39-28.8-305 (1)(a), shall annually credit to the assistance fund the greater  
9 of the first forty million dollars received and collected from the excise tax  
10 on retail marijuana imposed pursuant to part 3 of article 28.8 of title 39  
11 or ninety percent of the money received and collected from the tax. FOR  
12 THE STATE FISCAL YEAR COMMENCING JULY 1, 2019, AND FOR EACH STATE  
13 FISCAL YEAR THEREAFTER, THE STATE TREASURER, AS PROVIDED IN  
14 SECTION 39-28.8-305 (1)(a), SHALL ANNUALLY CREDIT TO THE  
15 ASSISTANCE FUND ALL OF THE MONEY RECEIVED AND COLLECTED FROM  
16 THE EXCISE TAX ON RETAIL MARIJUANA IMPOSED PURSUANT TO PART 3 OF  
17 ARTICLE 28.8 OF TITLE 39. FOR STATE FISCAL YEARS COMMENCING BEFORE  
18 JULY 1, 2019, the state treasurer shall credit twelve and five-tenths  
19 percent of the amount annually credited pursuant to this subsection (2)(d)  
20 to the charter school facilities assistance account, which account is  
21 created within the assistance fund. FOR EACH STATE FISCAL YEAR  
22 COMMENCING ON OR AFTER JULY 1, 2019, THE STATE TREASURER SHALL  
23 CREDIT TO THE CHARTER SCHOOL FACILITIES ASSISTANCE ACCOUNT A

5 POSSIBLE, OR AS SOON AS POSSIBLE THEREAFTER, THE STATE TREASURER  
6 SHALL TRANSFER FOUR MILLION TWO HUNDRED FIFTY THOUSAND DOLLARS  
7 FROM THE ASSISTANCE FUND TO THE CHARTER SCHOOL FACILITIES  
8 ASSISTANCE ACCOUNT OF THE ASSISTANCE FUND CREATED IN SUBSECTION  
9 (2)(d) OF THIS SECTION.

10 (3) Subject to annual appropriation, the department may expend  
11 moneys in the assistance fund for the purposes of paying the direct and  
12 indirect administrative costs, including but not limited to the costs of  
13 conducting or contracting for the financial assistance priority assessment  
14 required by section 22-43.7-108 (1), incurred by the division, the board,  
15 and the department in exercising their powers and duties pursuant to this  
16 article, providing financial assistance, making payments required by  
17 section 22-43.7-114, and paying any transaction costs necessarily incurred  
18 in connection with the provision of financial assistance as authorized by

1 the board may also instruct the state treasurer to enter into lease-purchase  
2 agreements on behalf of the state to provide financial assistance to

5 committee has authorized the provision of financial assistance that

- 14 (VI) One hundred million dollars for the 2017-18 ~~fiscal year and~~

- 16 (VII) ONE HUNDRED FIVE MILLION DOLLARS FOR THE 2019-20  
17 FISCAL YEAR; AND
- 18 (VIII) ONE HUNDRED TEN MILLION DOLLARS FOR THE 2020-21  
19 FISCAL YEAR AND FOR EACH FISCAL YEAR THEREAFTER.

20 **SECTION 3.** In Colorado Revised Statutes, **amend** 22-43.7-201  
21 as follows:

22 **22-43.7-201. Full-day kindergarten facility capital**  
23 **construction fund - creation - grants - definitions.** (1) ~~There is hereby~~  
24 ~~established in the state treasury~~ The full-day kindergarten facility capital  
25 construction fund, referred to in this part 2 as the "fund". "FUND", IS  
26 HEREBY CREATED IN THE STATE TREASURY. The fund shall consist  
27 CONSISTS of any ~~moneys annually appropriated thereto by the general~~

1 ~~assembly for the purposes of this part 2. All interest and income earned~~  
2 ~~on the deposit of moneys in the fund shall be credited to the fund. Any~~  
3 ~~unexpended and unencumbered moneys remaining in the fund at the end~~  
4 ~~of a budget year shall remain in the fund and shall not be credited or~~  
5 ~~transferred to the general fund or any other fund.~~ MONEY THAT THE  
6 GENERAL ASSEMBLY MAY APPROPRIATE OR TRANSFER TO THE FUND. THE  
7 STATE TREASURER SHALL CREDIT ALL INTEREST AND INCOME DERIVED  
8 FROM THE DEPOSIT AND INVESTMENT OF MONEY IN THE FUND TO THE

16 construction project to renovate a facility, rent a facility, or provide a  
17 temporary auxiliary facility that will be used in conjunction with  
18 providing a full-day kindergarten program. The board shall award a grant  
19 or matching grant pursuant to this part 2 to a school district or institute  
20 charter school only if, without the grant or matching grant, the school  
21 district or institute charter school would be unable to provide a facility in  
22 which to offer a full day of kindergarten to more students than were  
23 offered a full day of kindergarten in the 2007-08 budget year. For  
24 purposes of this part 2, "temporary auxiliary facility" means a temporary  
25 building that will be placed on the same campus as a main educational  
26 facility.

1 SECTION, each budget year, the board shall use fifty percent of the moneys  
2 MONEY in the fund to provide grants pursuant to this part 2 and fifty  
3 percent of the moneys MONEY in the fund to provide matching grants  
4 pursuant to this part 2.

13 (II) "EQUITABLE ADJUSTMENT FACTOR" MEANS, WITH RESPECT TO  
14 BOTH AN APPLICANT AND A POTENTIAL APPLICANT THAT DOES NOT  
15 ACTUALLY APPLY FOR A GRANT AS AUTHORIZED BY THIS SUBSECTION (4)  
16 THE SUM OF THE APPLICANT'S:

17 (A) SIZE FACTOR, AS DETERMINED PURSUANT TO SECTION  
18 22-54-104 (5)(b)(I.5);

19 (B) PERCENTAGE OF ENROLLED PUPILS WHO ARE ELIGIBLE FOR  
20 FREE OR REDUCED PRICE LUNCH;

21 (C) PERCENTAGE OF ENROLLED PUPILS WHO ARE ENGLISH  
22 LANGUAGE LEARNERS, AS DEFINED IN SECTION 22-24-103 (4); AND

23 (D) PERCENTAGE OF ENROLLED PUPILS WHO ARE SPECIAL  
24 EDUCATION STUDENTS.

25 (III) "EQUITABLY ADJUSTED FUNDING" MEANS, WITH RESPECT TO  
26 BOTH AN APPLICANT AND A POTENTIAL APPLICANT WHO DOES NOT  
27 ACTUALLY APPLY FOR A GRANT AS AUTHORIZED BY THIS SUBSECTION (4)

1 THE PRODUCT OF TOTAL APPLICANT PER PUPIL FUNDING AND THE  
2 EQUITABLE ADJUSTMENT FACTOR.

3 (IV) "TOTAL APPLICANT PER PUPIL FUNDING" MEANS, WITH  
4 RESPECT TO BOTH AN APPLICANT AND A POTENTIAL APPLICANT WHO DOES  
5 NOT ACTUALLY APPLY FOR A GRANT AS AUTHORIZED BY THIS SUBSECTION  
6 (4) THE PRODUCT OF THE NUMBER OF CHILDREN ENROLLED IN A FULL-DAY  
7 KINDERGARTEN EDUCATIONAL PROGRAM PROVIDED BY THE APPLICANT  
8 DURING THE 2019-20 BUDGET YEAR AND THE APPLICANT'S PER PUPIL  
9 FUNDING AMOUNT, AFTER APPLICATION OF SECTION 22-54-104 (5)(g), FOR  
10 THE 2019-20 BUDGET YEAR.

11 (b) ON JULY 1, 2019, THE STATE TREASURER SHALL TRANSFER  
12 TWENTY-FIVE MILLION DOLLARS FROM THE ASSISTANCE FUND TO THE  
13 FUND. DURING THE 2018-19 BUDGET YEAR, THE BOARD SHALL ACCEPT  
14 APPLICATIONS FROM APPLICANTS THAT WILL PROVIDE A FULL-DAY  
15 KINDERGARTEN EDUCATIONAL PROGRAM FOR THE 2019-20 BUDGET YEAR  
16 FOR FINANCIAL ASSISTANCE IN THE FORM OF FORMULA-BASED GRANTS IN  
17 A TOTAL AMOUNT OF UP TO TWENTY-FIVE MILLION DOLLARS FOR THE  
18 2019-20 BUDGET YEAR. THE BOARD SHALL ESTABLISH GRANT  
19 APPLICATION REQUIREMENTS AND DEADLINES THAT ALLOW APPLICANTS  
20 TO EFFICIENTLY PROVIDE THE INFORMATION NEEDED TO ALLOW THE  
21 BOARD TO QUICKLY DETERMINE THE ESTIMATED AMOUNT OF THE  
22 FORMULA-BASED GRANT TO BE AWARDED TO EACH APPLICANT AND  
23 EXPEDITE DISTRIBUTION OF THE FORMULA-BASED GRANTS.

24 (c) THE AMOUNT OF THE GRANT TO BE PROVIDED TO EACH  
25 APPLICANT PURSUANT TO SUBSECTION (4)(b) OF THIS SECTION IS  
26 DETERMINED BY THE FOLLOWING FORMULA:

27 THE LESSER OF \$25,000,000 X THE APPLICANT SHARE



1 PERCENTAGE OR THE AMOUNT ACTUALLY APPLIED FOR BY  
2 THE APPLICANT.

3 ON JULY 1, 2020, THE STATE TREASURER SHALL TRANSFER FROM THE  
4 FUND TO THE ASSISTANCE FUND ANY PORTION OF THE TWENTY-FIVE  
5 MILLION DOLLARS PREVIOUSLY TRANSFERRED FROM THE ASSISTANCE  
6 FUND TO THE FUND AS REQUIRED BY SUBSECTION (4)(b) OF THIS SECTION  
7 THAT IS NOT DISTRIBUTED TO APPLICANTS AS FORMULA-BASED GRANTS  
8 DURING THE 2019-20 BUDGET YEAR.

9 (d) ON JULY 1, 2019, OR AS SOON AS FEASIBLE THEREAFTER, THE  
10 BOARD SHALL CAUSE TO BE DISTRIBUTED TO EACH APPLICANT EIGHTY  
11 PERCENT OF THE ESTIMATED AMOUNT OF THE APPLICANT'S  
12 FORMULA-BASED GRANT. AS SOON AS FEASIBLE FOLLOWING THE FINAL  
13 DETERMINATION OF STATEWIDE AND APPLICANT FULL-DAY KINDERGARTEN  
14 ENROLLMENT FOR THE 2019-20 BUDGET YEAR AND NO LATER THAN  
15 FEBRUARY 15, 2020, THE BOARD SHALL DETERMINE THE FINAL AMOUNT  
16 OF EACH APPLICANT'S FORMULA-BASED GRANT AND CAUSE TO BE  
17 DISTRIBUTED TO EACH APPLICANT ANY ADDITIONAL AMOUNT NEEDED TO  
18 ENSURE THAT EACH APPLICANT RECEIVES THE FULL FINAL AMOUNT OF ITS  
19 GRANT.

20 (e) AS SOON AS POSSIBLE AFTER RECEIVING EACH DISTRIBUTION  
21 DESCRIBED IN THIS SECTION, THE AUTHORIZER FOR A CHARTER SCHOOL  
22 THAT OPERATES A FULL-DAY KINDERGARTEN EDUCATIONAL PROGRAM  
23 SHALL DISTRIBUTE TO THE CHARTER SCHOOL, IN A LUMP SUM, ONE  
24 HUNDRED PERCENT OF THE AMOUNT RECEIVED THAT IS ATTRIBUTABLE TO  
25 THE FULL-DAY KINDERGARTEN PUPILS ENROLLED IN THE CHARTER  
26 SCHOOL.

27 (f) AN APPLICANT MAY EXPEND A FORMULA-BASED GRANT

1 RECEIVED PURSUANT TO THIS SUBSECTION (4) DURING THE 2019-20  
2 BUDGET YEAR FOR THE PURPOSE OF ACQUIRING FURNITURE, FIXTURES, OR  
3 OTHER FIXED OR MOVEABLE EQUIPMENT, EXCLUDING CONSTRUCTION  
4 EQUIPMENT, THAT IS NEEDED TO CONDUCT A FULL-DAY KINDERGARTEN  
5 EDUCATIONAL PROGRAM OR A PRESCHOOL EDUCATIONAL PROGRAM.

6 **SECTION 4.** In Colorado Revised Statutes, 22-54-124, **amend**  
7 (3)(a)(IV)(B); and **add** (3)(a)(IV)(C) as follows:

9 **fund money - definitions.** (3) (a) (IV) (B) The total amount of state  
10 education fund ~~moneys~~ MONEY to be appropriated for all eligible districts  
11 and all eligible institute charter schools for the 2015-16 budget year and  
12 FOR each budget year thereafter THROUGH THE 2018-19 BUDGET YEAR is  
13 twenty million dollars.

14 (C) THE TOTAL AMOUNT OF STATE EDUCATION FUND MONEY TO BE  
15 APPROPRIATED FOR ALL ELIGIBLE DISTRICTS AND ALL ELIGIBLE INSTITUTE  
16 CHARTER SCHOOLS FOR THE 2019-20 BUDGET YEAR AND FOR EACH  
17 BUDGET YEAR THEREAFTER IS TWENTY MILLION DOLLARS MULTIPLIED BY
