**A BILL FOR AN ACT**

101      **CONCERNING THE ISSUANCE BY THE DEPARTMENT OF REVENUE OF**  
102              **IDENTIFICATION DOCUMENTS TO PEOPLE WHO ARE NOT**  
103              **LAWFULLY PRESENT IN COLORADO ON A PERMANENT BASIS,**  
104              **AND, IN CONNECTION THEREWITH, MAKING AN APPROPRIATION.**

**Bill Summary**

1 *Be it enacted by the General Assembly of the State of Colorado:*

2           **SECTION 1.** In Colorado Revised Statutes, **amend** 42-2-508 as  
3 follows:

4           **42-2-508. Fees - operations - rule - repeal.** (1) The department  
5 may promulgate a rule imposing an additional fee for issuance of a  
6 document issued under this part 5 to cover the direct and indirect cost of  
7 implementing this part 5. The department shall set the fee in accordance  
8 with section 42-2-114.5 (2). The department shall transfer the fees to the  
9 state treasurer, who shall credit the fees to the licensing services cash  
10 fund, created in section 42-2-114.5 (1).

11           (2) (a) BY JANUARY 1, 2020, THE DEPARTMENT SHALL ISSUE  
12 IDENTIFICATION DOCUMENTS UNDER THIS PART 5 IN AN EFFICIENT MANNER  
13 AT EIGHT OR MORE OFFICES, INCLUDING OFFICES OPERATING BEFORE  
14 JANUARY 1, 2020, THAT ARE GEOGRAPHICALLY DISTRIBUTED  
15 THROUGHOUT THE STATE. THIS SUBSECTION (2)(a) IS REPEALED,  
16 EFFECTIVE JULY 1, 2020.

17           (b) BY JULY 1, 2020, THE DEPARTMENT SHALL ISSUE  
18 IDENTIFICATION DOCUMENTS UNDER THIS PART 5 IN AN EFFICIENT MANNER  
19 AT TEN OR MORE OFFICES, INCLUDING OFFICES OPERATING BEFORE JULY 1,  
20 2020, THAT ARE GEOGRAPHICALLY DISTRIBUTED THROUGHOUT THE STATE.

21           **SECTION 2. Appropriation.** For the 2019-20 state fiscal year,  
22 \$1,737,800 is appropriated to the department of revenue. This  
23 appropriation is from the licensing services cash fund created in section  
24 42-2-114.5 (1), C.R.S., and is based on an assumption that the department  
25 will require an additional 21.6 FTE. To implement this act, the

13 **SECTION 3. Safety clause.** The general assembly hereby finds,  
14 determines, and declares that this act is necessary for the immediate  
15 preservation of the public peace, health, and safety.
