 24        *in the Legislative Council acting as a committee of reference in the*  
 25        *second house on the day of the asterisked final passage deadline are*  
 26        *excluded from the final passage deadline and from other deadlines*  
 27        *specified in this Joint Rule until the deadlines for passing bills in the*  
 28        *Appropriations Committee or passing bills in the Legislative Council. The*  
 29        *majority leader in each house shall direct that a memo be prepared on*  
 30        *the date of the asterisked final passage deadline that lists all of the bills*  
 31        *to which this exclusion applies. A copy of the memo shall be attached to*  
 32        *each bill listed in the memo and a copy shall be sent to each of the bill's*  
 33        *sponsors. At the discretion of the respective majority leaders, the list may*  
 34        *include any bills that have been referred out of the Appropriations*  
 35        *Committee during the seven legislative days preceding the asterisked*  
 36        *final passage deadline. In addition, bills in the Appropriations Committee*  
 37        *in either house on the day of a separate final passage deadline as*

1 *specified by the Committee on Delayed Bills for that house are also*  
2 *excluded from the specified final passage deadline unless otherwise*  
3 *indicated in the delayed bill form.*

4 (1.6) A member of the General Assembly shall introduce a bill  
5 for an increase in the number of district judges in a judicial  
6 district, or for an increase in the number of county judges  
7 in a county, no later than 1<sup>st</sup> day of a regular legislative  
8 session. The deadline for final passage of any such bills,  
9 including any conference committee report, ~~shall be~~ IS the  
10 ~~60<sup>th</sup>~~ **59<sup>th</sup>** legislative day.

11 (2) All bills which a member requested pursuant to Joint Rule  
12 24 (b)(1)(A) on or before ~~November 26 or December 10~~  
13 ~~DECEMBER 1 OR DECEMBER 15~~, whichever is applicable,  
14 ~~shall~~ **MUST** be introduced no later than the initial deadline  
15 for introduction of bills, subject to the following  
16 conditions:

17 (A) A member is not required to introduce more than  
18 three bills by said initial deadline;

19 (B) A member may choose to introduce any bill  
20 requested after said ~~November 26 or December 10~~  
21 ~~DECEMBER 1 OR DECEMBER 15~~ instead of any bill  
22 requested on or before said ~~November 26 or~~  
23 ~~December 10~~ ~~DECEMBER 1 OR DECEMBER 15~~; and

24 (C) One of the three bills that a member may request  
25 prior to said ~~November 26 or December 10~~ ~~shall~~  
26 ~~DECEMBER 1 OR DECEMBER 15~~ **MUST** be filed with  
27 the house of introduction ~~7~~ **5** days prior to the first  
28 day of the session for printing, distribution to  
29 Legislative Council staff for preparation of a fiscal  
30 note, and introduction on the 1<sup>st</sup> day.

31 That in the Joint Rules of the Senate and House of  
32 Representatives, Rule No. 24, **amend** (b)(1)(A) and (c) as follows:

33 **24. SPONSORSHIP OF BILLS**

34 (b) (1) (A) A member of the General Assembly may not



1 introduce more than five bills in a regular session of  
2 the General Assembly, excluding bills for  
3 appropriations and excluding the bills specified in  
4 subparagraph (D) of this paragraph (1). Permission  
5 to exceed the limits established by this rule may be  
6 given by the Senate Committee on Delayed Bills for  
7 members of the Senate and the House Committee on  
8 Delayed Bills for members of the House of  
9 Representatives. Of the bills which are subject to  
10 the five-bill limit under this subparagraph (A), not  
11 more than two bills may be requested after the  
12 ~~November 26~~ DECEMBER 1 which precedes the  
13 convening of the regular session; except that any  
14 member who will serve in the regular session in an  
15 odd-numbered year but who is not a member of the  
16 current General Assembly may not introduce more  
17 than two bills requested after the ~~December 10~~  
18 DECEMBER 15 which precedes the convening of said  
19 odd-year session. Bills requested on or before said  
20 ~~November 26 or December 10~~ DECEMBER 1 OR  
21 DECEMBER 15, as the case may be, ~~shall be~~ ARE  
22 treated as if requested to be prefiled bills, unless the  
23 member making the request specifies otherwise.

24 (c) Any member of the General Assembly who submits a bill draft  
25 request to the Office of Legislative Legal Services by subject only  
26 shall provide the necessary information to enable the office to  
27 proceed with the drafting of the bill as soon as possible. On and  
28 after ~~November 26 or December 10~~ DECEMBER 1 OR DECEMBER  
29 15, whichever is applicable, a member may not have more than  
30 five draft requests for bills that are not subject to approval under  
31 subsection (b)(1)(D) of this Joint Rule on file with the Office of  
32 Legislative Legal Services at any time.
