101 **CONCERNING HEALTH INSURANCE COVERAGE FOR COLORECTAL**  
102 **CANCER SCREENING.**

**Bill Summary**

Current law requires health insurance carriers (carriers) to provide preventive health insurance coverage for colorectal cancer screenings in accordance with U.S. preventive services task force guidelines. The bill requires carriers to instead provide coverage for colorectal cancer screenings in accordance with American Cancer Society guidelines. The coverage must include coverage for a colonoscopy or other medical test

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, 10-16-104, **amend**  
3 (18)(b)(V) as follows:

4 **10-16-104. Mandatory coverage provisions - definitions -**  
5 **rules. (18) Preventive health care services (b)** The coverage required  
6 by this subsection (18) must include preventive health care services for  
7 the following, in accordance with the A or B recommendations of the task  
8 force for the particular preventive health care service:

9 (V) (A) Colorectal cancer screening coverage for tests for the  
10 early detection of colorectal cancer and adenomatous polyps; EXCEPT  
11 THAT, IN ADDITION TO THE A OR B RECOMMENDATION OF THE TASK  
12 FORCE, THE COVERAGE MUST INCLUDE COVERED PERSONS WHO ARE  
13 FORTY-FIVE YEARS OF AGE OR OLDER.

14 (B) In addition to covered persons eligible for colorectal cancer  
15 screening coverage in accordance with A or B recommendations of the  
16 task force, colorectal cancer screening coverage required by this  
17 subparagraph (V) shall also be provided: To covered persons who are at  
18 high risk for colorectal cancer, including covered persons who have a  
19 family medical history of colorectal cancer; a prior occurrence of cancer  
20 or precursor neoplastic polyps; a prior occurrence of a chronic digestive  
21 disease condition such as inflammatory bowel disease, Crohn's disease,  
22 or ulcerative colitis; or other predisposing factors as determined by the  
23 provider; AND FOR A FOLLOW-UP COLONOSCOPY IF THE RESULTS OF A  
24 NONINVASIVE TEST FOR THE EARLY DETECTION OF COLORECTAL CANCER  
25 AND ADENOMATOUS POLYPS IS ABNORMAL.

1           **SECTION 2. Safety clause.** The general assembly hereby finds,  
2 determines, and declares that this act is necessary for the immediate  
3 preservation of the public peace, health, or safety.
