1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, **amend** 12-10-906 as
3 follows:

4 **12-10-906. Repeal of part - subject to review.** This part 9 is
5 repealed, effective ~~July 1, 2020~~ SEPTEMBER 1, 2026. Before the repeal,
6 this part 9 is scheduled for review in accordance with section 24-34-104.

7 **SECTION 2.** In Colorado Revised Statutes, 24-34-104, **add**
8 (27)(a)(XVII) as follows:

9 **24-34-104. General assembly review of regulatory agencies**
10 **and functions for repeal, continuation, or reestablishment - legislative**
11 **declaration - repeal.** (27) (a) The following agencies, functions, or both,
12 are scheduled for repeal on September 1, 2026:

13 (XVII) THE LEGAL REQUIREMENTS PERTAINING TO HOME
14 WARRANTY SERVICE CONTRACTS UNDER PART 9 OF ARTICLE 10 OF TITLE
15 12.

16 **SECTION 3.** In Colorado Revised Statutes, **amend** 12-10-905 as
17 follows:

18 **12-10-905. Prohibitions.** It is unlawful for any lending institution
19 to require the purchase of A home warranty ~~insurance~~ SERVICE CONTRACT
20 as a condition for granting financing for the purchase of the home.

21 **SECTION 4. Safety clause.** The general assembly hereby finds,
22 determines, and declares that this act is necessary for the immediate
23 preservation of the public peace, health, or safety.
