**Fiscal Impact of Bill as Amended to Date**

## JBC Staff Analysis

- Section 2 appropriates \$50,000 General Fund to the Youth Advisory Council Cash Fund for FY 2020-21.
- Section 3 authorizes the Legislative Council to spend \$24,000 of an existing FY 2019-20 appropriation in the next fiscal year (FY 2020-21) for new member orientation.
