101 **CONCERNING CONTINUING THE NECESSARY DOCUMENT PROGRAM**
102 **INDEFINITELY, AND, IN CONNECTION THEREWITH, MAKING AN**
103 **APPROPRIATION.**

Bill Summary

1 **SECTION 1.** In Colorado Revised Statutes, 25-4-2208, amend
2 (4) as follows:

3 **25-4-2208. Necessary document program - report - definition.**

4 (4) ~~This section is repealed, effective September 1, 2021.~~ BEGINNING
5 JANUARY 1, 2032, AND EACH FIVE YEARS THEREAFTER, THE DEPARTMENT
6 SHALL INCLUDE, AS PART OF ITS ANNUAL PRESENTATION TO THE GENERAL
7 ASSEMBLY PURSUANT TO THE "STATE MEASUREMENT FOR ACCOUNTABLE,
8 RESPONSIVE, AND TRANSPARENT (SMART) GOVERNMENT ACT", PART 2
9 OF ARTICLE 7 OF TITLE 2, A REPORT ON THE TOTAL NUMBER OF NECESSARY
10 DOCUMENTS ACQUIRED ON AN ANNUAL BASIS AND ANY SIGNIFICANT
11 TECHNOLOGICAL CHANGES OR OTHER DEVELOPMENTS THAT AFFECT THE
12 NEED FOR, OR OPERATIONS OF, THE NECESSARY DOCUMENT PROGRAM.

13 **SECTION 2. Appropriation.** For the 2021-22 state fiscal year,
14 \$250,000 is appropriated to the department of public health and
15 environment for use by the office of health equity. This appropriation is
16 from the general fund. To implement this act, the office may use this
17 appropriation for necessary document assistance.

18 **SECTION 3. Safety clause.** The general assembly hereby finds,
19 determines, and declares that this act is necessary for the immediate
20 preservation of the public peace, health, or safety.
