A BILL FOR AN ACT
CONCERNING EMERGENCY SUPPLIES FOR COLORADO BABIES AND
FAMILIES, AND, IN CONNECTION THEREWITH, PROVIDING
DIAPERING ESSENTIALS THROUGH DIAPER DISTRIBUTION
CENTERS AND MAKING AN APPROPRIATION.

Bill Summary

The bill requires the department of public health and environment to select one or more nonprofit organizations to administer diaper distribution centers that provide diapering essentials to eligible SENATE 3rd Reading Unamended May 7, 2021

SENATE Amended 2nd Reading May 6, 2021 individuals. Diapering essentials must be made available to all Colorado residents.

Be it enacted by the General Assembly of the State of Colorado: 1 2 **SECTION 1. Legislative declaration.** (1) The general assembly 3 finds and declares that: 4 Prior to the COVID-19 pandemic, one in three families 5 reported needing more diapering essentials and with unprecedented 6 unemployment rates due to the pandemic, this need is drastically higher. 7 With 202,608 children under the age of three in Colorado, 67,536 of them 8 experienced the negative effects of diapering-essential needs. 9 (b) The National Diaper Bank Network has seen the demand for 10 diapering essentials increase by as much as 300 percent in some areas of 11 the country and Colorado diaper banks report seeing four times the need 12 for diapering essentials due to the COVID-19 pandemic's impacts on 13 families; 14 (c) Thirty-five percent of Coloradans reported finding it difficult 15 or somewhat difficult to pay for basic necessities after the COVID-19 16 pandemic began, and parents are having to cut back on necessities such 17 as food and rent in order to afford diapering essentials; 18 (d) According to the National Diaper Bank Network, it costs at 19 least \$80 a month to diaper a child and diapering essentials cannot be 20 purchased through other public assistance programs such as the 21 supplemental nutrition assistance program or the women, infants, and 22 children program. Diaper banks' distribution of diapers to low-income 23 families is associated with increases in the personal income of recipients, 24 the elimination of medical expenses, and increases in state tax revenue.

(e) Parents report reusing disposable diapers, plastic bags, and

1	toilet paper when they run out of money for diapering essentials, leading
2	to painful diaper rash and health complications for children; and
3	(f) An adequate supply of diapers may prove to be a tangible way
4	of reducing parenting stress, which is a critical factor that influences child
5	health and development.
6	(2) Therefore, the general assembly finds and declares that it is
7	imperative to provide emergency diapering essentials to Colorado babies
8	and families in need.
9	SECTION 2. In Colorado Revised Statutes, add 26-2-140 as
10	<u>follows:</u>
11	26-2-140. Colorado diaper distribution program - diapering
12	essentials - report - rules - definitions. (1) As used in this section,
13	UNLESS THE CONTEXT OTHERWISE REQUIRES:
14	(a) "DIAPER DISTRIBUTION CENTER" MEANS A COMMUNITY-BASED
15	DIAPER BANK OR DISTRIBUTION CENTER OPERATING IN COLORADO, A
16	PUBLIC HEALTH AGENCY CREATED PURSUANT TO SECTION 25-1-506, OR A
17	COLORADO NONPROFIT ORGANIZATION WITH A MINIMUM OF THREE YEARS
18	EXPERIENCE DISTRIBUTING BABY OR TODDLER PRODUCTS.
19	(b) "Diapering essentials" includes diapers, wipes, and
20	DIAPER CREAMS.
21	(c) "Eligible individual" means a parent, guardian, or
22	FAMILY MEMBER OF A CHILD WHO WEARS DIAPERS AND RESIDES IN
23	<u>Colorado.</u>
24	(d) "PROGRAM" MEANS THE COLORADO DIAPER DISTRIBUTION
25	PROGRAM CREATED IN SECTION SUBSECTION (2) OF THIS SECTION.
26	(2) There is created in the state department the Colorado

2	(3) (a) NO LATER THAN THIRTY DAYS AFTER THE EFFECTIVE DATE

15	OPERATE FOR NOT MORE THAN TWELVE MONTHS AFTER WHICH THE STATE
16	DEPARTMENT MUST COMMENCE A SELECTION PROCESS THAT COMPLIES
17	WITH THE "PROCUREMENT CODE", ARTICLES 101 TO 112 OF TITLE 24.
18	(4) THE STATE DEPARTMENT MAY PROMULGATE RULES FOR THE
19	IMPLEMENTATION OF THIS SECTION.
20	(5) FOR THE 2021-22 STATE FISCAL YEAR, THE STATE DEPARTMENT
21	SHALL SUBMIT A PRELIMINARY REPORT, AND BEGINNING IN STATE FISCAL
22	YEAR 2022-23, AND EACH FISCAL YEAR THEREAFTER, THE STATE
23	DEPARTMENT SHALL REPORT TO THE PUBLIC THROUGH THE ANNUAL

11	MILLION DOLLARS FROM THE GENERAL FUND TO THE STATE DEPARTMENT
12	FOR USE BY THE DIAPER DISTRIBUTION CENTERS FOR THE IMPLEMENTATION
13	OF THIS SECTION. THE STATE DEPARTMENT MAY USE UP TO ONE HUNDRED
14	THOUSAND DOLLARS OR SEVEN AND A HALF PERCENT OF ANY MONEY
15	APPROPRIATED BY THE GENERAL ASSEMBLY FOR ADMINISTRATIVE COSTS
16	INCURRED BY THE STATE DEPARTMENT PURSUANT TO THIS SECTION.

18	SECTION 3. Appropriation. For the 2021-22 state fiscal year,
19	\$2,000,000 is appropriated to the department of human services for use
20	by the office of self sufficiency. This appropriation is from the general
21	fund and is based on an assumption that the office will require an
22	additional 1.9 FTE. To implement this act, the office may use this
23	appropriation for the Colorado diaper distribution program.
24	SECTION <u>4.</u> Safety clause. The general assembly hereby finds,
25	determines, and declares that this act is necessary for the immediate
26	preservation of the public peace, health, or safety.
