101      **CONCERNING THE CREATION OF THE OUTDOOR EQUITY GRANT**  
102              **PROGRAM, AND, IN CONNECTION THEREWITH, FUNDING THE**  
103              **GRANT PROGRAM FROM LOTTERY MONEY, AND MAKING AN**  
104              **APPROPRIATION.**

**Bill Summary**

The bill establishes an outdoor equity board (board) in the division of parks and wildlife. The board is responsible for the governance of the outdoor equity grant program (grant program), which is created in the bill.

The purpose of the outdoor equity grant program is to increase access and opportunity for underserved youth and their families to experience Colorado's open spaces, state parks, public lands, and other outdoor areas.

The bill specifies that the board may award grants to applicants that will directly utilize the grant to engage eligible youth and their families by reducing barriers to the Colorado outdoors, creating pathways for formal or informal conservation of the Colorado outdoors, or offering environmental and Colorado outdoor-based educational opportunities.

The bill funds the grant program through a redistribution of lottery money that is earmarked for the general fund.

2           **SECTION 1.** In Colorado Revised Statutes, **add** part 2 to article  
3 9 of title 33 as follows:

6           **33-9-201. Legislative declaration.** (1) THE GENERAL ASSEMBLY  
7 FINDS THAT:

8                   (a) THE PURPOSE OF THE OUTDOOR EQUITY GRANT PROGRAM IS TO  
9 INCREASE ACCESS AND OPPORTUNITY FOR UNDERSERVED YOUTH AND  
10 THEIR FAMILIES TO EXPERIENCE COLORADO'S OPEN SPACES, STATE PARKS,  
11 PUBLIC LANDS, AND OTHER OUTDOOR AREAS THROUGH PROGRAMS WITH  
12 A FOCUS ON CONSERVATION, THE ENVIRONMENT, OUTDOOR EDUCATION,  
13 OR OUTDOOR RECREATION;

14                   (b) COLORADO IS A STATE OF DYNAMIC GROWTH, CHANGE, AND  
15 PROGRESS. IT IS INTERNATIONALLY RENOWNED FOR ITS BEAUTY AND VAST  
16 SCOPE OF YEAR-ROUND OUTDOOR ACTIVITIES, NATURAL LANDSCAPES, AND  
17 MOUNTAIN ADVENTURES.

18                   (c) PARADOXICALLY, DESPITE THE PLETHORA OF OUTDOOR  
19 OPPORTUNITIES, CERTAIN DEMOGRAPHICS OF COLORADO YOUTH AND  
20 THEIR FAMILIES FACE REAL CHALLENGES AND OBSTACLES TO ACCESSING

1 NATURE;

2 (d) A CLEAR LACK OF EQUITY EXISTS FOR LOW-INCOME,  
3 INNER-CITY, RURAL, RACIALLY, AND ETHNICALLY DIVERSE YOUTH, FOR  
4 YOUTH WHO ARE LESBIAN, GAY, BISEXUAL, TRANSGENDER, OR QUEER OR  
5 QUESTIONING, FOR NATIVE AMERICAN OR INDIGENOUS YOUTH, AND FOR  
6 YOUTH WITH DISABILITIES TO ENGAGE IN MEANINGFUL OUTDOOR  
7 EXPERIENCES AND NATURE-BASED EDUCATION;

8 (e) HISTORIC AND CHRONIC SYSTEMIC INEQUITIES HAVE MADE  
9 ACCESS TO NATURE MORE CHALLENGING FOR THESE YOUTH;

10 (f) RESEARCH CONFIRMS THAT TIME SPENT OUTSIDE IS ESSENTIAL  
11 TO HEALTH AND WELL-BEING; IT IMPROVES PHYSICAL AND MENTAL  
12 HEALTH, REDUCES STRESS, AND ENHANCES SOCIAL SKILLS; AND

13 (g) MORE TIME SPENT IN NATURE FOR DISPOSSESSED YOUTH CAN  
14 TRANSLATE TO BETTER ACADEMIC PERFORMANCE, INCREASED  
15 ENTHUSIASM FOR SCHOOL AND SCHOOL ACTIVITIES, AND A LESSENER  
16 LIKELIHOOD FOR ATTENDANCE PROBLEMS.

17 (2) THE GENERAL ASSEMBLY FURTHER FINDS AND DECLARES THAT  
18 IT IS NECESSARY TO ESTABLISH AN OUTDOOR EQUITY GRANT PROGRAM TO  
19 FUND PROGRAMS AND MEANINGFUL EXPERIENCES LED BY COMMUNITY  
20 MEMBERS AND LEADERS WHO UNDERSTAND THE UNIQUE NEEDS AND  
21 PERSPECTIVES OF UNDERSERVED YOUTH AND THEIR COMMUNITIES IN  
22 ORDER TO ENSURE LONG-TERM AND SUSTAINABLE INVESTMENTS FOR NEW  
23 GENERATIONS OF OUTDOOR ENTHUSIASTS AND CONSERVATIONISTS.

24 **33-9-202. Definitions.** AS USED IN THIS PART 2, UNLESS THE  
25 CONTEXT OTHERWISE REQUIRES:

26 (1) "APPLICANT" MEANS A GOVERNMENTAL ENTITY, A NONPROFIT  
27 ORGANIZATION, A FOR-PROFIT ORGANIZATION, OR A FEDERALLY

1 RECOGNIZED TRIBE THAT IS LOCATED IN THE STATE.

2 (2) "COLORADO OUTDOORS" MEANS COLORADO'S OPEN SPACES,

11 COLORADO AND WHO IS ELIGIBLE FOR ADMISSION TO PUBLIC SCHOOL IN  
12 THE STATE OR WHO IS NO LONGER ELIGIBLE FOR ADMISSION TO PUBLIC  
13 SCHOOL IN THE STATE BUT IS NOT YET TWENTY-SIX YEARS OLD, AND  
14 INCLUDES THE PERSON'S FAMILY.

15 (7) "EXECUTIVE DIRECTOR" MEANS THE EXECUTIVE DIRECTOR OF  
16 THE DEPARTMENT OF NATURAL RESOURCES.

17 (8) "LOW INCOME" MEANS MEDIAN HOUSEHOLD INCOME THAT IS  
18 LESS THAN OR EQUAL TO TWO HUNDRED PERCENT OF THE FEDERAL  
19 POVERTY LINE.

20 (9) "OUTDOOR EQUITY BOARD" OR "BOARD" MEANS THE OUTDOOR  
21 EQUITY BOARD CREATED IN SECTION 33-9-203.

22 (10) "OUTDOOR EQUITY FUND" OR "FUND" MEANS THE OUTDOOR  
23 EQUITY FUND CREATED IN SECTION 33-9-206.

24 (11) "OUTDOOR EQUITY GRANT PROGRAM" OR "GRANT PROGRAM"  
25 MEANS THE OUTDOOR EQUITY GRANT PROGRAM CREATED IN SECTION  
26 33-9-205.

27 **33-9-203. Outdoor equity board - creation - terms - per diem**

1     **and expense reimbursement.** (1) THERE IS HEREBY CREATED THE  
2     OUTDOOR EQUITY BOARD IN THE DIVISION OF PARKS AND WILDLIFE. THE  
3     BOARD IS RESPONSIBLE FOR THE GOVERNANCE OF THE OUTDOOR EQUITY  
4     GRANT PROGRAM.

5             (2) THE BOARD CONSISTS OF THE FOLLOWING NINE VOTING  
6     MEMBERS AS FOLLOWS:

7             (a) ONE MEMBER PERSONALLY IMPACTED BY AND WITH  
8     EXPERIENCE IN RACIAL JUSTICE ISSUES;

9             (b) ONE MEMBER PERSONALLY IMPACTED BY AND WITH  
10    EXPERIENCE IN ENVIRONMENTAL JUSTICE ISSUES;

11            (c) ONE MEMBER WITH EXPERIENCE WORKING ON CONSERVATION  
12    ISSUES;

13            (d) ONE MEMBER WITH EXPERIENCE IN PROVIDING OUTDOOR  
14    EDUCATION PROGRAMS;

15            (e) ONE MEMBER PERSONALLY IMPACTED BY AND WITH  
16    EXPERIENCE IN DISABILITY-ACCESSIBLE OUTDOOR PROGRAMMING;

17            (f) ONE MEMBER PERSONALLY IMPACTED BY AND WITH  
18    EXPERIENCE IN EQUITY FOR INDIVIDUALS WHO ARE LESBIAN, GAY,  
19    BISexual, TRANSGENDER, OR QUEER OR QUESTIONING; AND

20            (g) THREE YOUTH MEMBERS FROM COMMUNITIES ELIGIBLE TO BE  
21    SERVED BY THE GRANT PROGRAM AT THE TIME OF THEIR APPOINTMENT.

22            (3) THE BOARD CONSISTS OF THE FOLLOWING THREE NONVOTING  
23    MEMBERS AS FOLLOWS:

24            (a) THE DIRECTOR OF THE COLORADO OUTDOOR RECREATION  
25    INDUSTRY OFFICE, CREATED IN SECTION 24-48.5-129, OR THEIR APPOINTEE;

26            (b) THE DIRECTOR OF THE DIVISION OF PARKS AND WILDLIFE, OR  
27    THEIR APPOINTEE; AND

1 (c) THE EXECUTIVE DIRECTOR OF THE GREAT OUTDOORS  
2 COLORADO PROGRAM, OR THEIR APPOINTEE.

3 (4) (a) THE DIRECTOR SHALL APPOINT THE VOTING MEMBERS OF  
4 THE BOARD IN CONSULTATION WITH THE EXECUTIVE DIRECTOR.

5 (b) THE DIRECTOR SHALL ACCEPT NOMINATIONS FOR BOARD  
6 MEMBERS THROUGH AN OPEN AND PUBLIC PROCESS ESTABLISHED BY THE  
7 DIVISION THAT ENGAGES NONPROFIT AND PUBLIC ORGANIZATIONS THAT  
8 HAVE A FOCUS ON RACIAL EQUITY, ENVIRONMENTAL JUSTICE,  
9 CONSERVATION AND STEWARDSHIP, YOUTH ACTIVITY AND ENGAGEMENT,  
10 EDUCATION, DISABILITY ADVOCACY AND ACCESSIBILITY, ADVOCACY AND  
11 ACCESSIBILITY FOR INDIVIDUALS WHO ARE LESBIAN, GAY, BISEXUAL,  
12 TRANSGENDER, OR QUEER OR QUESTIONING, ADVOCACY FOR NATIVE  
13 AMERICAN OR INDIGENOUS PEOPLE, AND OTHER RELEVANT AREAS OF  
14 FOCUS, AND THAT:

15 (I) WORK TO ENSURE THAT YOUTH AND THEIR FAMILIES HAVE  
16 ACCESS, REPRESENTATION, MEANINGFUL PARTICIPATION, AND QUALITY  
17 EXPERIENCES IN THE OUTDOORS;

18 (II) PROMOTE CULTURALLY RESPONSIVE PROGRAMS, POLICIES,  
19 PROTOCOLS, AND STAFFING IN THE OUTDOORS; AND

20 (III) RAISE AWARENESS OF AND SEEK TO ADDRESS THE ROOT  
21 CAUSES OF THE ENVIRONMENTAL DISPARITIES FACING UNDERSERVED  
22 COMMUNITIES.

23 (5) TO THE EXTENT POSSIBLE, THE DIRECTOR SHALL ATTEMPT TO  
24 APPOINT VOTING MEMBERS OF THE BOARD:

25 (a) WHO HAVE EXPERIENCE PROVIDING EDUCATIONAL  
26 EXPERIENCES TO UNDERSERVED YOUTH; AND

27 (b) WHO REFLECT THE DIVERSITY OF THE STATE WITH REGARD TO

1 RACE, ETHNICITY, GENDER, IMMIGRATION STATUS, INCOME, WEALTH,  
2 ABILITY, AND GEOGRAPHY.

3 (6) THE DIRECTOR SHALL MAKE INITIAL APPOINTMENTS TO THE  
4 BOARD BY OCTOBER 15, 2021.

5 (7) (a) EXCEPT AS PROVIDED IN SUBSECTIONS (7)(b) AND (7)(c) OF  
6 THIS SECTION, THE TERM OF OFFICE OF THE MEMBERS OF THE BOARD  
7 APPOINTED BY THE DIRECTOR IS FOUR YEARS.

8 (b) IN ORDER TO ENSURE STAGGERED TERMS OF OFFICE, THE  
9 INITIAL TERM OF OFFICE OF THE MEMBERS OF THE BOARD IS:

10 (I) TWO YEARS FOR THE MEMBERS APPOINTED PURSUANT TO  
11 SUBSECTIONS (2)(a), (2)(b), AND (2)(c) OF THIS SECTION; AND

12 (II) FOUR YEARS FOR THE MEMBERS APPOINTED PURSUANT TO  
13 SUBSECTIONS (2)(d), (2)(e), AND (2)(f) OF THIS SECTION.

14 (c) THE TERM OF OFFICE FOR TWO OF THE YOUTH MEMBERS OF THE  
15 BOARD IS TWO YEARS AND THE TERM OF OFFICE FOR ONE OF THE YOUTH  
16 MEMBERS OF THE BOARD IS ONE YEAR, AS ESTABLISHED BY THE DIRECTOR.

17 (d) BOARD MEMBERS MAY SERVE NO MORE THAN TWO TERMS.

18 (e) A MEMBER WHO IS APPOINTED TO FILL A VACANCY SHALL  
19 SERVE THE REMAINDER OF THE UNEXPIRED TERM OF THE MEMBER WHOSE  
20 VACANCY IS BEING FILLED; THE REMAINDER COUNTS AS ONE TERM FOR  
21 THAT APPOINTEE.

22 (8) (a) VOTING MEMBERS OF THE BOARD RECEIVE A PER DIEM OF  
23 TWO HUNDRED DOLLARS FOR ATTENDANCE AT REGULARLY SCHEDULED  
24 MEETINGS OF THE BOARD DURING THE 2021-22 STATE FISCAL YEAR, AND  
25 TWO HUNDRED DOLLARS AS ANNUALLY ADJUSTED FOR INFLATION BASED  
26 ON THE PERCENTAGE CHANGE IN THE UNITED STATES DEPARTMENT OF  
27 LABOR'S BUREAU OF LABOR STATISTICS CONSUMER PRICE INDEX FOR

1 DENVER-AURORA-LAKEWOOD FOR ALL ITEMS PAID BY ALL URBAN  
2 CONSUMERS, OR ITS APPLICABLE PREDECESSOR OR SUCCESSOR INDEX,  
3 DURING THE 2022-23 STATE FISCAL YEAR AND EACH STATE FISCAL YEAR  
4 THEREAFTER. VOTING MEMBERS OF THE BOARD ARE ALSO REIMBURSED  
5 FOR ACTUAL AND NECESSARY EXPENSES INCURRED WHILE PERFORMING  
6 OFFICIAL DUTIES, TOGETHER WITH MILEAGE AT THE RATE AT WHICH

14 **33-9-204. Outdoor equity board - duties.** (1) THE BOARD SHALL

17 (a) TO CREATE AN OUTDOOR EQUITY WEBSITE;

18 (b) TO ADMINISTER THE GRANT PROGRAM AND, SUBJECT TO  
19 AVAILABLE APPROPRIATIONS, AWARD GRANTS AS PROVIDED IN SECTION  
20 33-9-205;

21 (c) TO ESTABLISH ANY POLICIES AS ARE NECESSARY OR EXPEDIENT

9 HIGHLIGHT WHO THEY ARE SERVING AND HOW THEY ARE SERVING THEM,  
10 INCLUDING REPORTS ON THE ETHNIC AND RACIAL MAKEUP OF THE  
11 PARTICIPANTS OF PROGRAMS FUNDED, THE AGES AND LOCALITIES OF  
12 PROGRAM PARTICIPANTS, THE TYPES OF PROGRAMMING FUNDED, AND

23 (II) IN JANUARY 2023, AND EACH JANUARY THEREAFTER, THE

25 SUMMARY OF THE REPORT DESCRIBED IN SUBSECTION (1)(e) OF THIS  
26 SECTION, AS PART OF THE DEPARTMENT'S PRESENTATION TO ITS  
27 COMMITTEE OF REFERENCE AT A HEARING HELD PURSUANT TO SECTION

3 (2) THE BOARD IS SUBJECT TO ALL THE APPLICABLE REQUIREMENTS  
4 OF THE "COLORADO OPEN RECORDS ACT", PART 2 OF ARTICLE 72 OF TITLE  
5 24, AND THE OPEN MEETINGS LAW CONTAINED IN PART 4 OF ARTICLE 6 OF  
6 TITLE 24.

7 **33-9-205. Outdoor equity grant program - creation.** (1) THE  
8 BOARD SHALL IMPLEMENT THE GRANT PROGRAM IN ACCORDANCE WITH  
9 THIS SECTION AND THE POLICIES IT ESTABLISHES UNDER SECTION 33-9-204  
10 (1)(c).

11 (2) TO RECEIVE A GRANT, AN APPLICANT MUST SUBMIT AN  
12 APPLICATION TO THE BOARD.

13 (3) THE BOARD SHALL REVIEW EACH APPLICATION IT RECEIVES  
14 AND MAY AWARD GRANTS TO APPLICANTS THAT WILL DIRECTLY UTILIZE  
15 THE GRANT TO ENGAGE RACIALLY OR ETHNICALLY DIVERSE ELIGIBLE  
16 YOUTH WHO ARE FROM LOW-INCOME FAMILIES, ENGAGE ELIGIBLE YOUTH  
17 WHO ARE LESBIAN, GAY, BISEXUAL, TRANSGENDER, OR QUEER OR  
18 QUESTIONING, ENGAGE NATIVE AMERICAN OR INDIGENOUS YOUTH, OR  
19 ENGAGE ELIGIBLE YOUTH WITH DISABILITIES IN SUCH A WAY SO AS TO  
20 BUILD SUSTAINABILITY AND CAPACITY FOR SUCH HISTORICALLY  
21 UNDERSERVED COMMUNITIES, AND SO AS TO:

22 (a) REDUCE BARRIERS TO THE COLORADO OUTDOORS;

23 (b) CREATE PATHWAYS FOR FORMAL OR INFORMAL CONSERVATION  
24 OF THE COLORADO OUTDOORS; OR

25 (c) OFFER ENVIRONMENTAL AND COLORADO OUTDOOR-BASED  
26 EDUCATIONAL OPPORTUNITIES.

27 (4) SUBJECT TO AVAILABLE APPROPRIATIONS, GRANTS SHALL BE

1 PAID OUT OF THE OUTDOOR EQUITY FUND CREATED IN SECTION 33-9-206.

2 **33-9-206. Outdoor equity fund.** (1) (a) THE OUTDOOR EQUITY  
3 FUND IS HEREBY CREATED IN THE STATE TREASURY. THE FUND CONSISTS  
4 OF MONEY CREDITED TO THE FUND PURSUANT TO SECTION 44-40-111 (12).  
5 ALL INTEREST AND INCOME DERIVED FROM THE DEPOSIT AND INVESTMENT  
6 OF MONEY IN THE OUTDOOR EQUITY FUND MUST BE CREDITED TO THE FUND  
7 AND MAY NOT BE TRANSFERRED TO THE GENERAL FUND OR ANY OTHER

11 (b) THE MONEY CREDITED TO THE OUTDOOR EQUITY FUND  
12 PURSUANT TO SUBSECTION (1)(a) OF THIS SECTION AND ANY INCOME AND  
13 INTEREST DERIVED FROM THE DEPOSIT AND INVESTMENT OF SUCH MONEY  
14 IS EXEMPT FROM ANY RESTRICTION ON SPENDING, REVENUE, OR  
15 APPROPRIATIONS, INCLUDING, WITHOUT LIMITATION, THE RESTRICTIONS OF

17 (2) SUBJECT TO ANNUAL APPROPRIATION BY THE GENERAL

13           **SECTION 5. Appropriation.** For the 2021-22 state fiscal year,  
14 \$730,674 is appropriated to the department of natural resources for use  
15 by the division of parks and wildlife. This appropriation is from the  
16 outdoor equity fund created in section 33-9-206 (1)(a), C.R.S., and is  
17 based on an assumption that the division will require an additional 1.0  
18 FTE. To implement this act, the division may use this appropriation for  
19 the outdoor equity grant program.

20           **SECTION 6. Safety clause.** The general assembly hereby finds,  
21 determines, and declares that this act is necessary for the immediate  
22 preservation of the public peace, health, or safety.
