A BILL FOR AN ACT

101 **CONCERNING THE CREATION OF A SPECIAL OLYMPICS LICENSE PLATE**
102 **FOR MOTOR VEHICLES, AND, IN CONNECTION THEREWITH,**
103 **MAKING AN APPROPRIATION.**

Bill Summary

(Note: This summary applies to this bill as introduced and does not reflect any amendments that may be subsequently adopted. If this bill passes third reading in the house of introduction, a bill summary that applies to the reengrossed version of this bill will be available at <http://leg.colorado.gov>.)

The bill creates the Special Olympics license plate for motor vehicles. A person qualifies for issuance of the plate if the person makes a donation to a designated nonprofit organization. The designated nonprofit organization must:

- Be headquartered in Colorado;

- Have existed for at least 40 years;
- Provide year-round sports training and athletic competitions for children and adults with intellectual disabilities;
- Collaborate with schools throughout Colorado to bring students together through shared activities that include sports, leadership opportunities, and health education and fitness; and
- Ensure that the donation is spent in Colorado to support athletes with intellectual disabilities.

In addition to the normal fees for a license plate, a person must pay 2 additional one-time fees for the issuance of the plate. One of these fees is credited to the highway users tax fund and the other fee is credited to the licensing services cash fund.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, **add** 42-3-255 as
3 follows:

4 **42-3-255. Special plates - Special Olympics Colorado - short**
5 **title - definition.** (1) THE SHORT TITLE OF THIS SECTION IS THE "TERI
6 LEIKER ACT".

7 (2) BEGINNING ON OR BEFORE JANUARY 1, 2022, THE DEPARTMENT
8 SHALL ISSUE SPECIAL LICENSE PLATES TO QUALIFIED APPLICANTS IN
9 ACCORDANCE WITH THIS SECTION FOR MOTORCYCLES, PASSENGER CARS,
10 TRUCKS, OR NONCOMMERCIAL OR RECREATIONAL MOTOR VEHICLES THAT
11 DO NOT EXCEED SIXTEEN THOUSAND POUNDS EMPTY WEIGHT.

12 (3) (a) THERE IS HEREBY ESTABLISHED THE SPECIAL OLYMPICS
13 COLORADO LICENSE PLATE.

14 (b) THE DEPARTMENT SHALL SELECT A DESIGN FOR THE SPECIAL
15 OLYMPICS COLORADO LICENSE PLATE FROM A DESIGNATED
16 ORGANIZATION THAT MEETS THE STANDARDS IN SUBSECTION (4)(a) OF
17 THIS SECTION, BUT THE DESIGN MUST CONFORM TO DEPARTMENT

1 STANDARDS AND BE APPROVED BY THE DEPARTMENT.

2 (4) (a) AT LEAST ONCE EVERY FIVE YEARS, THE DEPARTMENT
3 SHALL DESIGNATE AN ORGANIZATION THAT MAY QUALIFY APPLICANTS TO
4 BE ISSUED THE SPECIAL OLYMPICS COLORADO LICENSE PLATE. THE
5 ORGANIZATION MUST:

6 (I) BE HEADQUARTERED IN COLORADO;

7 (II) HAVE BEEN IN EXISTENCE FOR AT LEAST FORTY YEARS;

8 (III) PROVIDE YEAR-ROUND SPORTS TRAINING AND ATHLETIC
9 COMPETITIONS FOR CHILDREN AND ADULTS WITH INTELLECTUAL
10 DISABILITIES;

11 (IV) COLLABORATE WITH SCHOOLS THROUGHOUT COLORADO TO
12 BRING STUDENTS TOGETHER, WITH AND WITHOUT DISABILITIES, THROUGH
13 SHARED ACTIVITIES THAT INCLUDE SPORTS, LEADERSHIP OPPORTUNITIES,
14 AND HEALTH EDUCATION AND FITNESS; AND

15 (V) FILE WITH THE DEPARTMENT AN ANNUAL STATEMENT
16 VERIFYING THAT IT IS A NONPROFIT ORGANIZATION.

17 (b) A PERSON MAY APPLY FOR A SPECIAL OLYMPICS COLORADO
18 LICENSE PLATE IF THE PERSON PAYS THE TAXES AND FEES REQUIRED
19 UNDER THIS SECTION AND PROVIDES TO THE DEPARTMENT A CERTIFICATE
20 ISSUED BY A DESIGNATED ORGANIZATION CONFIRMING THAT THE PERSON
21 HAS MADE A DONATION TO THE ORGANIZATION. THE DESIGNATED
22 ORGANIZATION MAY ESTABLISH A MINIMUM DONATION AMOUNT OF NO
23 LESS THAN SIXTY DOLLARS AND NO MORE THAN ONE HUNDRED DOLLARS
24 TO QUALIFY FOR THE SPECIAL LICENSE PLATE. A DESIGNATED
25 ORGANIZATION SHALL ONLY SPEND THE DONATIONS IN COLORADO TO
26 SUPPORT ATHLETES WITH INTELLECTUAL DISABILITIES.

27 (5) THE AMOUNT OF THE TAXES AND FEES FOR SPECIAL LICENSE

1 PLATES UNDER THIS SECTION IS THE SAME AS THE AMOUNT OF THE TAXES
2 AND FEES FOR REGULAR MOTOR VEHICLE LICENSE PLATES; EXCEPT THAT
3 THE DEPARTMENT SHALL COLLECT AN ADDITIONAL ONE-TIME FEE OF
4 TWENTY-FIVE DOLLARS FOR ISSUANCE OR REPLACEMENT OF THE SPECIAL
5 LICENSE PLATE. THE DEPARTMENT SHALL TRANSMIT THE ADDITIONAL
6 ONE-TIME FEE TO THE STATE TREASURER, WHO SHALL CREDIT THE FEE TO
7 THE HIGHWAY USERS TAX FUND CREATED IN SECTION 43-4-201.

8 (6) A QUALIFIED APPLICANT MAY APPLY TO THE DEPARTMENT FOR
9 PERSONALIZED SPECIAL OLYMPICS COLORADO LICENSE PLATES. UPON
10 PAYMENT OF THE ADDITIONAL FEE REQUIRED BY SECTION 42-3-211 (6)(a)
11 FOR PERSONALIZED LICENSE PLATES, THE DEPARTMENT MAY ISSUE THE
12 PLATES IF THE QUALIFIED APPLICANT COMPLIES WITH SECTION 42-3-211.
13 IF A QUALIFIED APPLICANT HAS EXISTING PERSONALIZED LICENSE PLATES
14 FOR A MOTOR VEHICLE, THE APPLICANT MAY TRANSFER THE COMBINATION
15 OF LETTERS OR NUMBERS TO A NEW SET OF SPECIAL OLYMPICS COLORADO
16 LICENSE PLATES FOR THE VEHICLE UPON PAYING THE FEE REQUIRED BY
17 SECTION 42-3-211 (6)(a) AND UPON TURNING IN THE EXISTING PLATES TO
18 THE DEPARTMENT. A PERSON WHO HAS OBTAINED PERSONALIZED LICENSE
19 PLATES UNDER THIS SUBSECTION (6) MUST PAY THE ANNUAL FEE IMPOSED
20 BY SECTION 42-3-211 (6)(b) FOR RENEWAL OF THE PERSONALIZED PLATES.
21 THE FEES UNDER THIS SUBSECTION (6) ARE IN ADDITION TO ALL OTHER
22 APPLICABLE TAXES AND FEES.

23 (7) AS USED IN THIS SECTION, "DESIGNATED ORGANIZATION"
24 MEANS AN ORGANIZATION DESIGNATED BY THE DEPARTMENT THAT MEETS
25 THE CRITERIA SET FORTH IN SUBSECTION (4)(a) OF THIS SECTION.

26 **SECTION 2.** In Colorado Revised Statutes, **amend** 42-3-312 as
27 follows:

1 **42-3-312. Special license plate surcharge.** In addition to any
2 other fee imposed by this article 3, an applicant for a special license plate
3 created by rule in accordance with section 42-3-207, as the section existed
4 when the plate was created, or SPECIAL license plates issued pursuant to
5 sections 42-3-211 to 42-3-214, sections 42-3-217 to 42-3-218, sections
6 42-3-221 to 42-3-234, and sections 42-3-237 to ~~42-3-254~~ TO 42-3-255
7 shall pay an issuance fee of twenty-five dollars; except that the fee is not
8 imposed on special license plates exempted from additional fees for the
9 issuance of a military special license plate by section 42-3-213 (1)(b)(II).
10 The department shall transfer the fee to the state treasurer, who shall
11 credit it to the licensing services cash fund created in section 42-2-114.5.

12 **SECTION 3. Appropriation.** (1) For the 2021-22 state fiscal
13 year, \$13,460 is appropriated to the department of revenue for use by the
14 division of motor vehicles. This appropriation consists of \$5,400 from the
15 Colorado DRIVES vehicle services account in the highway users tax fund
16 created in section 42-1-211 (2)(b)(I), C.R.S., and \$8,060 from the license
17 plate cash fund created in section 42-3-301 (1)(b), C.R.S. To implement
18 this act, the division may use this appropriation as follows:

19 (a) \$5,400 from the Colorado DRIVES vehicle services account
20 in the highway users tax fund for DRIVES maintenance and support; and

21 (b) \$8,060 from the license plate cash fund for license plate
22 ordering.

23 **SECTION 4. Act subject to petition - effective date.** This act
24 takes effect at 12:01 a.m. on the day following the expiration of the
25 ninety-day period after final adjournment of the general assembly; except
26 that, if a referendum petition is filed pursuant to section 1 (3) of article V
27 of the state constitution against this act or an item, section, or part of this

1 act within such period, then the act, item, section, or part will not take
2 effect unless approved by the people at the general election to be held in
3 November 2022 and, in such case, will take effect on the date of the
4 official declaration of the vote thereon by the governor.
