**A BILL FOR AN ACT**

101 **CONCERNING THE EFFECTIVE DATE OF SENATE BILL 20-123.**

**Bill Summary**

*(Note: This summary applies to this bill as introduced and does not reflect any amendments that may be subsequently adopted. During the 2020 regular legislative session, the general assembly enacted Senate Bill 20-123 concerning the rights of college athletes, and in connection therewith, establishing their right to receive compensation for the use of their names, images, and likenesses and their right to obtain professional and legal representation. The governor subsequently signed Senate Bill 20-123 into law.

Senate Bill 20-123 was enacted with an effective date of January 1, 2023. The bill changes this effective date to July 1, 2021.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2           **SECTION 1.** In Session Laws of Colorado 2020, **amend** section  
3 4 of chapter 35 as follows:

4           Section 4. **Act subject to petition - effective date.** This act takes  
5 effect ~~January 1, 2023~~ JULY 1, 2021; except that, if a referendum petition  
6 is filed pursuant to section 1 (3) of article V of the state constitution  
7 against this act or an item, section, or part of this act within the ninety-day  
8 period after final adjournment of the general assembly, then the act, item,  
9 section, or part will not take effect unless approved by the people at the  
10 general election to be held in November 2020 and, in such case, will take  
11 effect ~~January 1, 2023~~ JULY 1, 2021.

12           **SECTION 2. Safety clause.** The general assembly hereby finds,  
13 determines, and declares that this act is necessary for the immediate  
14 preservation of the public peace, health, or safety.
