**Bill Summary**

**Statutory Revision Committee.** The bill eliminates the advisory committee that advised the state department of human services on the licensing of child care facilities prior to the creation of the early childhood leadership commission.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, 26-6-109, **repeal** (1)  
3 as follows:

4 **26-6-109. Institutes.** (1) ~~(a) There is hereby created an advisory~~  
5 ~~committee on licensing of child care facilities to advise and consult with~~  
6 ~~the department in the administration and enforcement of this part 1. The~~  
7 ~~committee shall consist of fifteen members to be appointed by the~~  
8 ~~governor for terms of three years; except that, of the members first~~  
9 ~~appointed, four shall be appointed for three years, four for two years, and~~  
10 ~~three for one year. Thereafter, members shall be appointed for terms of~~  
11 ~~three years except in the case of a vacancy that shall be filled for the~~  
12 ~~remainder of the unexpired term. A member may be appointed to succeed~~  
13 ~~himself or herself and may continue to serve on the committee beyond the~~  
14 ~~end of his or her term until the governor appoints a successor. Members~~  
15 ~~who have been appointed to fill the remainder of an unexpired term may~~  
16 ~~be appointed to fill the succeeding full term.~~

17 ~~(b) The members of the advisory committee shall serve without~~  
18 ~~compensation but shall be entitled to their reasonable traveling expenses~~  
19 ~~incurred in the performance of their duties, which shall be paid as a part~~  
20 ~~of the expenses of administering this part 1.~~

21 ~~(c) The committee shall consist of nine members who shall~~  
22 ~~represent the various types of facilities licensed under the provisions of~~  
23 ~~this part 1, four members representing various state and local~~  
24 ~~governmental agencies with an interest in and concern for children, and~~  
25 ~~two members at large who are parents, each having at least one child~~  
26 ~~attending a facility licensed or certified under this part 1 at the time of~~  
27 ~~such members' appointment.~~

1           ~~(d) A majority of the members of the committee shall constitute~~  
2 ~~a quorum, the presence of which at any meeting thereof duly called by the~~  
3 ~~department shall have full and complete power to act upon and resolve in~~  
4 ~~the name of the committee any matter or question referred to it by the~~  
5 ~~department. The committee, as soon after appointment as practicable,~~  
6 ~~shall elect from among its members a chairman, a vice-chairman, and a~~  
7 ~~secretary who shall hold office until their successors are elected. The~~  
8 ~~chairman shall preside at all meetings of the committee, and the secretary~~  
9 ~~shall make a record of the proceedings thereof that shall be preserved in~~  
10 ~~the office of the department. All members of the committee shall be~~  
11 ~~entitled to vote on any matter or question that properly comes before it.~~

12           ~~(e) Repealed.~~

13           **SECTION 2.** In Colorado Revised Statutes, 26-6-113, **amend** (2)  
14 as follows:

15           **26-6-113. Periodic review of licensing regulations and**  
16 **procedures.** (2) Beginning with fiscal year 1995-1996, an initial  
17 comprehensive rule and regulation review shall be conducted in  
18 conjunction with the performance audit required by section 26-6-107  
19 (1.5), and, at least every fifth fiscal year thereafter, a comprehensive  
20 review of the licensing rules and regulations for child care centers, family  
21 child care homes, and foster care homes and the procedures relating to  
22 and governing child care centers, family child care homes, and foster care  
23 homes shall be conducted by the department, including procedures for the  
24 review of backgrounds of employees and owners. In conducting such  
25 periodic review, the department shall consult with parents and consumers  
26 of child care, child care providers, the department of public health and  
27 environment, experts in the child care field, and other interested parties

1 throughout the state. The periodic review shall include an examination of  
2 the rules and regulations applicable to child care centers, family child care  
3 homes, and foster care homes, the process of licensing such facilities,  
4 uniformity of standards or lack thereof in the licensing process, statewide  
5 standardization of investigations and enforcement of licensing by the  
6 department, duplication and conflicts in regulations, requirements, or  
7 procedures between the department and the department of public health  
8 and environment, and recommendations for streamlining and unifying the  
9 licensing process. Said review shall also include an examination of  
10 regulations and procedures regarding the general physical and mental  
11 health of employees and owners. At the conclusion of each review, the  
12 department shall report its findings and conclusions and its  
13 recommendations for administrative changes and for legislation to the  
14 state board ~~the advisory committee on licensing of child care facilities,~~  
15 and the executive director of the department of public health and  
16 environment.

17 **SECTION 3. Act subject to petition - effective date.** This act  
18 takes effect at 12:01 a.m. on the day following the expiration of the  
19 ninety-day period after final adjournment of the general assembly; except  
20 that, if a referendum petition is filed pursuant to section 1 (3) of article V  
21 of the state constitution against this act or an item, section, or part of this  
22 act within such period, then the act, item, section, or part will not take  
23 effect unless approved by the people at the general election to be held in  
24 November 2022 and, in such case, will take effect on the date of the  
25 official declaration of the vote thereon by the governor.
