The bill funds water projects in the Department of Natural Resources. It increases state expenditures beginning in the current FY 2021-22, and transfers funds from FY 2020-21 through FY 2029-30.

Appropriation Summary: In the Department of Natural Resources the bill establishes an annual continuous appropriation of \$150,000 beginning in the current FY 2020-21, and appropriates an additional \$4.25 million for FY 2021-22.

Fiscal Note Status: The revised fiscal note reflects the reengrossed bill.

Summary of Legislation

The bill appropriates funds from the Colorado Water Conservation Board (CWCB) Construction Fund in the Department of Natural Resources (DNR) to the CWCB and the Division of Water Resources for specified water-related projects. For FY 2021-22, the bill transfers up to \$2.0 million from the CWCB Construction Fund to the Litigation Fund. In addition, the bill reinstates annual transfers of up to \$550,000 from the Severance Tax Operational Fund to the Water Efficiency Grant Program Cash Fund, which were repealed July 1, 2020. Lastly, the bill reinstates \$150,000 in annual funding from the CWCB Construction Fund for the Water Education Foundation, known as Water Education Colorado.

State Revenue

Revenue will be generated from the interest on water project loans authorized by the bill. This amount will depend on the terms of the loans and cannot be determined at this time.

State Transfers

This bill authorizes transfers of up to \$550,000 in the current FY 2020-21, up to \$2,550,000 in FY 2021-22, and up to \$550,000 per year from FY 2022-23 through FY 2029-30. As explained below, these transfers are expected to be less than these amounts in the near term.

The transfer from the CWCB Construction Fund to the Litigation Fund is to address legal issues associated with compact compliance or related issues. The amount transferred will be the amount necessary to bring the fund's balance to \$2.0 million on July 1, 2021.

For FY 2020-21, the bill transfers \$219,803 from the Severance Tax Operational Fund to the Water Efficiency Grant Program Cash Fund to support water conservation plans and promote water efficiency. This amount reflects that all transfers to all *natural resources and energy grant programs* are proportionally reduced by about 60 percent relative to their fully authorized amounts this year due to insufficient funds in the Severance Tax Operational Fund. The annual transfer is authorized from FY 2020-21 through FY 2029-30, when the program repeals. Due to a forecasted shortfall in severance tax revenue, future transfers are not expected to take place until at least FY 2024-25.

State Expenditures

The bill increases state expenditures in the Department of Natural Resources by an estimated \$4.4 million in FY 2021-22, and up to \$150,000 in subsequent years.

Water Education Foundation. Beginning in the current FY 2020-21, the bill reinstates an annual continuous appropriation of \$150,000 from the CWCB Construction Fund to the CWCB for the Water Education Foundation. Transfers to the foundation within this appropriation are made at the discretion of the CWCB. The fiscal note assumes no money will be provided to the foundation in the current FY 2020-21 due to timing constraints, \$150,000 will be provided in FY 2021-22, and up to \$150,000 in subsequent years.

Projects. For FY 2021-22, the bill appropriates \$4.25 million to the Department of Natural Resources for water-related projects paid from the CWCB Construction Fund. The funds are available for the designated purposes until fully expended. These projects are shown in Table 2.

Local Government

Some of the funding authorized in this bill will benefit local governments or local water providers.

Effective Date

The bill takes effect upon signature of the Governor, or upon becoming law without his signature.

State Appropriations

Beginning in the current FY 2020-21, the bill establishes an annual continuous appropriation of \$150,000 to the Department of Natural Resources from the CWCB Construction Fund.

For FY 2021-22, the bill appropriates an additional \$4.25 million to the Department of Natural Resources from the CWCB Construction Fund.
