**Bill Summary**

**Wildfire Matters Review Committee.** The bill allows fire departments, including fire protection districts and volunteer fire departments, to be compensated from state funding sources for wildland

fire suppression activities conducted in the fire department's jurisdiction if the fire department relies primarily or solely on volunteer firefighters, the fire exceeds the department's capacity to extinguish or control, and the period of mutual aid has ended. The fire department must use money received to compensate volunteer firefighters in accordance with guidelines adopted by the division of fire prevention and control (division) in the annual wildfire preparedness plan. Boards of county commissioners are authorized to reimburse fire departments from county funds for wildland fire suppression activities conducted within the fire department's jurisdiction in the same circumstances.

The bill amends the existing local firefighter safety and disease prevention fund grant program (program) to allow grants to be spent to provide access to mental health services for seasonal and volunteer firefighters involved in wildland fire suppression in addition to purchasing equipment and providing training. The bill requires the program to give priority in awarding grants to governing bodies and volunteer fire departments that:

- Have lost tax revenues as a result of decreased assessment values due to a wildland fire within their jurisdiction in the previous 5 years;
- Rely solely or primarily on volunteer firefighters and serve communities affected by wildland fires; or
- Demonstrate the greatest need for additional funding to ensure the safety of volunteer and seasonal firefighters.

The general assembly is required to annually appropriate \$5 million to the program and may appropriate additional money as necessary to meet the needs of governing bodies and volunteer fire departments. On or before September 1, 2032, the staff of the joint budget committee is required to report on whether the amount of the annual appropriation should be adjusted based on current needs.

In addition, the division may use money in the firefighter safety and disease prevention fund to reimburse mental and behavioral health-care specialists for services provided to firefighters who have served as volunteer or seasonal wildland firefighters, in accordance with rules adopted by the division.

2 **24-33.5-1226. Wildfire emergency response fund - creation -**  
3 **gifts, grants, and donations authorized - rules.** (2.5) In addition to any  
4 other purpose for the use of money in the wildfire emergency  
5 ~~preparedness~~ RESPONSE fund specified in this section, the division may  
6 use money in the fund to provide wildfire suppression assistance to  
7 county sheriffs, municipal fire departments, or fire protection districts  
8 throughout the state at no cost to such entities pursuant to annual  
9 guidelines published by the division in the wildfire preparedness plan  
10 required by section 24-33.5-1227 (2)(a).

11 **SECTION 3.** In Colorado Revised Statutes, 24-33.5-1231,  
12 **amend** (1), (2), (3)     , (3)(a), (3)(b), and (4); and **add** (3.5) and (5) as  
13 follows:

14 **24-33.5-1231. Local firefighter safety and disease prevention**  
15 **fund - creation - grants - rules - report.** (1) There is hereby created in  
16 the state treasury the local firefighter safety and disease prevention fund.  
17 The fund consists of all ~~moneys~~ MONEY that may be appropriated OR  
18 TRANSFERRED to the fund by the general assembly and all private and  
19 public ~~moneys~~ MONEY received through gifts, grants, or donations that ~~are~~  
20 IS transmitted to the state treasurer and credited to the fund. The state  
21 treasurer shall credit all interest earned from the investment of ~~moneys~~

10 PART 5 OF ARTICLE 5 OF TITLE 29. IN FISCAL YEAR 2022-23, THE TOTAL  
11 REIMBURSEMENT PURSUANT TO THIS SUBSECTION (2)(a)(II) MUST NOT  
12 EXCEED ONE MILLION DOLLARS. IN SUBSEQUENT FISCAL YEARS, THE FIRE  
13 SERVICE TRAINING, CERTIFICATION, AND FIREFIGHTER SAFETY ADVISORY  
14 BOARD, CREATED IN SECTION 24-33.5-1204 (1) SHALL MAKE A

21 that the need-based grants from the fund are in addition to, and do not  
22 supplant, other sources of funding regarding firefighting.

23 (3) The director shall promulgate rules governing the award of

25 of:

26 (a) The recommendations of the fire service training, certification,  
27 and firefighter safety advisory board, created in section 24-33.5-1204 (1),

4 (b) How to structure the grant application process, which must  
5 include a merit-based, peer-review process with grant reviewers from the  
6 Colorado state fire chiefs, Colorado professional fire fighters association,  
7 ~~and~~ the Colorado state fire fighters association, AND INDIVIDUALS WITH  
8 EXPERIENCE AS VOLUNTEER FIREFIGHTERS in equal representation. The  
9 peer reviewers shall make recommendations to the director on the award  
10 of grants under the program.

11 NOTWITHSTANDING THE REQUIREMENT IN SECTION 24-1-136 (11)(a)(I),  
12 THE REQUIREMENT TO SUBMIT THE REPORT REQUIRED IN THIS SUBSECTION  
13 (5) CONTINUES INDEFINITELY.

18 BENEFITS PROGRAM

19 **29-5-501. Definitions.** AS USED IN THIS PART 5, UNLESS THE  
20 CONTEXT OTHERWISE REQUIRES:

21 (1) "EMPLOYER" MEANS A MUNICIPALITY, SPECIAL DISTRICT, FIRE  
22 AUTHORITY, OR COUNTY IMPROVEMENT DISTRICT THAT EMPLOYS ONE OR  
23 MORE FIREFIGHTERS. "EMPLOYER" ALSO MEANS THE DIVISION OF FIRE  
24 PREVENTION AND CONTROL CREATED IN SECTION 24-33.5-1201.  
25 "EMPLOYER" DOES NOT INCLUDE A POWER AUTHORITY CREATED  
26 PURSUANT TO SECTION 29-1-204 OR A MUNICIPALLY OWNED UTILITY.

27 (2) "FIREFIGHTER" MEANS A FULL- OR PART-TIME EMPLOYEE OF AN



1 EMPLOYER WHOSE DUTIES ARE DIRECTLY INVOLVED WITH THE PROVISION  
2 OF FIRE PROTECTION SERVICES AND A VOLUNTEER FIREFIGHTER AS  
3 DEFINED IN SECTION 31-30-1102. "FIREFIGHTER" INCLUDES A PERSON  
4 MEETING THIS DEFINITION WHO PROVIDES VOLUNTEER SERVICES TO A FIRE  
5 AUTHORITY CREATED BY AN INTERGOVERNMENTAL AGREEMENT  
6 PROVIDING FIRE PROTECTION.

7 (3) "TRUST" MEANS A MULTIPLE EMPLOYER BEHAVIORAL HEALTH  
8 TRUST DESCRIBED IN SECTION 10-3-903.5 (7)(e), ESTABLISHED FOR THE  
9 PURPOSES OF THIS PART 5.

10 **29-5-502. Required program - reimbursement.** (1) AN  
11 EMPLOYER SHALL PARTICIPATE IN A MULTIPLE EMPLOYER BEHAVIORAL  
12 HEALTH TRUST IN ORDER TO PROVIDE THE PROGRAM SPECIFIED IN THIS  
13 SECTION FOR ITS FIREFIGHTERS. IF AT ANY TIME THE FUNDING PROVIDED  
14 PURSUANT TO SUBSECTION (3) OF THIS SECTION IS INSUFFICIENT TO COVER  
15 THE COST OF THE PROGRAM REQUIRED BY THIS SECTION, THEN THE  
16 REQUIREMENT TO PARTICIPATE IN THE PROGRAM BECOMES OPTIONAL  
17 PURSUANT TO SECTION 29-1-304.5.

18 (2) A TRUST SHALL PROVIDE A PROGRAM PLANNED, ORGANIZED,  
19 OPERATED, AND MAINTAINED TO PROVIDE BASIC SERVICES TO  
20 FIREFIGHTERS FOR THE PREVENTION, DIAGNOSIS, AND INITIAL TREATMENT  
21 OF EMOTIONAL, BEHAVIORAL, OR MENTAL HEALTH DISORDERS. SERVICES  
22 PROVIDED UNDER THE PROGRAM SHALL BE RENDERED PRIMARILY ON AN  
23 OUTPATIENT AND CONSULTATIVE BASIS, INCLUDING SERVICES DELIVERED  
24 TELEPHONICALLY OR REMOTELY.

25 (3) SUBJECT TO AVAILABLE APPROPRIATIONS AND THE

27 **TO MEET THE BEHAVIORAL HEALTH CARE NEEDS OF FIREFIGHTERS; AND**

2           MEET THE BEHAVIORAL HEALTH CARE NEEDS OF FIREFIGHTERS ACROSS

4           **SECTION 5.** In Colorado Revised Statutes, 29-22.5-103, **amend**  
5           (1)(d) as follows:

6           **29-22.5-103. Wildland fires - general authority and**  
7           **responsibilities.** (1) (d) The fire chief shall not seek reimbursement from  
8           the county for expenses incurred by the district for their own apparatus,  
9           equipment, and personnel used in containing or suppressing a wildfire  
10          occurring on private property within the boundaries of the district,  
11          EXCEPT AS PROVIDED IN SECTION 30-10-513 (3)(b).

12          **SECTION 6.** In Colorado Revised Statutes, 30-10-513, **amend**  
13          (3) as follows:

14          **30-10-513. Duties of sheriff - coordination of fire suppression**  
15          **efforts for forest, prairie, or wildland fire - expenses.** (3) (a) The  
16          board of county commissioners of any county may allow the sheriff,  
17          undersheriffs, deputies, municipal or county fire departments, fire  
18          protection districts, fire authorities, and such other persons as may be  
19          called upon to assist in controlling or extinguishing a prairie, forest, or  
20          wildland fire such compensation and reimbursement for other expenses  
21          necessarily incurred as the board deems just.

22          (b) THE BOARD OF COUNTY COMMISSIONERS OF ANY COUNTY MAY  
23          ALLOW A FIRE DEPARTMENT, FIRE PROTECTION DISTRICT, OR VOLUNTEER  
24          FIRE DEPARTMENT COMPENSATION AND REIMBURSEMENT FROM A COUNTY  
25          FUNDING SOURCE FOR OTHER EXPENSES NECESSARILY INCURRED IN  
26          CONTROLLING OR EXTINGUISHING A PRAIRIE, FOREST, OR WILDLAND FIRE  
27          WITHIN THE JURISDICTION OR BOUNDARIES OF THE FIRE DEPARTMENT, FIRE

1 PROTECTION DISTRICT, OR VOLUNTEER FIRE DEPARTMENT IF THE  
2 CIRCUMSTANCES SET FORTH IN SECTION 24-33.5-1220 (6)(a)(I), (6)(a)(II),  
3 AND (6)(a)(III) ARE MET, AS THE BOARD DEEMS JUST.

4 **SECTION 7.** In Colorado Revised Statutes, 30-10-513.5, **add**  
5 (1)(c) as follows:

6 **30-10-513.5. Authority of sheriff relating to fires within**  
7 **unincorporated areas of county - liability for expenses.** (1) (c) THIS  
8 SECTION DOES NOT PROHIBIT A COUNTY FROM REIMBURSING A FIRE  
9 PROTECTION DISTRICT, FIRE DEPARTMENT, OR VOLUNTEER FIRE  
10 DEPARTMENT FOR EXPENSES NECESSARILY INCURRED IN CONTROLLING OR  
11 EXTINGUISHING A PRAIRIE, FOREST, OR WILDLAND FIRE FROM A COUNTY  
12 FUNDING SOURCE IN ACCORDANCE WITH SECTION 30-10-513 (3)(b).

13 **SECTION 8.** In Colorado Revised Statutes, 10-3-903.5, **amend**  
14 **(7)(a); and add (7)(e) as follows:**

15 **10-3-903.5. Jurisdiction over providers of health-care benefits**  
16 **- rules.** (7) (a) The provisions of this section and any other laws of this  
17 state that regulate insurance or insurance companies shall not apply to any  
18 multiple employer health trust which THAT meets the requirements of  
19 paragraph (b) of this subsection (7) or SUBSECTION (7)(b) OF THIS  
20 SECTION, any multiple employer welfare arrangement which THAT meets  
21 the requirements of paragraph (c) of this subsection (7) SUBSECTION  
22 (7)(c) OF THIS SECTION, OR ANY MULTIPLE EMPLOYER BEHAVIORAL  
23 HEALTH TRUST THAT MEETS THE REQUIREMENTS OF SUBSECTION (7)(e) OF  
24 THIS SECTION. Any such trust or arrangement shall be subject to the  
25 requirements of this subsection (7) and section 10-3-1104. The exemption  
26 provided by this subsection (7) shall not apply to any entity if the division  
27 of insurance determines that its operation is hazardous to the public or to

1 individuals receiving benefits.

2 (e) A MULTIPLE EMPLOYER BEHAVIORAL HEALTH TRUST IS ANY  
3 TRUST THAT IS SPONSORED AND MAINTAINED BY ONE OR MORE ENTITIES  
4 OF STATE GOVERNMENT OR POLITICAL SUBDIVISIONS OF THE STATE,  
5 ORGANIZED PURSUANT TO STATE LAW, AND FUNDED BY THE STATE FOR  
6 THE BENEFIT OF THE ENTITIES' EMPLOYEES, INCLUDING A MULTIPLE  
7 EMPLOYER BEHAVIORAL HEALTH TRUST ESTABLISHED FOR THE PURPOSES  
8 OF PART 5 OF ARTICLE 5 OF TITLE 29.

9 **SECTION 9. Appropriation.** (1) For the 2022-23 state fiscal  
10 year, \$1,000,000 is appropriated to the local firefighter safety and disease  
11 prevention fund created in section 24-33.5-1231 (1), C.R.S. This  
12 appropriation is from the General Fund. The department of public safety  
13 is responsible for the accounting related to this appropriation.

14 **SECTION 10. Safety clause.** The general assembly hereby finds,  
15 determines, and declares that this act is necessary for the immediate  
16 preservation of the public peace, health, or safety.
