**A BILL FOR AN ACT**

101 **CONCERNING CERTAIN TRAFFIC VIOLATIONS ON THE INTERSTATE 70**  
102 **PEAK PERIOD SHOULDER LANES.**

**Bill Summary**

*(Note: This summary applies to this bill as introduced and does not reflect any amendments that may be subsequently adopted. The bill prohibits the drivers of motor vehicles from driving on the interstate 70 peak period shoulder lanes (PPSL) while the lanes are closed and prohibits the drivers of motor vehicles with more than 2 axles or that are 25 feet long or longer from driving on the PPSL at any time. The high-performance transportation enterprise is authorized to assess civil penalties and enforce violations.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2           **SECTION 1.** In Colorado Revised Statutes, 43-4-806, **add** (11)  
3 as follows:

4           **43-4-806. High-performance transportation enterprise -**  
5 **creation - board - funds - powers and duties - limitations - reporting**  
6 **requirements - violations on the peak period shoulder lanes -**  
7 **legislative declaration - definitions.** (11) (a) AS USED IN THIS  
8 SUBSECTION (11), UNLESS THE CONTEXT OTHERWISE REQUIRES, "PEAK  
9 PERIOD SHOULDER LANE" MEANS:

10           (I) THE EASTBOUND MANAGED TOLL LANE ON INTERSTATE 70  
11 BETWEEN MILE MARKER 230 (EMPIRE JUNCTION) AND THE VETERANS  
12 MEMORIAL TUNNEL; OR

13           (II) THE WESTBOUND MANAGED TOLL LANE ON INTERSTATE 70  
14 BETWEEN THE VETERANS MEMORIAL TUNNEL AND MILE MARKER 230  
15 (EMPIRE JUNCTION).

16           (b) (I) UNLESS A PERSON IS OPERATING AN AUTHORIZED  
17 EMERGENCY VEHICLE, AS DEFINED IN SECTION 42-1-102 (6), OR AN  
18 AUTHORIZED SERVICE VEHICLE, AS DEFINED IN SECTION 42-1-102 (7), OR  
19 USING A LANE IN THE CASE OF AN EMERGENCY, A PERSON SHALL NOT  
20 DRIVE ON THE PEAK PERIOD SHOULDER LANE WHEN THE POSTED SIGNAGE  
21 INDICATES THAT THE PEAK PERIOD SHOULDER LANE IS CLOSED.

22           (II) A PERSON SHALL NOT DRIVE ON A PEAK PERIOD SHOULDER  
23 LANE AT ANY TIME IF THE PERSON IS DRIVING A MOTOR VEHICLE WITH  
24 MORE THAN TWO AXLES OR THAT IS TWENTY-FIVE FEET IN LENGTH OR  
25 LONGER.

26           (c) THE TRANSPORTATION ENTERPRISE SHALL ENFORCE

1 VIOLATIONS OF SUBSECTION (11)(b) OF THIS SECTION AND ASSESS AND  
2 REMIT CIVIL PENALTIES FOR THE VIOLATIONS IN ACCORDANCE WITH  
3 SECTION 43-4-808 (2).

4 **SECTION 2. Effective date - applicability.** This act takes effect  
5 August 1, 2022, and applies to violations committed on or after said date.

6 **SECTION 3. Safety clause.** The general assembly hereby finds,  
7 determines, and declares that this act is necessary for the immediate  
8 preservation of the public peace, health, or safety.
