1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, 24-72.4-103, **amend**
3 (1) introductory portion, (1)(j), and (1)(k); and **add** (1)(l) as follows:

4 **24-72.4-103. Web-based system - enhancements - procedure**
5 **for challenging exclusions.** (1) The ~~chief information officer~~
6 DEPARTMENT OF PERSONNEL shall modify the web-based system to meet
7 the following requirements:

8 (j) The web-based system shall include a link to the online
9 database; ~~and~~

10 (k) The web-based system shall include county expenditure and
11 revenue data in accordance with section 24-72.4-106; AND

12 (l) THE WEB-BASED SYSTEM MUST INCLUDE, FOR ANY
13 EXPENDITURE MADE TO PAY A VENDOR, THE LEGAL NAME OF THE VENDOR
14 PAID; EXCEPT THAT THE WEB-BASED SYSTEM IS NOT REQUIRED TO INCLUDE
15 THE LEGAL NAME OF THE VENDOR IF THE STATE AGENCY HAS DETERMINED
16 THAT THE PUBLIC INTEREST IS BEST SERVED BY EXCLUDING THE LEGAL
17 NAME OF THE VENDOR OR THAT INCLUDING THE LEGAL NAME OF THE
18 VENDOR IS OTHERWISE PROHIBITED BY LAW. WHEN INCLUDED IN THE
19 WEB-BASED SYSTEM, THE LEGAL NAME OF THE VENDOR MUST BE
20 INCLUDED WITHOUT REDACTION.

21 **SECTION 2. Act subject to petition - effective date.** This act
22 takes effect at 12:01 a.m. on the day following the expiration of the
23 ninety-day period after final adjournment of the general assembly; except

1 that, if a referendum petition is filed pursuant to section 1 (3) of article V
2 of the state constitution against this act or an item, section, or part of this
3 act within such period, then the act, item, section, or part will not take
4 effect unless approved by the people at the general election to be held in
5 November 2022 and, in such case, will take effect on the date of the
6 official declaration of the vote thereon by the governor.
