A BILL FOR AN ACT

101 **CONCERNING MODIFICATIONS TO CIVIL INVOLUNTARY COMMITMENT**
102 **STATUTES FOR PERSONS WITH MENTAL HEALTH DISORDERS,**
103 **AND, IN CONNECTION THEREWITH, MAKING AN APPROPRIATION.**

Bill Summary

(Note: This summary applies to this bill as introduced and does not reflect any amendments that may be subsequently adopted. Current law sets forth emergency procedures to transport a person for a screening and to detain a person for a 72-hour treatment and evaluation if the person appears to have a mental health disorder, and as a result of the mental health disorder, appears to be an imminent danger to the person's self or others, or appears to be gravely disabled. law also sets forth procedures to certify a person for short-term or long-term care and treatment if the person has a mental health disorder, and as a result of the mental health disorder, is a danger to the person's self or others, or is gravely disabled. The bill modifies these procedures by:

- Transferring duties of the executive director of the department of human services to the commissioner (commissioner) of the behavioral health administration (BHA);
- Limiting who can take a person into protective custody and transport the person to an outpatient mental health facility, a facility designated by the commissioner of the BHA (designated facility), or an emergency medical services facility (EMS facility) if the person has probable cause to believe a person is experiencing a behavioral health crisis;
- Requiring the facility where the person is transported to require an application, in writing, stating the circumstances and specific facts under which the person's condition was called to the attention of a certified peace officer or emergency medical services provider;
- Requiring an intervening professional to screen the person immediately or within 8 hours after the person's arrival at the facility to determine if the person meets the criteria for an emergency mental health hold;
- Establishing certain rights for a person being transported, which must be explained prior to transporting the person;
- Requiring a petition for certification for long-term treatment and care to be filed with the court at least 30 days prior to the expiration of the extended certification and requiring the petition to include a recommendation as to whether the certification should take place on an inpatient or outpatient basis;
- Effective July 1, 2023:
 - Subjecting a person who files a malicious or false petition for an evaluation of a respondent to criminal prosecution;
 - Authorizing a certified peace officer to transport a person to an emergency medical services facility (EMS facility), even if a warrant has been issued for the person's arrest, if the certified peace officer believes it is in the best interest of the person;
 - Authorizing an intervening professional or certified peace officer to initiate an emergency mental health hold at the time of screening the respondent;
 - Authorizing a secure transportation provider to take

- a respondent into custody and transport the person to an EMS facility or designated facility for an emergency mental health hold;
 - Expanding the list of professionals who may terminate the emergency mental health hold;
 - Requiring the evaluation to be completed using a standardized form approved by the commissioner;
 - Expanding who can initiate a certification to include an advanced practice registered nurse with training in psychiatric nursing and prescriptive authority;
 - Requiring an EMS facility to immediately notify the BHA if a person is evaluated and the evaluating professional determines that the person continues to meet the criteria for an emergency mental health hold and the initial emergency mental health hold is set to expire before an appropriate placement is located;
 - Requiring the BHA to support the EMS facility in locating an appropriate placement option. If an appropriate placement option cannot be located, the bill authorizes the EMS facility to place the person under a second emergency mental health hold and requires the court to immediately appoint an attorney.
 - Authorizing a designated facility to place the person under a second emergency mental health hold if the person has been recently transferred from an EMS facility to the designated facility and the designated facility is unable to complete the evaluation before the initial emergency mental health hold is set to expire; and
 - Requiring the facility to provide the person with a discharge summary and a copy of the completed evaluation; facilitate a follow-up appointment within 7 calendar days after discharge; attempt to follow up with the person 48 hours after discharge; and encourage the person to designate a family member, friend, or lay person to participate in the person's discharge planning.
- Effective January 1, 2025:
 - Authorizing the court to certify a respondent for not more than 3 months for short-term treatment and place the respondent in the BHA's custody without the need for an emergency mental health hold upon a petition of certain individuals;

- Requiring the court to commit the respondent to the custody of the BHA if the court finds that grounds for certification for short-term treatment have been established;
- Authorizing the judge or magistrate who certified the respondent for short-term treatment to sign the notice of certification;
- Requiring the notification of certification to include a recommendation whether the certification should take place on an inpatient or outpatient basis;
- Authorizing the BHA to delegate physical custody of the respondent to a designated facility;
- Requiring an extended certification to be filed with the court at least 30 days prior to the expiration of the original certification;
- Establishing requirements for a short-term or long-term certification on an outpatient basis; and
- Requiring the outpatient treatment provider, in collaboration with the BHA, to develop a treatment plan for the respondent and requiring the BHA to create a one-step grievance process for the respondent related to the respondent's treatment plan or provider.

The bill establishes a right to an attorney for a person certified for short-term or long-term care and treatment, regardless of income.

The bill establishes certain rights for a person transported or detained for an emergency mental health hold or certified on an outpatient basis. The bill modifies current rights for a person certified for short-term or long-term care and treatment on an inpatient basis. The bill grants a person whose rights are wrongfully denied or violated a private right of action against the facility.

Beginning January 1, 2025, the bill requires the BHA to annually submit a report to the general assembly on the outcomes and effectiveness of the involuntary commitment system, disaggregated by region, including any recommendations to improve the system and outcomes for persons involuntarily committed or certified.

The bill makes conforming amendments.

**Care and Treatment of Persons
with Mental Health Disorders**

27-65-101. Legislative declaration. (1) The general assembly declares that ~~subject to available appropriations,~~ the purposes of this article 65 are:

(a) To secure for each person with a mental health disorder such care and treatment suited to ~~his or her~~ THE PERSON'S needs and to ensure that the care and treatment are skillfully and humanely administered with full respect for the person's dignity and personal integrity;

(b) To deprive a person of ~~his or her~~ THE PERSON'S liberty for purposes of care or treatment only when less restrictive alternatives are unavailable and only when ~~his or her~~ THE PERSON'S safety or the safety of others is endangered;

(c) To provide the fullest possible measure of privacy, dignity, and other rights to persons undergoing care and treatment for a mental health disorder;

(d) To encourage the use of voluntary, rather than coercive, measures to provide care and treatment for mental health disorders and to provide the care and treatment in the least restrictive setting;

(e) To provide appropriate information to family members concerning the location and fact of admission of a person with a mental health disorder to inpatient or residential care and treatment;

(f) To encourage the appropriate participation of family members in the care and treatment of a person with a mental health disorder and, when appropriate, to provide information to family members in order to facilitate that participation; and

(g) To facilitate the recovery and resiliency of each person who

1 receives care and treatment pursuant to this article 65.

4 BE AVAILABLE IN A TIMELY MANNER, THE CERTIFIED PEACE OFFICER OR
5 EMERGENCY MEDICAL SERVICES PROVIDER SHALL ACCESS THE
6 BEHAVIORAL HEALTH CRISIS RESPONSE TEAM PRIOR TO TRANSPORTING AN
7 INDIVIDUAL INVOLUNTARILY PURSUANT TO THIS SUBSECTION (1).

8 (2) WHEN A PERSON IS TRANSPORTED AGAINST THE PERSON'S WILL
9 PURSUANT TO SUBSECTION (1) OF THIS SECTION, THE FACILITY SHALL
10 REQUIRE AN APPLICATION, IN WRITING, STATING THE CIRCUMSTANCES
11 UNDER WHICH THE PERSON'S CONDITION WAS CALLED TO THE ATTENTION
12 OF THE CERTIFIED PEACE OFFICER OR EMERGENCY MEDICAL SERVICES
13 PROVIDER AND FURTHER STATING SUFFICIENT FACTS, OBTAINED FROM
14 PERSONAL OBSERVATIONS OR OBTAINED FROM OTHERS WHOM THE
15 CERTIFIED PEACE OFFICER OR EMERGENCY MEDICAL SERVICES PROVIDER
16 REASONABLY BELIEVES TO BE RELIABLE, TO ESTABLISH THAT THE PERSON
17 IS EXPERIENCING A BEHAVIORAL HEALTH CRISIS OR IS GRAVELY DISABLED
18 AND, AS A RESULT, IT IS BELIEVED THAT WITHOUT PROFESSIONAL
19 INTERVENTION THE PERSON MAY BE A DANGER TO THE PERSON'S SELF OR
20 OTHERS. THE APPLICATION MUST INDICATE THE NAME OF THE PERSON AND
21 THE TIME THE PERSON WAS TRANSPORTED. A COPY OF THE APPLICATION
22 MUST BE FURNISHED TO THE PERSON BEING TRANSPORTED.

23 (3) ONCE THE PERSON IS PRESENTED TO AN OUTPATIENT MENTAL
24 HEALTH FACILITY OR FACILITY DESIGNATED BY THE COMMISSIONER, AN
25 INTERVENING PROFESSIONAL SHALL SCREEN THE PERSON IMMEDIATELY.
26 IF AN INTERVENING PROFESSIONAL IS NOT IMMEDIATELY AVAILABLE, THE
27 PERSON MUST BE SCREENED WITHIN EIGHT HOURS AFTER THE PERSON'S

1 ARRIVAL AT THE FACILITY TO DETERMINE IF THE PERSON MEETS CRITERIA
2 FOR AN EMERGENCY MENTAL HEALTH HOLD PURSUANT TO SECTION
3 27-65-106. ONCE THE SCREENING IS COMPLETED AND IF THE PERSON
4 MEETS THE CRITERIA, THE INTERVENING PROFESSIONAL SHALL FIRST
5 PURSUE VOLUNTARY TREATMENT AND EVALUATION. IF THE PERSON
6 REFUSES OR THE INTERVENING PROFESSIONAL HAS REASONABLE GROUNDS
7 TO BELIEVE THE PERSON WILL NOT REMAIN VOLUNTARILY, THE
8 INTERVENING PROFESSIONAL MAY PLACE THE PERSON UNDER AN
9 EMERGENCY MENTAL HEALTH HOLD PURSUANT TO SECTION 27-65-106.

10 (4) (a) A PERSON DETAINED PURSUANT TO THIS SECTION AT AN
11 OUTPATIENT MENTAL HEALTH FACILITY OR FACILITY DESIGNATED BY THE
12 COMMISSIONER, HAS THE FOLLOWING RIGHTS WHILE BEING DETAINED,
13 WHICH MUST BE EXPLAINED TO THE PERSON BEFORE BEING TRANSPORTED
14 TO A RECEIVING FACILITY:

15 (I) TO NOT BE DETAINED UNDER AN EMERGENCY TRANSPORTATION
16 HOLD PURSUANT TO THIS SECTION FOR LONGER THAN FOURTEEN HOURS,
17 TO NOT BE TRANSPORTED FOR LONGER THAN SIX HOURS, AND TO RECEIVE
18 A SCREENING WITHIN EIGHT HOURS AFTER BEING PRESENTED TO THE

2 MEDICAL SERVICES PROVIDER BELIEVES ACCESS TO A PHONE POSES A
3 PHYSICAL DANGER TO THE PERSON OR SOMEONE ELSE, THE RECEIVING
4 FACILITY SHALL MAKE THE CALL ON THE PERSON'S BEHALF IMMEDIATELY
5 UPON ARRIVAL AT THE RECEIVING FACILITY.

6 (III) TO WEAR THE PERSON'S OWN CLOTHES AND KEEP AND USE
7 PERSONAL POSSESSIONS THAT THE PERSON HAD IN THE PERSON'S
8 POSSESSION AT THE TIME OF DETAINMENT. A FACILITY MAY TEMPORARILY
9 RESTRICT A PERSON'S ACCESS TO PERSONAL CLOTHING OR PERSONAL
10 POSSESSIONS UNTIL A SAFETY ASSESSMENT IS COMPLETED. IF THE FACILITY
11 RESTRICTS A PERSON'S ACCESS TO PERSONAL CLOTHING OR PERSONAL
12 POSSESSIONS, THE FACILITY SHALL HAVE A DISCUSSION WITH THE PERSON
13 ABOUT WHY THE PERSON'S PERSONAL CLOTHING OR PERSONAL
14 POSSESSIONS ARE BEING RESTRICTED. A LICENSED MEDICAL PROFESSIONAL
15 OR A LICENSED BEHAVIORAL HEALTH PROFESSIONAL SHALL CONDUCT A
16 SAFETY ASSESSMENT AS SOON AS POSSIBLE. THE LICENSED PROFESSIONAL
17 SHALL DOCUMENT IN THE PERSON'S MEDICAL RECORD THE SPECIFIC
18 REASONS WHY IT IS NOT SAFE FOR THE PERSON TO POSSESS THE PERSON'S
19 PERSONAL CLOTHING OR PERSONAL POSSESSIONS.

20 (IV) TO KEEP AND USE THE PERSON'S CELL PHONE, UNLESS ACCESS
21 TO THE CELL PHONE CAUSES THE PERSON TO DESTABILIZE OR CREATES A
22 DANGER TO THE PERSON'S SELF OR OTHERS, AS DETERMINED BY A
23 PROVIDER, FACILITY STAFF MEMBER, OR SECURITY PERSONNEL INVOLVED
24 IN THE PERSON'S CARE;

25 (V) TO HAVE APPROPRIATE ACCESS TO ADEQUATE WATER AND
26 FOOD AND TO HAVE THE PERSON'S NUTRITIONAL NEEDS MET IN A MANNER
27 THAT IS CONSISTENT WITH RECOGNIZED DIETARY PRACTICES;

1 (VI) TO BE TREATED FAIRLY, WITH RESPECT AND RECOGNITION OF
2 THE PERSON'S DIGNITY AND INDIVIDUALITY; AND

3 (VII) TO FILE A GRIEVANCE WITH THE BHA, THE DEPARTMENT OF
4 PUBLIC HEALTH AND ENVIRONMENT, OR THE OFFICE OF THE OMBUDSMAN
5 FOR BEHAVIORAL HEALTH ACCESS TO CARE ESTABLISHED PURSUANT TO
6 PART 3 OF ARTICLE 80 OF TITLE 27.

7 (b) A PERSON'S RIGHTS PURSUANT TO SUBSECTION (4)(a) OF THIS
8 SECTION MAY ONLY BE DENIED IF ACCESS TO THE ITEM, PROGRAM, OR
9 SERVICE CAUSES THE PERSON TO DESTABILIZE OR CREATES A DANGER TO
10 THE PERSON'S SELF OR OTHERS, AS DETERMINED BY A LICENSED PROVIDER
11 INVOLVED IN THE PERSON'S CARE OR TRANSPORTATION. DENIAL OF ANY
12 RIGHT MUST BE ENTERED INTO THE PERSON'S TREATMENT RECORD OR
13 BHA-APPROVED FORM. INFORMATION PERTAINING TO A DENIAL OF RIGHTS
14 CONTAINED IN THE PERSON'S TREATMENT RECORD MUST BE MADE
15 AVAILABLE, UPON REQUEST, TO THE PERSON, THE PERSON'S ATTORNEY, OR
16 THE PERSON'S LAY PERSON.

17 **27-65-108. Care coordination for persons certified or**
18 **in need of ongoing treatment.** (1) A FACILITY DESIGNATED BY THE
19 COMMISSIONER SHALL NOTIFY AND ENGAGE THE BHA PRIOR TO
20 TERMINATING OR TRANSFERRING A PERSON CERTIFIED PURSUANT TO

4 SERVICES HOTLINE AND INFORMATION ON THE AVAILABILITY OF PEER
5 SUPPORT SERVICES;

6 (VII) INFORMATION ON HOW TO ESTABLISH A PSYCHIATRIC
7 ADVANCE DIRECTIVE IF ONE IS NOT PRESENTED;

8 (VIII) MEDICATIONS THAT WERE CHANGED DURING THE
9 EMERGENCY MENTAL HEALTH HOLD, INCLUDING ANY MEDICATIONS THAT
10 THE PERSON WAS TAKING OR THAT WERE PREVIOUSLY PRESCRIBED UPON
11 ADMISSION, AND WHICH MEDICATIONS, IF ANY, WERE CHANGED OR

18 IMAGING THAT WAS COMPLETED OR ATTEMPTED, IF REQUESTED;

19 (XII) THE PERSON'S VITAL SIGNS UPON DISCHARGE FROM THE
20 EMERGENCY MENTAL HEALTH HOLD, IF REQUESTED;

21 (XIII) A COPY OF ANY PSYCHIATRIC ADVANCE DIRECTIVE

7 (II) TO REQUEST A CHANGE TO VOLUNTARY STATUS;

8 (III) TO BE TREATED FAIRLY, WITH RESPECT AND RECOGNITION OF
9 THE PERSON'S DIGNITY AND INDIVIDUALITY, BY ALL EMPLOYEES OF THE
10 FACILITY WITH WHOM THE PERSON COMES IN CONTACT;

11 (IV) TO NOT BE DISCRIMINATED AGAINST ON THE BASIS OF AGE,
12 RACE, ETHNICITY, RELIGION, CULTURE, SPOKEN LANGUAGE, PHYSICAL OR
13 MENTAL DISABILITY, SOCIOECONOMIC STATUS, SEX, SEXUAL ORIENTATION,
14 GENDER IDENTITY, OR GENDER EXPRESSION;

15 (V) TO RETAIN AND CONSULT WITH AN ATTORNEY AT ANY TIME;
16 EXCEPT THAT, UNLESS SPECIFIED IN SUBSECTION (7)(b) OF THIS SECTION,
17 THE FACILITY IS NOT REQUIRED TO RETAIN AN ATTORNEY ON BEHALF OF
18 THE PERSON BUT MUST ALLOW THE PERSON TO CONTACT AN ATTORNEY;

19 (VI) TO CONTINUE THE PRACTICE OF RELIGION;

20 (VII) WITHIN TWENTY-FOUR HOURS AFTER THE PERSON'S
21 REQUEST, TO SEE AND RECEIVE THE SERVICES OF A PATIENT
22 REPRESENTATIVE WHO HAS NO DIRECT OR INDIRECT CLINICAL,
23 ADMINISTRATIVE, OR FINANCIAL RESPONSIBILITY FOR THE PERSON;

24 (VIII) TO HAVE REASONABLE ACCESS TO TELEPHONES OR OTHER
25 COMMUNICATION DEVICES AND TO MAKE AND TO RECEIVE CALLS OR
26 COMMUNICATIONS IN PRIVATE. FACILITY STAFF SHALL NOT OPEN, DELAY,
27 INTERCEPT, READ, OR CENSOR MAIL OR OTHER COMMUNICATIONS OR USE

1 MAIL OR OTHER COMMUNICATIONS AS A METHOD TO ENFORCE
2 COMPLIANCE WITH FACILITY STAFF.

3 (IX) TO WEAR THE PERSON'S OWN CLOTHES, KEEP AND USE THE
4 PERSON'S OWN PERSONAL POSSESSIONS AND KEEP AND BE ALLOWED TO
5 SPEND A REASONABLE SUM OF THE PERSON'S OWN MONEY. A FACILITY
6 MAY TEMPORARILY RESTRICT A PERSON'S ACCESS TO PERSONAL CLOTHING
7 OR PERSONAL POSSESSIONS, UNTIL A SAFETY ASSESSMENT IS COMPLETED.
8 IF THE FACILITY RESTRICTS A PERSON'S ACCESS TO PERSONAL CLOTHING

3 CONFIDENTIAL, EXCEPT AS REQUIRED BY LAW;

4 (XIII) TO NOT BE FINGERPRINTED, UNLESS REQUIRED BY LAW;

5 (XIV) TO NOT BE PHOTOGRAPHED, EXCEPT UPON ADMISSION FOR
6 IDENTIFICATION AND ADMINISTRATIVE PURPOSES. ANY PHOTOGRAPHS
7 MUST BE CONFIDENTIAL AND MUST NOT BE RELEASED BY THE FACILITY
8 EXCEPT PURSUANT TO A COURT ORDER. NONMEDICAL PHOTOGRAPHS MUST

3 **SECTION 57. Appropriation.** (1) For the 2022-23 state fiscal
4 year, \$522,433 is appropriated to the department of human services. This
5 appropriation is from the general fund. To implement this act, the
6 department may use this appropriation as follows:

7 (a) \$345,007 for use by the behavioral health administration for
8 program costs, which amount is based on an assumption that the
9 administration will require an additional 4.5 FTE; and

10 (b) \$177,426 for the purchase of legal services.

11 (2) For the 2022-23 state fiscal year, \$177,426 is appropriated to
12 the department of law. This appropriation is from reappropriated funds
13 received from the department of human services under subsection (1)(b)

15 will require an additional 1.0 FTE. To implement this act, the department
16 of law may use this appropriation to provide legal services for the
