The bill changes the name of Pikes Peak community college to Pikes Peak state college.

1           **SECTION 1.** In Colorado Revised Statutes, **amend** 23-60-205 as  
2 follows:

3           **23-60-205. Community and technical colleges.** The state system  
4 of community and technical colleges includes: Arapahoe community  
5 college, Colorado Northwestern community college, the community  
6 college of Aurora, the community college of Denver, Front Range  
7 community college, Lamar community college, Morgan community  
8 college, northeastern junior college, Otero college, Pikes Peak ~~community~~  
9 STATE college, Pueblo community college, Red Rocks community  
10 college, Trinidad state college, and Colorado community college and  
11 occupational education system college. The state board for community  
12 colleges and occupational education governs the state system of  
13 community and technical colleges.

14           **SECTION 2.** In Colorado Revised Statutes, 44-30-702, **amend**  
15 (4)(a) as follows:

16           **44-30-702. Revenues attributable to local revisions to gaming**  
17 **limits - extended limited gaming fund - identification - separate**  
18 **administration - distribution - definitions - legislative declaration.**

19 (4) **Definitions.** As used in this section, unless the context otherwise  
20 requires:

21           (a) "Colleges that were operating on and after January 1, 2008"  
22 means: Aims community college, Arapahoe community college, Colorado  
23 mountain college, Colorado Northwestern community college, the  
24 community college of Aurora, the community college of Denver, Front  
25 Range community college, Lamar community college, Morgan  
26 community college, Northeastern junior college, Otero college, Pikes  
27 Peak ~~community~~ STATE college, Pueblo community college, Red Rocks

1 community college, Trinidad state college, the two-year role and mission  
2 of Colorado Mesa university, currently referred to as Western Colorado  
3 community college division of Colorado Mesa university, the two-year  
4 academic role and mission of Adams state university, and the state board  
5 for community colleges and occupational education, for so long as each  
6 such college or board continues operating.

7 **SECTION 3. Safety clause.** The general assembly hereby finds,  
8 determines, and declares that this act is necessary for the immediate  
9 preservation of the public peace, health, or safety.
