**A BILL FOR AN ACT**

101 **CONCERNING TECHNICAL CHANGES TO THE PRACTICE ACTS**  
102 **REGULATING MENTAL HEALTH PROVIDERS.**

**Bill Summary**

*(Note: This summary applies to this bill as introduced and does not reflect any amendments that may be subsequently adopted. **Statutory Revision Committee. Section 1** of the bill adds mental health professional to the list of individuals and entities that are not held liable for dispensing an opiate antagonist in accordance with the law. **Section 1** also updates the definition of "mental health professional" by adding "unlicensed" before "psychotherapist".

**Section 2** adds, in the legislative declaration of the mental health

practice act, clinical social worker candidates and addiction counselor candidates to the list of mental health licensee candidates who are subject to disciplinary actions and injunctions by their respective regulatory boards.

**Section 3** updates the definition of "registrant" by adding a cross reference for clinical social worker candidates and by adding addiction counselor candidates to the definition.

**Section 4** adds unlicensed psychotherapists to the section of law that clarifies that mental health professionals cannot administer or prescribe drugs or practice medicine.

Current law prohibits a person who practices religious ministry from publicly claiming to be a licensed, certified, or registered mental health professional unless the person possesses the proper credentials. **Section 5** adds certified addiction specialists and certified addiction technicians to the list of mental health professionals and makes a technical change to that same section of law.

**Sections 6, 7, 9, and 10** delete obsolete language from the social worker practice act, the marriage and family therapist practice act, the licensed professional counselor practice act, and the addiction counselor practice act concerning the initial appointment of members to their respective regulatory boards.

**Section 8** replaces the term "psychotherapists" with the proper term "mental health professionals" in the definition of "marriage and family therapy practice".

2 **SECTION 1.** In Colorado Revised Statutes, 12-30-110, **amend**

4 **12-30-110. Prescribing or dispensing opiate antagonists -**  
5 **authorized recipients - definitions.** (4) (b) A law enforcement agency  
6 or first responder; an employee or volunteer of a harm reduction  
7 organization; a school district, school, or employee or agent of a school;  
8 a person described in section 25-20.5-1001; A MENTAL HEALTH  
9 PROFESSIONAL; or a unit of local government acting in accordance with  
10 this section is not subject to civil liability or criminal prosecution, as  
11 specified in sections 13-21-108.7 (3) and 18-1-712 (2), respectively.

1 (7) As used in this section:

2 (b.5) "Mental health professional" means a psychologist, social  
3 worker, marriage and family therapist, licensed professional counselor,  
4 UNLICENSED psychotherapist, or addiction counselor licensed, registered,  
5 or certified under article 245 of this title 12.

13 professional counseling, psychotherapy, and addiction counseling, it is  
14 necessary that the proper regulatory authorities be established and  
15 adequately provided for.

17 established a state board of psychologist examiners, a state board of social  
18 work examiners, a state board of marriage and family therapist examiners,  
19 a state board of licensed professional counselor examiners, a state board  
20 of unlicensed psychotherapists, and a state board of addiction counselor  
21 examiners with the authority to license, register, or certify, and take  
22 disciplinary actions or bring injunctive actions, or both, concerning  
23 licensed psychologists and psychologist candidates, licensed social  
24 workers AND CLINICAL SOCIAL WORKER CANDIDATES, licensed marriage  
25 and family therapists and marriage and family therapist candidates,  
26 licensed professional counselors and licensed professional counselor  
27 candidates, unlicensed psychotherapists, and licensed and certified

1 addiction counselors AND ADDICTION COUNSELOR CANDIDATES,  
2 respectively, and mental health professionals who have been issued a

21 REGISTERED under this article 245 to administer or prescribe drugs or in  
22 any manner engage in the practice of medicine as defined by the laws of  
23 this state.

25 **SECTION 11. Act subject to petition - effective date.** This act  
26 takes effect at 12:01 a.m. on the day following the expiration of the  
27 ninety-day period after final adjournment of the general assembly; except

1 that, if a referendum petition is filed pursuant to section 1 (3) of article V  
2 of the state constitution against this act or an item, section, or part of this  
3 act within such period, then the act, item, section, or part will not take  
4 effect unless approved by the people at the general election to be held in  
5 November 2022 and, in such case, will take effect on the date of the  
6 official declaration of the vote thereon by the governor.
