**A BILL FOR AN ACT**

101      **CONCERNING CRITERIA RELATING TO THE OPERATION OF**  
102                    **TELEPHARMACY OUTLETS, AND, IN CONNECTION THEREWITH,**  
103                    **MAKING AN APPROPRIATION.**

**Bill Summary**

Currently, a "telepharmacy outlet" must be located more than 20 miles from the nearest prescription drug outlet or other telepharmacy outlet. The bill removes this geographic restriction on the operation of telepharmacy outlets.

The bill authorizes the state board of pharmacy (board) to adopt

1 *Be it enacted by the General Assembly of the State of Colorado:*

2           **SECTION 1.** In Colorado Revised Statutes, 12-280-103, **amend**  
3 (50)(a)(II), (50)(a)(III), and (50)(a)(IV); repeal (50)(b); and add (50)(c)  
4 as follows:

5           **12-280-103. Definitions - rules.** As used in this article 280, unless  
6 the context otherwise requires or the term is otherwise defined in another  
7 part of this article 280:

8           (50) (a) "Telepharmacy outlet" means a remote pharmacy site that:

9           (II) At the time of registration, is located more than twenty miles  
10 from the nearest prescription drug outlet and from any other telepharmacy  
11 outlet registered under this article 280 IN AN AREA OF NEED;

12           (III) Is connected via computer link, video link, and audio link, or  
13 via other functionally equivalent telecommunication equipment, with a  
14 central pharmacy LOCATED IN THIS STATE that is registered under this  
15 article 280; and

16           (IV) Has a pharmacy technician on site who, under the remote  
17 supervision of a licensed pharmacist located at the central pharmacy IN  
18 THIS STATE, performs the tasks described in subsection (38.5)(a) of this  
19 section.

20           (b) ~~The board may adopt rules as necessary to specify additional~~  
21 ~~criteria for a telepharmacy outlet that the board deems necessary.~~

22           (c) AS USED IN SUBSECTION (50)(a)(II) OF THIS SECTION, "AREA OF  
23 NEED" MEANS:

24           (I) ANY HEALTH FACILITY LICENSED OR CERTIFIED BY THE  
25 DEPARTMENT OF PUBLIC HEALTH AND ENVIRONMENT PURSUANT TO

1 SECTION 25-1.5-103 (1); OR

2 (II) ANY AREA WHERE A DEMONSTRATION OF NEED IS APPROVED  
3 BY THE BOARD.

4 **SECTION 2.** In Colorado Revised Statutes, 12-280-107, **add** (3)  
5 as follows:

6 **12-280-107. Rules.** (3) THE BOARD SHALL ADOPT RULES AS  
7 NECESSARY TO SPECIFY ADDITIONAL CRITERIA FOR A TELEPHARMACY  
8 OUTLET. THE BOARD'S RULES ARE LIMITED TO RULES CONCERNING THE  
9 FOLLOWING:

- 10 (a) APPLICATION REQUIREMENTS;
- 11 (b) STRUCTURAL AND EQUIPMENT REQUIREMENTS;
- 12 (c) STAFFING AND TRAINING REQUIREMENTS;
- 13 (d) CONSULTANT PHARMACIST VISITATION REQUIREMENTS;
- 14 (e) INVENTORY RECORD-KEEPING AND STORAGE REQUIREMENTS;
- 15 (f) ESTABLISHING POLICIES AND PROCEDURES RELATING TO  
16 TELEPHARMACY OPERATIONS; AND
- 17 (g) THE NUMBER OF TELEPHARMACY OUTLETS THAT MAY BE  
18 OPERATED BY A CENTRAL PHARMACY.

20 **SECTION 3. Appropriation.** (1) For the 2022-23 state fiscal  
21 year, \$505,819 is appropriated to the department of regulatory agencies.  
22 This appropriation is from the division of professions and occupations  
23 cash fund created in section 12-20-105 (3), C.R.S. To implement this act,  
24 the department may use this appropriation as follows:

- 25 (a) \$383,823 for use by the division of professions and  
26 occupations for personal services, which amount is based on an  
27 assumption that the division will require an additional 4.4 FTE;

1           (b) \$43,140 for use by the division of professions and occupations  
2           for operating expenses; and

3           (c) \$78,856 for the purchase of legal services.

4           (2) For the 2022-23 state fiscal year, \$78,856 is appropriated to  
5           the department of law. This appropriation is from reappropriated funds  
6           received from the department of regulatory agencies under subsection  
7           (1)(c) of this section and is based on an assumption that the department  
8           of law will require an additional 0.4 FTE. To implement this act, the  
9           department of law may use this appropriation to provide legal services for  
10           the department of regulatory agencies.

11           **SECTION 4. Act subject to petition - effective date.** This act  
12           takes effect at 12:01 a.m. on the day following the expiration of the  
13           ninety-day period after final adjournment of the general assembly; except  
14           that, if a referendum petition is filed pursuant to section 1 (3) of article V  
15           of the state constitution against this act or an item, section, or part of this  
16           act within such period, then the act, item, section, or part will not take  
17           effect unless approved by the people at the general election to be held in  
18           November 2022 and, in such case, will take effect on the date of the  
19           official declaration of the vote thereon by the governor.
