**Bill Summary**

The bill expands the grant program administered by the Colorado bureau of investigation (CBI) that assists counties in implementing recovery programs for persons who wander (grant program). A recovery program for persons who wander (recovery program), currently known as a lifesaver program, is a program under which a participant has a device that may be used to assist in attempting to electronically locate the participant. The bill expands the grant program to apply to recovery programs established or maintained by counties and municipalities (local governments) or local government designees. The bill also removes limits on the amount local governments and their designees may be awarded in any single grant and on the amount of money that the general assembly may annually appropriate to the recovery program cash fund that funds the grant program. Further, the bill allows the executive director of the department of public safety to award grants to assist in maintaining and implementing recovery programs.

The bill also requires the CBI to establish a website that lists those local governments and local government designees that have a recovery program, describes how to contact those local governments and local government designees, lists resources for caretakers of persons with medical conditions that cause wandering, provides procedures to follow when a participant of a recovery program is determined to be missing, describes how the technology used by the various local governments and local government designees for recovery programs works, and provides any other information the CBI may conclude is necessary to better explain and publicize recovery programs.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2           **SECTION 1.** In Colorado Revised Statutes, 24-33.5-415.9,  
3 **amend** (1)(b), (1)(f), (2), (3), (4)(a) introductory portion, (4)(a)(I),  
4 (4)(a)(II), (4)(b), (5), and (6); and **add** (1.5) and (5.5) as follows:

5           **24-33.5-415.9. Local recovery programs for persons who**  
6 **wander - administration - rules - grants to local governments -**  
7 **requirements for recovery programs for persons who wander -**  
8 **website - cash fund - legislative declaration - definitions.** (1) The  
9 general assembly hereby finds, determines, and declares that:

1 (b) In Colorado, there are currently estimated to be approximately  
2 seventy-nine thousand people with medical conditions, such as  
3 Alzheimer's disease AND RELATED DEMENTIAS, autism, ~~Down syndrome,~~  
4 ~~and other mental impairments, that cause wandering~~ BRAIN INJURY, OR  
5 DEVELOPMENTAL, COGNITIVE, NEUROLOGICAL, OR CHROMOSOMAL  
6 DISORDERS THAT MAY CAUSE PEOPLE TO WANDER.

7 (f) Establishing a grant program to encourage county sheriffs'  
8 departments, MUNICIPALITIES, AND COUNTY OR MUNICIPAL DESIGNEES to  
9 establish ~~lifesaver~~ RECOVERY programs FOR PERSONS WHO WANDER  
10 pursuant to this section will be beneficial to the citizens of Colorado by  
11 PROVIDING TOOLS THAT WILL INCREASE THE CHANCES OF saving the lives  
12 of lost and missing persons.

13 (1.5) AS USED IN THIS SECTION, UNLESS THE CONTEXT OTHERWISE  
14 REQUIRES:

15 (a) "DESIGNEE" MEANS AN ORGANIZATION DESIGNATED BY A  
16 COUNTY OR MUNICIPALITY TO ADMINISTER A RECOVERY PROGRAM FOR  
17 PERSONS WHO WANDER.

18 (b) "PARTICIPANT" MEANS A PERSON WHO HAS A MEDICAL  
19 CONDITION SUCH AS ALZHEIMER'S DISEASE AND RELATED DEMENTIAS,  
20 AUTISM, BRAIN INJURY, OR DEVELOPMENTAL, COGNITIVE, NEUROLOGICAL,  
21 OR CHROMOSOMAL DISORDERS, THAT MAY CAUSE THEM TO WANDER AND  
22 WHO PARTICIPATES IN A RECOVERY PROGRAM FOR PERSONS WHO WANDER.

23 (c) "RECOVERY PROGRAM FOR PERSONS WHO WANDER" MEANS A  
24 PROGRAM UNDER WHICH A PARTICIPANT HAS A DEVICE THAT MAY BE USED  
25 TO ASSIST IN ATTEMPTING TO ELECTRONICALLY LOCATE THE PARTICIPANT.

26 (2) The general assembly encourages each county, ~~or~~ any  
27 combination of counties, EACH MUNICIPALITY, ANY COMBINATION OF

1 MUNICIPALITIES, ANY COMBINATION OF COUNTIES AND MUNICIPALITIES,  
2 OR DESIGNEES to implement a lifesaver program under which a participant  
3 wears a small transmitter on his or her wrist to allow the county sheriffs'  
4 departments to electronically locate the participant if necessary using a  
5 radio receiver AND MAINTAIN A RECOVERY PROGRAM FOR PERSONS WHO  
6 WANDER.

7 (3) The executive director shall serve as the liaison to lifesaver  
8 RECOVERY programs in counties that choose to implement them FOR  
9 PERSONS WHO WANDER and shall administer the state grant moneys  
10 MONEY awarded for the purpose of starting the OR MAINTAINING  
11 RECOVERY programs FOR PERSONS WHO WANDER. The executive director  
12 may promulgate such rules as are necessary for the administration of this  
13 section, including but not limited to annual deadlines for submitting  
14 GRANT applications, reporting of search and rescue statistics using  
15 technology obtained under this section, and implementation AND  
16 MAINTENANCE policies for RECOVERY programs The maximum amount  
17 that a county may receive for startup is ten thousand dollars. FOR PERSONS  
18 WHO WANDER. THE EXECUTIVE DIRECTOR SHALL ENSURE THAT GRANTS  
19 ARE ONLY AWARDED TO THOSE RECOVERY PROGRAMS FOR PERSONS WHO  
20 WANDER THAT ENSURE THAT EVERY PARTICIPANT IN THE PROGRAM IS  
21 ENROLLED BY THEIR CAREGIVER.

22 (4) (a) If a county initiates COUNTY, MUNICIPALITY, OR DESIGNEE  
23 EITHER HAS A RECOVERY PROGRAM FOR PERSONS WHO WANDER OR  
24 CHOOSES TO INITIATE a lifesaver RECOVERY program FOR PERSONS WHO  
25 WANDER, it may submit a written GRANT application in a form specified  
26 by the executive director. Counties, MUNICIPALITIES, AND DESIGNEES may  
27 submit GRANT applications jointly. The GRANT application shall include

1 but not be limited to:

2 (I) An estimate of the number of people who ARE AT RISK OF  
3 WANDERING AND might qualify for assistance ~~in the county~~ UNDER THE  
4 RECOVERY PROGRAM FOR PERSONS WHO WANDER;

5 (II) An estimate of the startup OR MAINTENANCE cost OF THE  
6 RECOVERY PROGRAM FOR PERSONS WHO WANDER; and

7 (b) The executive director shall prioritize the grant awards in  
8 accordance with the respective needs of each county, MUNICIPALITY, OR  
9 DESIGNEE for tracking services and the availability of local funding  
10 sources, as documented in the GRANT applications submitted pursuant to  
11 ~~paragraph (a) of this subsection (4)~~ SUBSECTION (4)(a) OF THIS SECTION.  
12 Awards to qualifying counties, MUNICIPALITIES, AND DESIGNEES shall be  
13 prorated in accordance with the availability of state grant ~~funds~~ MONEY.

14 (5) (a) If a county, MUNICIPALITY, OR DESIGNEE accepts a grant  
15 under this section, the county, MUNICIPALITY, OR DESIGNEE shall use such  
16 grant moneys to ~~purchase emergency response kits, which shall include~~  
17 ~~equipment necessary to track and triangulate searches, as well as~~  
18 ~~transmitters, and shall provide such training as is necessary for search~~  
19 ~~personnel. Grant moneys awarded under this section shall be used for~~  
20 ~~startup capital equipment costs and initial training of search personnel and~~  
21 ~~inventory including transmitters or any other related equipment or~~  
22 ~~training required in order to implement the program. Counties accepting~~  
23 ~~grant moneys under this section shall manage and provide ongoing costs~~  
24 ~~associated with lifesaver programs once implemented.~~ MONEY FOR  
25 EQUIPMENT COSTS, TRAINING OF SEARCH PERSONNEL, OUTREACH ABOUT  
26 RECOVERY PROGRAMS FOR PERSONS WHO WANDER, AND ANY OTHER  
27 COSTS REQUIRED TO IMPLEMENT OR MAINTAIN A RECOVERY PROGRAM FOR

2 (b) ~~For All counties, MUNICIPALITIES, OR DESIGNEES establishing~~  
3 ~~OR MAINTAINING a lifesaver RECOVERY program FOR PERSONS WHO~~  
4 ~~WANDER under this section the Alzheimer's association Colorado chapter,~~  
5 ~~or its successor organization, shall provide free training for law~~  
6 ~~enforcement and families about the dangers of wandering and other~~  
7 ~~potentially hazardous behavior secondary to Alzheimer's disease, as well~~  
8 ~~as follow-up with families when a wandering incident has occurred. The~~  
9 ~~training shall delineate the course of the disease and the potential for~~

16 AND RELATED DEMENTIAS, AUTISM, BRAIN INJURY, OR DEVELOPMENTAL,

22 (c) THE BUREAU SHALL PROVIDE ALL COUNTIES, MUNICIPALITIES,  
23 OR DESIGNEES ESTABLISHING OR MAINTAINING A RECOVERY PROGRAM FOR  
24 PERSONS WHO WANDER UNDER THIS SECTION WITH ANY INFORMATION THE  
25 BUREAU CONCLUDES IS NECESSARY TO EFFECTIVELY INITIATE OR  
26 MAINTAIN A RECOVERY PROGRAM FOR PERSONS WHO WANDER.

27 (5.5) NOT LATER THAN JANUARY 1, 2023, THE BUREAU SHALL

1 ESTABLISH AND MAINTAIN A WEBSITE THAT IS AVAILABLE TO THE PUBLIC  
2 FREE OF CHARGE AND THAT:

3 (a) LISTS THOSE COUNTIES, MUNICIPALITIES, OR DESIGNEES THAT  
4 HAVE A RECOVERY PROGRAM FOR PERSONS WHO WANDER AND WHO MAY  
5 QUALIFY TO PARTICIPATE IN THOSE PROGRAMS;

6 (b) DESCRIBES HOW TO CONTACT THE COUNTIES, MUNICIPALITIES,  
7 OR DESIGNEES THAT HAVE A RECOVERY PROGRAM FOR PERSONS WHO

9 (c) LISTS RESOURCES FOR CARETAKERS OF PERSONS WITH MEDICAL  
10 CONDITIONS THAT CAUSE WANDERING;

11 (d) PROVIDES PROCEDURES TO FOLLOW WHEN A PARTICIPANT OF  
12 A RECOVERY PROGRAM FOR PERSONS WHO WANDER IS DETERMINED TO BE  
13 MISSING;

14 (e) DESCRIBES HOW THE RECOVERY TECHNOLOGY USED BY THE  
15 RECOVERY PROGRAMS FOR PERSONS WHO WANDER WORKS; AND

16 (f) PROVIDES ANY OTHER INFORMATION THE BUREAU CONCLUDES  
17 IS NECESSARY TO BETTER EXPLAIN AND PUBLICIZE RECOVERY PROGRAMS  
18 FOR PERSONS WHO WANDER.

19 (6) There is hereby created in the state treasury the lifesaver  
20 RECOVERY program FOR PERSONS WHO WANDER cash fund. The moneys  
21 MONEY in the cash fund shall be IS subject to annual appropriation by the  
22 general assembly for the direct and indirect costs of the administration of  
23 this section, including grants to counties, MUNICIPALITIES, AND DESIGNEES  
24 to ~~implement lifesaver~~ INITIATE AND MAINTAIN RECOVERY programs FOR  
25 PERSONS WHO WANDER AND THE CREATION AND MAINTENANCE OF THE

6 **SECTION 2.** In Colorado Revised Statutes, 24-33.5-102, **amend**  
7 the introductory portion; and **repeal** (4) as follows:

8 **24-33.5-102. Definitions.** As used in this ~~article~~ ARTICLE 33.5,  
9 unless the context otherwise requires:

10 (4) "Lifesaver program" or "program" means a search and rescue  
11 program designed to quickly find a wandering, lost, and missing person,  
12 as described in section ~~24-33.5-415.9~~ (2).

13 **SECTION 3. Appropriation.** (1) For the 2022-23 state fiscal  
14 year, \$100,000 is appropriated to the recovery program for the persons  
15 who wander cash fund created in section 24-33.5-415.9 (6), C.R.S. This  
16 appropriation is from the general fund. The department of public safety  
17 is responsible for the accounting related to this appropriation.

18 (2) For the 2022-23 state fiscal year, \$100,000 is appropriated to  
19 the department of public safety for use by the Colorado bureau of  
20 investigation. This appropriation is from reappropriated funds in the  
21 recovery program for the persons who wander cash fund under subsection  
22 (1) of this section. To implement this act, the bureau may use the  
23 appropriation as follows:

24 (a) \$10,859 for personal services related to the Colorado crime  
25 information center, which amount is based on an assumption that the  
26 bureau will require an additional 0.2 FTE; and

27 (b) \$89,141 for operating expenses related to the Colorado crime

1 information center.

2           **SECTION 4. Act subject to petition - effective date.** This act  
3 takes effect at 12:01 a.m. on the day following the expiration of the  
4 ninety-day period after final adjournment of the general assembly; except  
5 that, if a referendum petition is filed pursuant to section 1 (3) of article V  
6 of the state constitution against this act or an item, section, or part of this  
7 act within such period, then the act, item, section, or part will not take  
8 effect unless approved by the people at the general election to be held in  
9 November 2022 and, in such case, will take effect on the date of the  
10 official declaration of the vote thereon by the governor.
