Bill Summary

(Note: This summary applies to this bill as introduced and does not reflect any amendments that may be subsequently adopted. Beginning in the 2022-23 budget year, the bill directs the department of education (department) to annually distribute to each eligible school district and each eligible institute charter school an amount of state money as a matching amount to the property tax revenue the eligible district receives from mills levied for additional revenue (override

SENATE Amended 2nd Reading April 26, 2022 mills). To determine the amount, if any, of state matching money, the department must calculate for each district:

- The district's maximum number of override mills; and
- The number of override mills the district may be expected to levy toward the district's maximum number of override mills (override mill capacity), based on the district's median household income.

If a district's override mill capacity is less than the maximum number of override mills, the district is eligible to receive matching state money. The department must calculate each eligible district's mill levy match amount as provided in the bill. An institute charter school that is located within an eligible district is eligible to receive a distribution of state money equal to the eligible district's per pupil mill levy match amount multiplied by the institute charter school's pupil enrollment. The department must calculate and distribute in June of each budget year the mill levy match amounts from the mill levy override match fund created in the bill.

Be it enacted by the General Assembly of the State of Colorado:

(a) "ADDITIONAL MILL LEVY REVENUE PER PUPIL AMOUNT" MEANS THE AMOUNT OF AN ELIGIBLE DISTRICT'S ADDITIONAL MILL LEVY REVENUE, AS DEFINED IN SECTION 22-32-108.5, FOR A BUDGET YEAR, DIVIDED BY THE ELIGIBLE DISTRICT'S FUNDED PUPIL COUNT FOR THAT BUDGET YEAR.

BUDGET YEAR THEREAFTER, THE DEPARTMENT, IN JUNE OF EACH BUDGET YEAR, SHALL CALCULATE AND DISTRIBUTE AS A LUMP SUM TO EACH ELIGIBLE DISTRICT AND EACH ELIGIBLE INSTITUTE CHARTER SCHOOL AN OVERRIDE MILL MATCH AMOUNT AS PROVIDED IN THIS SECTION. THE DEPARTMENT SHALL DISTRIBUTE THE OVERRIDE MILL MATCH AMOUNT FROM MONEY ANNUALLY APPROPRIATED FROM THE MILL LEVY OVERRIDE MATCH FUND CREATED IN SUBSECTION (6) OF THIS SECTION. 2	as added in House Bill 22-1390 (8) as follows:
3	24-75-220. State education fund - transfers - surplus -
4	legislative declaration. (8) On July 1, 2022, the state treasurer shall
5	transfer three hundred TWO HUNDRED NINETY million dollars from the
6	general fund to the state education fund created in section 17 (4) of article
7	IX of the state constitution.
8	SECTION 3. Appropriation. (1) For the 2022-23 state fiscal
9	year, \$10,041,238 is appropriated to the department of education. This
10	appropriation consists of \$41,238 from the general fund and \$10,000,000
11	from the mill levy override match fund created in section 22-54-107.9 (6),
12	C.R.S. To implement this act, the department may use this appropriation
13	as follows:
14	(a) \$10,000,000 from the mill levy override match fund for mill
15	levy override matching pursuant to section 22-54-107.9, C.R.S.; and
16	(b) \$41,238 from the general fund for administration related to
17	public school finance, which amount is based on an assumption that the
18	department will require an additional 0.5 FTE.
19	SECTION 4. Effective date. This act takes effect upon passage;
20	except that sections 2 and 3 of this act take effect only if House Bill
21	22-1390 becomes law, in which case sections 2 and 3 of this act take
22	effect on the effective date of this act or House Bill 22-1390, whichever
23	is later.
24	SECTION 5. Safety clause. The general assembly hereby finds,
25	determines, and declares that this act is necessary for the immediate
26	preservation of the public peace, health, or safety.
