#### **Current Appropriations Clause in Bill**

The bill requires but does not contain an appropriation clause.

#### **Description of Amendments in This Packet**

**J.001** Staff has prepared amendment **J.001** (attached) to add a provision appropriating \$2,702,512 General Fund to the Department of Higher Education for FY 2022-23. This provision also

states that the appropriation is based on the assumption that the Department will require an additional 4.6 FTE

## L.006 and J.002

Bill Sponsor amendment **L.006** (attached) strikes provisions in the Education Committee Report dated February 3, 2022, which require the Department of Higher Education to establish the Foster Care Student Navigator Office. It also specifies that the General Assembly "shall appropriate money for the purpose of covering" fifty percent of foster students' remaining balance financial assistance, rather than specifying that the General Assembly "shall appropriate money to cover" fifty percent of foster students' remaining balance financial assistance. Legislative Council Staff and JBC Staff agree that: (1) eliminating the requirement for a Foster Care Student Navigator Office reduces the cost of the bill to \$2,328,035 General Fund in FY 2022-23 and ongoing; (2) the other changes in amendment L.006 will eliminate the need for mid-year budget adjustments to true-up annual appropriations.

Staff has prepared amendment J.002 to appropriate \$2,328,035 General Fund to the Department of Higher Education for FY 2022-23. The Committee may adopt J.001 or the combination of L.006 and J.002 but should not adopt any other combination of these amendments.

### **Points to Consider**

#### General Fund Impact

The Joint Budget Committee (JBC) is developing a budget package for FY 2022-23. This bill requires a General Fund appropriation of \$2,702,512 for FY 2022-23 as it was referred to the Appropriations Committee or requires a General Fund appropriation of \$2,328,035 for FY 2022-23 if amendments L.006 and J.002 are adopted. The appropriations included in this bill will reduce the General Fund available for other FY 2022-23 appropriations by the same amount.
