

(14) (a) The following statutory authorizations for the designated advisory committees are scheduled for 13 14 repeal on September 1, 2023: 15 (XI) The sexual misconduct advisory committee created in section 16 23-5-147. 17 SECTION 3. Act subject to petition - effective date. This act 18 takes effect at 12:01 a.m. on the day following the expiration of the 19 ninety-day period after final adjournment of the general assembly; except 20 that, if a referendum petition is filed pursuant to section 1 (3) of article V 21 of the state constitution against this act or an item, section, or part of this 22 act within such period, then the act, item, section, or part will not take 23 effect unless approved by the people at the general election to be held in 24 November 2024 and, in such case, will take effect on the date of the 25 official declaration of the vote thereon by the governor.
