A BILL FOR AN ACT

101 **CONCERNING THE AFFORDABILITY OF EPINEPHRINE AUTO-INJECTORS,**
102 **AND, IN CONNECTION THEREWITH, MAKING AN APPROPRIATION.**

Bill Summary

(Note: This summary applies to this bill as introduced and does not reflect any amendments that may be subsequently adopted. Effective January 1, 2024, the bill creates an epinephrine auto-injector affordability program (program) to provide low-cost epinephrine auto-injectors to individuals who:

- Are residents of this state;
- Are not enrolled in the state medicaid program or the federal medicare program;

- Have a prescription for an epinephrine auto-injector; and
- Are not enrolled in prescription drug coverage that limits the total amount of cost sharing that the enrollee is required to pay for an epinephrine auto-injector.

The bill requires the division of insurance in the department of regulatory agencies (division) to create an application for the program and requires the division and the department of health care policy and financing to make the application available on their websites and to promote the availability of the program.

The bill requires a carrier that provides coverage for prescription epinephrine auto-injectors to cap the total amount that a covered person is required to pay for all covered prescription epinephrine auto-injectors at an amount not to exceed \$60 for a 2-pack of epinephrine auto-injectors.

A pharmacy that dispenses epinephrine auto-injectors is authorized to collect a copayment not to exceed \$60 from the individual to cover the pharmacy's costs of processing and dispensing a 2-pack of epinephrine auto-injectors.

A manufacturer of epinephrine auto-injectors:

- Is required to make epinephrine auto-injectors available to individuals through the program; and
- May be required to reimburse the dispensing pharmacy an amount that covers the difference between the pharmacy's wholesale acquisition cost for the number of epinephrine auto-injectors dispensed through the program and the amount the recipients of the epinephrine auto-injectors paid for the same number of epinephrine auto-injectors or send the pharmacy a replacement supply of the same number of epinephrine auto-injectors.

If a manufacturer fails to comply with the requirements of the bill, the manufacturer may be subject to a fine.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1. Legislative declaration.** (1) The general assembly
3 finds and declares that:

4 (a) Individuals who have moderate to severe allergies, severe
5 asthma, or genetic conditions such as angioedema are at risk of reactions
6 that can occur within seconds or minutes and that can lead to anaphylaxis,
7 a potentially fatal reaction;

8 (b) Epinephrine works quickly to improve breathing, stimulate the

1 heart, raise dropping blood pressure, prevent airways from closing,
2 prevent or decrease shock, reverse hives, and reduce swelling of the face,
3 lips, and throat;

4 (c) Delay in appropriate treatment for anaphylaxis almost certainly
5 contributes to death in individuals, so it is critical that all anaphylaxis
6 reactions are treated as a medical emergency;

7 (d) In Colorado, there are approximately 565,824 individuals with
8 life-threatening food allergies, which is more than the population of
9 Colorado Springs; of these individuals, 101,848 are under 18 years of age,
10 which means that the number of children with food allergies in Colorado
11 is larger than the population of Longmont;

12 (e) Epinephrine auto-injectors are essential because they are the
13 easiest and most efficient way to potentially save the life of an individual
14 exhibiting symptoms of or experiencing anaphylactic shock;

15 (f) Many individuals are unable to afford an epinephrine
16 auto-injector because they cannot pay the copayment amount required
17 under their insurance plan or, if they are uninsured, the cost of an
18 epinephrine auto-injector; these individuals risk their lives every day by
19 not having access to this life-saving medicine if faced with an allergic
20 reaction; and

21 (g) Rising costs of epinephrine auto-injectors make this
22 life-saving medication difficult or impossible to obtain for many people,
23 even those with private health insurance or who are enrolled in a public
24 health benefit program.

25 (2) Therefore, it is the intent of the general assembly to establish
26 an epinephrine auto-injector affordability program to ensure Colorado
27 residents have greater access to epinephrine.

1 **SECTION 2.** In Colorado Revised Statutes, **add** 10-16-158 as
2 follows:

3 **10-16-158. Cost sharing - prescription epinephrine - limits -**
4 **rules - definition.** (1) AS USED IN THIS SECTION, UNLESS THE CONTEXT
5 OTHERWISE REQUIRES, "EPINEPHRINE AUTO-INJECTOR" HAS THE SAME
6 MEANING AS SET FORTH IN SECTION 12-280-141 (1)(c).

7 (2) A CARRIER THAT PROVIDES COVERAGE FOR PRESCRIPTION
8 EPINEPHRINE AUTO-INJECTORS PURSUANT TO THE TERMS OF A HEALTH
9 COVERAGE PLAN THE CARRIER OFFERS SHALL CAP THE TOTAL AMOUNT
10 THAT A COVERED PERSON IS REQUIRED TO PAY FOR ALL COVERED
11 PRESCRIPTION EPINEPHRINE AUTO-INJECTORS AT AN AMOUNT NOT TO
12 EXCEED SIXTY DOLLARS FOR A TWO-PACK OF EPINEPHRINE
13 AUTO-INJECTORS, REGARDLESS OF THE AMOUNT OR TYPE OF EPINEPHRINE
14 NEEDED TO FILL THE COVERED PERSON'S PRESCRIPTION.

15 (3) NOTHING IN THIS SECTION PREVENTS A CARRIER FROM
16 REDUCING A COVERED PERSON'S COST SHARING TO AN AMOUNT THAT IS
17 LOWER THAN THE AMOUNT SPECIFIED IN SUBSECTION (2) OF THIS SECTION.

18 (4) THIS SECTION DOES NOT APPLY TO A HIGH DEDUCTIBLE HEALTH
19 PLAN AS DEFINED BY 26 U.S.C. SEC. 223 (c)(2), AS AMENDED, THAT IS
20 ISSUED OR RENEWED IN THIS STATE UNTIL A COVERED PERSON HAS MET
21 THE COVERED PERSON'S APPLICABLE DEDUCTIBLE AMOUNT FOR SUCH
22 PLAN, UNLESS ALLOWED PURSUANT TO FEDERAL LAW.

23 (5) THE COMMISSIONER MAY USE ANY OF THE COMMISSIONER'S
24 ENFORCEMENT POWERS TO OBTAIN A CARRIER'S COMPLIANCE WITH THIS
25 SECTION.

26 (6) THE COMMISSIONER MAY PROMULGATE RULES AS NECESSARY
27 TO IMPLEMENT AND ADMINISTER THIS SECTION AND TO ALIGN WITH

1 FEDERAL REQUIREMENTS.

2 **SECTION 3.** In Colorado Revised Statutes, **add** 12-280-141 as
3 follows:

4 **12-280-141. Epinephrine auto-injector affordability program**
5 **- record keeping - reimbursement - definitions.** (1) AS USED IN THIS
6 SECTION:

7 (a) "CONSUMER PRICE INDEX" MEANS THE UNITED STATES
8 DEPARTMENT OF LABOR'S BUREAU OF LABOR STATISTICS CONSUMER PRICE
9 INDEX FOR DENVER-AURORA-LAKEWOOD FOR ALL ITEMS PAID BY ALL
10 URBAN CONSUMERS, OR ITS APPLICABLE PREDECESSOR OR SUCCESSOR
11 INDEX.

12 (b) "DIVISION OF INSURANCE" MEANS THE DIVISION OF INSURANCE
13 IN THE DEPARTMENT OF REGULATORY AGENCIES, CREATED IN SECTION
14 10-1-103.

15 (c) "EPINEPHRINE AUTO-INJECTOR" MEANS AN AUTOMATIC
16 INJECTION DEVICE FOR INJECTING A MEASURED DOSE OF EPINEPHRINE
17 BASED ON THE WEIGHT OF THE PERSON WHO IS TO RECEIVE THE INJECTION.

18 (d) "MANUFACTURER" MEANS A PERSON ENGAGED IN
19 MANUFACTURING EPINEPHRINE AUTO-INJECTORS THAT ARE AVAILABLE
20 FOR PURCHASE IN THIS STATE.

21 (e) "PHARMACY" MEANS A PHARMACY OUTLET REGISTERED
22 PURSUANT TO THIS ARTICLE 280 WHERE PRESCRIPTIONS ARE COMPOUNDED
23 AND DISPENSED.

24 (f) "PROGRAM" MEANS THE EPINEPHRINE AUTO-INJECTOR
25 AFFORDABILITY PROGRAM CREATED IN SUBSECTION (2) OF THIS SECTION.

26 (g) "PROOF OF RESIDENCY" MEANS A CURRENT AND VALID
27 DOCUMENT THAT IS IN ENGLISH, OR IS TRANSLATED INTO ENGLISH AND IS

1 UNALTERED, AND THAT INCLUDES THE INDIVIDUAL'S, OR IN THE CASE OF
2 A MINOR, THE MINOR'S PARENT'S OR GUARDIAN'S, PRINTED NAME AND
3 COLORADO RESIDENTIAL ADDRESS. DOCUMENTS THAT MAY BE USED FOR
4 PROOF OF RESIDENCY ARE:

5 (I) A COLORADO-ISSUED DRIVER'S LICENSE OR COLORADO
6 IDENTIFICATION CARD;

7 (II) A PRINTED BILL, INCLUDING A UTILITY, TELEPHONE, INTERNET,
8 CABLE, INSURANCE, MORTGAGE, RENT, WASTE DISPOSAL, WATER OR
9 SEWER, MEDICAL, OR OTHER BILL;

10 (III) A CREDIT CARD OR BANK STATEMENT;

11 (IV) A PAY STUB OR EARNINGS STATEMENT;

12 (V) A PIECE OF POST-MARKED FIRST-CLASS MAIL OR UNITED
13 STATES POSTAL SERVICE CHANGE OF ADDRESS CONFIRMATION;

14 (VI) A PRINTED RENT RECEIPT OR RESIDENTIAL LEASE;

15 (VII) A TRANSCRIPT OR REPORT CARD FROM AN ACCREDITED
16 SCHOOL;

17 (VIII) A VEHICLE TITLE OR REGISTRATION;

18 (IX) AN INSURANCE POLICY;

19 (X) A GOVERNMENT-ISSUED LETTER OR STATE OR FEDERAL
20 GOVERNMENT-ISSUED CHECK; OR

21 (XI) A RECORD OF MEDICAL SERVICE FROM A SHELTER,
22 TREATMENT FACILITY, OR ASSISTED LIVING FACILITY, INCLUDING A
23 HOMELESS SHELTER, WOMEN'S SHELTER, OTHER NONPROFIT SHELTER,
24 HALFWAY HOUSE, NURSING HOME, OR REHABILITATION FACILITY.

25

26 (2) (a) EFFECTIVE JANUARY 1, 2024, THE EPINEPHRINE
27 AUTO-INJECTOR AFFORDABILITY PROGRAM IS CREATED TO PROVIDE

1 LOW-COST EPINEPHRINE AUTO-INJECTORS TO ELIGIBLE INDIVIDUALS. BY
2 JANUARY 1, 2024, EACH MANUFACTURER SHALL ESTABLISH PROCEDURES
3 TO AND SHALL MAKE EPINEPHRINE AUTO-INJECTORS AVAILABLE IN
4 ACCORDANCE WITH THIS SECTION TO ELIGIBLE INDIVIDUALS WHO HOLD A
5 VALID PRESCRIPTION FOR EPINEPHRINE AUTO-INJECTORS. THE
6 COMMISSIONER OF INSURANCE MAY DETERMINE THAT A MANUFACTURER
7 MEETS THE REQUIREMENTS OF THIS SECTION IF THE MANUFACTURER:

8 (I) HAS A PATIENT ASSISTANCE PROGRAM THAT HAS BEEN
9 REVIEWED AND APPROVED BY THE DIVISION;

10 (II) PROVIDES COLORADO PATIENTS WITH EPINEPHRINE
11 AUTO-INJECTORS AT THE COST OF SIXTY DOLLARS OR LESS FOR EACH
12 TWO-PACK OF EPINEPHRINE AUTO-INJECTORS; AND

13 (III) CONTINUES TO MAKE THE PATIENT ASSISTANCE PROGRAM
14 AVAILABLE TO COLORADO PATIENTS WHO MEET THE ELIGIBILITY CRITERIA
15 OUTLINED IN SUBSECTION (3) OF THIS SECTION.

16 (b) THE COMMISSIONER OF INSURANCE SHALL DEVELOP A FORM
17 FOR MANUFACTURERS TO USE IN SEEKING SUCH DETERMINATION.

18 (c) IF A MANUFACTURER DISCONTINUES ITS APPROVED PATIENT
19 ASSISTANCE PROGRAM, THE MANUFACTURER MUST IMMEDIATELY
20 IMPLEMENT A PROGRAM TO COMPLY WITH THE REQUIREMENTS OF THIS
21 SECTION FOR QUALIFYING COLORADO PATIENTS.

22 (3) TO BE ELIGIBLE TO RECEIVE EPINEPHRINE AUTO-INJECTORS
23 THROUGH THE PROGRAM, AN INDIVIDUAL MUST:

24 (a) DEMONSTRATE PROOF OF RESIDENCY IN COLORADO;

25 (b) NOT BE ELIGIBLE FOR ASSISTANCE PROVIDED THROUGH THE
26 "COLORADO MEDICAL ASSISTANCE ACT", ARTICLES 4 TO 6 OF TITLE 25.5,
27 OR THE FEDERAL "HEALTH INSURANCE FOR THE AGED ACT", TITLE XVIII

1 OF THE FEDERAL "SOCIAL SECURITY ACT", 42 U.S.C. SEC. 1395 ET SEQ.,
2 AS AMENDED;

3 (c) HAVE A VALID EPINEPHRINE AUTO-INJECTOR PRESCRIPTION;
4 AND

5 (d) NOT BE ENROLLED IN PRESCRIPTION DRUG COVERAGE THAT
6 LIMITS THE TOTAL AMOUNT OF COST SHARING THAT THE ENROLLEE IS
7 REQUIRED TO PAY FOR A COVERED PRESCRIPTION TO NOT MORE THAN
8 SIXTY DOLLARS FOR A TWO-PACK OF EPINEPHRINE AUTO-INJECTORS,
9 REGARDLESS OF THE AMOUNT OR TYPE OF EPINEPHRINE NEEDED TO FILL
10 THE PRESCRIPTION.

11 (4) (a) THE DIVISION OF INSURANCE SHALL DEVELOP AN
12 APPLICATION FORM TO BE USED BY AN INDIVIDUAL WHO IS SEEKING
13 EPINEPHRINE AUTO-INJECTORS THROUGH THE PROGRAM. AT A MINIMUM,
14 THE APPLICATION FORM MUST:

15 (I) PROVIDE INFORMATION RELATED TO PROGRAM ELIGIBILITY AND
16 COVERAGE IN ENGLISH, SPANISH, AND IN EACH LANGUAGE SPOKEN BY AT
17 LEAST TWO AND ONE-HALF PERCENT OF THE POPULATION OF ANY COUNTY
18 IN WHICH SUCH POPULATION SPEAKS ENGLISH LESS THAN VERY WELL, AS
19 DEFINED BY THE UNITED STATES BUREAU OF THE CENSUS AMERICAN
20 COMMUNITY SURVEY OR COMPARABLE CENSUS DATA, AND SPEAKS A
21 SHARED MINORITY LANGUAGE AT HOME; AND

22 (II) REQUIRE THE INDIVIDUAL TO SHOW PROOF THAT THE
23 INDIVIDUAL MEETS THE REQUIREMENTS OF SUBSECTION (3) OF THIS
24 SECTION.

25 (b) THE DIVISION OF INSURANCE AND THE DEPARTMENT OF HEALTH
26 CARE POLICY AND FINANCING SHALL MAKE THE APPLICATION FORM
27 AVAILABLE ON EACH AGENCY'S WEBSITE. THE DIVISION OF INSURANCE

1 SHALL ALSO MAKE THE APPLICATION FORM AVAILABLE TO PHARMACIES,
2 HEALTH-CARE PROVIDERS, AND HEALTH FACILITIES THAT PRESCRIBE OR
3 DISPENSE EPINEPHRINE AUTO-INJECTORS.

4 (5) TO ACCESS EPINEPHRINE AUTO-INJECTORS THROUGH THE
5 PROGRAM, AN INDIVIDUAL MUST PRESENT, AT A PHARMACY, A
6 COMPLETED, SIGNED, AND DATED APPLICATION FORM WITH PROOF OF
7 RESIDENCY. IF THE INDIVIDUAL IS UNDER EIGHTEEN YEARS OF AGE, THE
8 INDIVIDUAL'S PARENT OR LEGAL GUARDIAN MAY PROVIDE THE
9 PHARMACIST WITH PROOF OF RESIDENCY.

10 (6) (a) UPON RECEIPT OF AN INDIVIDUAL'S PROOF OF RESIDENCY
11 AND COMPLETED, SIGNED, AND DATED APPLICATION FORM
12 DEMONSTRATING THAT THE INDIVIDUAL IS ELIGIBLE PURSUANT TO
13 SUBSECTION (3) OF THIS SECTION, A PHARMACIST SHALL DISPENSE THE
14 PRESCRIBED EPINEPHRINE AUTO-INJECTORS. AN INDIVIDUAL WHO IS
15 ELIGIBLE TO RECEIVE EPINEPHRINE AUTO-INJECTORS THROUGH THE
16 PROGRAM MAY RECEIVE EPINEPHRINE AUTO-INJECTORS AS PRESCRIBED
17 FOR TWELVE MONTHS.

18 (b) THE PHARMACIST IS ENCOURAGED TO INFORM THE INDIVIDUAL:

19 (I) THAT THE INDIVIDUAL MAY BE ELIGIBLE FOR MEDICAL
20 ASSISTANCE PROGRAMS PURSUANT TO THE "COLORADO MEDICAL
21 ASSISTANCE ACT", ARTICLES 4 TO 6 OF TITLE 25.5, OR AN AFFORDABLE
22 INSURANCE PRODUCT ON THE HEALTH BENEFIT EXCHANGE CREATED IN
23 SECTION 10-22-104; AND

24 (II) OF ANY MANUFACTURER-SPONSORED PROGRAMS THAT ASSIST
25 INDIVIDUALS WHO CANNOT AFFORD THEIR PRESCRIPTION EPINEPHRINE
26 AUTO-INJECTORS.

27 (c) THE PHARMACIST SHALL RETAIN A COPY OF THE APPLICATION

1 FORM SUBMITTED BY THE INDIVIDUAL FOR TWO YEARS AFTER THE DATE
2 THE EPINEPHRINE AUTO-INJECTOR WAS INITIALLY DISPENSED.

3 (7) A PHARMACY THAT DISPENSES EPINEPHRINE AUTO-INJECTORS
4 PURSUANT TO SUBSECTION (6)(a) OF THIS SECTION MAY COLLECT A
5 COPAYMENT FROM THE INDIVIDUAL TO COVER THE PHARMACY'S COSTS OF
6 PROCESSING AND DISPENSING THE EPINEPHRINE AUTO-INJECTOR, WHICH
7 COPAYMENT AMOUNT MUST NOT EXCEED SIXTY DOLLARS FOR EACH
8 TWO-PACK OF EPINEPHRINE AUTO-INJECTORS THAT THE PHARMACY
9 DISPENSES TO THE INDIVIDUAL.

10 (8) (a) THE PHARMACY MAY SUBMIT TO THE MANUFACTURER OF
11 THE DISPENSED EPINEPHRINE AUTO-INJECTORS, DIRECTLY OR THROUGH
12 THE MANUFACTURER'S DELEGATED REPRESENTATIVE, SUBCONTRACTOR,
13 OR OTHER VENDOR, AN ELECTRONIC CLAIM FOR PAYMENT THAT IS MADE
14 IN ACCORDANCE WITH THE NATIONAL COUNCIL FOR PRESCRIPTION DRUG
15 PROGRAMS' STANDARDS FOR ELECTRONIC CLAIMS PROCESSING. IF A
16 PHARMACY SUBMITS AN ELECTRONIC CLAIM TO A MANUFACTURER
17 PURSUANT TO THIS SUBSECTION (8)(a), THE PHARMACY SHALL PROVIDE
18 DOCUMENTATION OF THE DOLLAR AMOUNT THAT THE PHARMACY PAID TO
19 ITS WHOLESALER OR OTHER DISTRIBUTOR FOR THE EPINEPHRINE
20 AUTO-INJECTORS FOR WHICH THE PHARMACY IS SEEKING REIMBURSEMENT.

21 (b) BY JANUARY 1, 2024, EACH MANUFACTURER SHALL DEVELOP
22 A PROCESS FOR A PHARMACY TO SUBMIT AN ELECTRONIC CLAIM FOR
23 REIMBURSEMENT, INCLUDING AN ACCESSIBLE ONLINE APPLICATION FOR
24 REIMBURSEMENT CLAIMS FROM PHARMACIES UNDER THE PROGRAM, AS
25 PROVIDED IN SUBSECTION (8)(a) OF THIS SECTION.

26 (c) IF THE PHARMACY SUBMITS AN ELECTRONIC CLAIM TO THE
27 MANUFACTURER PURSUANT TO SUBSECTION (8)(a) OF THIS SECTION, THE

1 MANUFACTURER OR THE MANUFACTURER'S DELEGATED REPRESENTATIVE,
2 SUBCONTRACTOR, OR OTHER VENDOR SHALL, WITHIN THIRTY DAYS AFTER
3 RECEIPT OF THE CLAIM, REIMBURSE THE PHARMACY THE AMOUNT THAT
4 THE PHARMACY PAID THE MANUFACTURER FOR THE NUMBER OF
5 EPINEPHRINE AUTO-INJECTORS DISPENSED THROUGH THE PROGRAM.

6 (9) THE DIVISION OF INSURANCE AND THE DEPARTMENT OF HEALTH
7 CARE POLICY AND FINANCING SHALL PROMOTE THE AVAILABILITY OF THE
8 PROGRAM TO COLORADANS. THE PROMOTIONAL MATERIAL MUST INCLUDE
9 INFORMATION ABOUT EACH MANUFACTURER'S CONSUMER EPINEPHRINE
10 AUTO-INJECTOR PROGRAM, AS APPLICABLE. EACH AGENCY MAY SEEK AND
11 ACCEPT GIFTS, GRANTS, AND DONATIONS TO FULFILL THE REQUIREMENTS
12 OF THIS SUBSECTION (9).

13 (10) A MANUFACTURER'S REIMBURSEMENT PURSUANT TO
14 SUBSECTION (8)(c) OF THIS SECTION IS NOT A KICKBACK.

15 (11) A MANUFACTURER THAT FAILS TO COMPLY WITH THE
16 REQUIREMENTS OF THIS SECTION:

17 (a) IS SUBJECT TO A FINE OF TEN THOUSAND DOLLARS FOR EACH
18 MONTH OF NONCOMPLIANCE; AND

19 (b) ENGAGES IN A DECEPTIVE TRADE PRACTICE UNDER SECTION
20 6-1-105 (1)(uuu).

21 **SECTION 4.** In Colorado Revised Statutes, 6-1-105, **amend**
22 (1)(uuu) as follows:

23 **6-1-105. Unfair or deceptive trade practices.** (1) A person
24 engages in a deceptive trade practice when, in the course of the person's
25 business, vocation, or occupation, the person:

26 (uuu) FAILS TO COMPLY WITH THE REQUIREMENTS OF SECTION
27 12-280-141.

1 **SECTION 5. Appropriation.** For the 2023-24 state fiscal year,
2 \$58,291 is appropriated to the department of regulatory agencies for use
3 by the division of insurance. This appropriation is from the division of
4 insurance cash fund created in section 10-1-103 (3), C.R.S. To implement
5 this act, the division may use this appropriation as follows:

6 (a) \$49,176 for personal services, which amount is based on an
7 assumption that the division will require an additional 0.7 FTE; and

8 (b) \$9,115 for operating expenses.

9 **SECTION 6. Act subject to petition - effective date.** This act
10 takes effect at 12:01 a.m. on the day following the expiration of the
11 ninety-day period after final adjournment of the general assembly; except
12 that, if a referendum petition is filed pursuant to section 1 (3) of article V
13 of the state constitution against this act or an item, section, or part of this
14 act within such period, then the act, item, section, or part will not take
15 effect unless approved by the people at the general election to be held in
16 November 2024 and, in such case, will take effect on the date of the
17 official declaration of the vote thereon by the governor.
