A BILL FOR AN ACT

101 CONCERNING MEASURES DESIGNED TO ENCOURAGE THE USE OF

102 NONTOXIC BULLETS FOR HUNTING.

Bill Summary

(Note: This summary applies to this bill as introduced and does not reflect any amendments that may be subsequently adopted. The bill creates the nontoxic bullet replacement program (program) that will allow hunters to exchange:

- Hunting rounds that have lead bullets with hunting rounds that have nonlead bullets; or
- Reloading or muzzle-loader lead bullets with nonlead bullets.

The bill sets standards for taking advantage of the program.

The division of parks and wildlife (division) is directed to designate an entity to:

- Educate the public about the benefits of nontoxic bullets; and
- Publicize the program to hunters, including using hunting brochures and the division's website.
- 1 Be it enacted by the General Assembly of the State of Colorado:

2 SECTION 1. In Colorado Revised Statutes, add 33-1-127 as 3 follows:

- 33-1-127. Nontoxic bullet replacement program rules.
 (1) THE DIVISION SHALL CREATE A NONTOXIC BULLET REPLACEMENT
 PROGRAM THAT ALLOWS INDIVIDUALS WHO SATISFY THE REQUIREMENTS
- 7 OF SUBSECTION (2) OF THIS SECTION TO EXCHANGE:
- 8 (a) HUNTING ROUNDS THAT HAVE LEAD BULLETS FOR HUNTING
 9 ROUNDS THAT HAVE NONLEAD BULLETS; OR
- 10 (b) RELOADING OR MUZZLE-LOADER BULLETS FOR NONLEAD11 BULLETS.
- 12 (2) TO MAKE AN EXCHANGE AUTHORIZED IN SUBSECTION (1) OF13 THIS SECTION:
- 14 (a) AN INDIVIDUAL MUST PROVIDE EVIDENCE TO THE DIVISION
 15 THAT THE INDIVIDUAL POSSESSES A HUNTING LICENSE THAT IS CURRENTLY
 16 VALID OR WILL BE VALID IN THE FUTURE;
- 17 (b) THE ROUND OR BULLET MUST BE A LEGAL ROUND OR BULLET
 18 TO TAKE THE SPECIES FOR WHICH THE INDIVIDUAL HOLDS THE HUNTING
 19 LICENSE DESCRIBED IN SUBSECTION (2)(a) OF THIS SECTION; AND
- 20 (c) THE LEAD BULLET OR THE ROUND CONTAINING THE LEAD
 21 BULLET MUST HAVE BEEN PURCHASED BEFORE THE EFFECTIVE DATE OF
 22 THIS SECTION.

(3) THE DIVISION SHALL DESIGNATE A QUALIFIED ENTITY, AS
 DETERMINED BY THE DIVISION, TO:

3 (a) EDUCATE THE PUBLIC ABOUT THE BENEFITS OF USING
4 NONTOXIC BULLETS IN HUNTING; AND

5 (b) PUBLICIZE THE NONTOXIC BULLET REPLACEMENT PROGRAM,
6 INCLUDING USING HUNTING BROCHURES AND THE DIVISION'S WEBSITE.

7 (4) THE COMMISSION MAY PROMULGATE RULES REASONABLY
8 NECESSARY TO IMPLEMENT THIS SECTION.

9 **SECTION 2.** Act subject to petition - effective date. This act takes effect at 12:01 a.m. on the day following the expiration of the 10 11 ninety-day period after final adjournment of the general assembly; except 12 that, if a referendum petition is filed pursuant to section 1 (3) of article V 13 of the state constitution against this act or an item, section, or part of this 14 act within such period, then the act, item, section, or part will not take 15 effect unless approved by the people at the general election to be held in 16 November 2024 and, in such case, will take effect on the date of the 17 official declaration of the vote thereon by the governor.
