A BILL FOR AN ACT

101 **CONCERNING MEASURES TO SUPPORT THE IN-DEMAND CAREER**
102 **WORKFORCE, AND, IN CONNECTION THEREWITH, MAKING AN**
103 **APPROPRIATION.**

Bill Summary

(Note: This summary applies to this bill as introduced and does not reflect any amendments that may be subsequently adopted. The bill directs the state board of community colleges and occupational education (board) to administer the in-demand short-term credentials program (program) in order to support the expansion of the number of available and qualified professionals who are able to meet Colorado's in-demand workforce needs.

The bill appropriates \$38.6 million from the general fund for this program. The board is required to allocate funds to community and technical colleges, area technical colleges, local district colleges, and Colorado Mesa university to provide assistance to students for eligible expenses that support their enrollment in eligible programs. If unexpended resources exist, the funds must be used to pay for a student's housing, transportation, or food expenses.

The bill requires the office of future work to provide grants to registered apprenticeship programs that provide training in the building and construction trade at no cost to apprentices. The bill appropriates \$1.4 million from the general fund for this grant program.

The bill appropriates \$5 million from the general fund to create 2 new short-term degree nursing programs at community or technical colleges.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1. Legislative declaration.** (1) The general assembly
3 finds and declares that:

4 (a) Colorado has significant workforce demands in various
5 industries, including early childhood education, education, law
6 enforcement, fire and forestry, construction, and nursing;

7 (b) These industries support other industries across the economy
8 and have a positive return on public investment because: All Coloradans
9 benefit from the availability of child care and education so that they may
10 work while knowing their children are safe and cared for; that the
11 foundational infrastructure is secure through high-quality construction;
12 that fundamental public services are provided through fire protection,
13 forest management, and law enforcement; and that people have access to
14 quality health care;

15 (c) According to labor market index data, Colorado has an
16 opportunity to scale these industries because demand for these industries
17 is projected to grow based on recent patterns suggesting an average of ten

1 to fifteen percent annual increase in these industry jobs;

2 (d) These in-demand industries have significant job openings:

3 (I) The education sector consistently has approximately five
4 thousand job openings, which openings have been exacerbated by
5 professionals leaving the sector because of industry pressures and the
6 COVID-19 pandemic;

7 (II) The nursing sector consistently has approximately twenty
8 thousand job openings;

9 (III) Job openings in the construction sector are anticipated to
10 double because of the historic federal investment in infrastructure and
11 electrification; and

12 (IV) The early childhood sector, the fire and forestry sector, and
13 the law enforcement sector each have approximately one thousand job
14 openings;

15 (e) Investment in postsecondary education and training that leads
16 to careers in these industries demonstrates to Coloradans that these
17 professions are a priority for the state and that supporting enrollment in
18 educational and training programs will ensure a qualified workforce with
19 limited debt and a clear path to employment;

20 (f) The state's investment in the in-demand short-term credentials
21 program is intended to support twenty thousand students pursuing
22 credentials in these industries; and

23 (g) The extraordinary demand for short-term education and
24 training in nursing exceeds the state's current capacity to meet the
25 demand. The state's investment in increasing the capacity is intended to
26 support the training of two hundred additional nurses annually.

12 EDUCATION FOR ALLOCATION BY THE BOARD THIRTY-EIGHT MILLION SIX
13 HUNDRED THOUSAND DOLLARS FROM THE GENERAL FUND FOR THE
14 PROGRAM, OF WHICH NOT MORE THAN EIGHTY THOUSAND DOLLARS MAY
15 BE USED FOR PURPOSES OF MARKETING THE PROGRAM AND NOT MORE
16 THAN ONE PERCENT MAY BE USED FOR ADMINISTRATION PURSUANT TO
17 THIS SECTION.

18 (II) ANY UNEXPENDED MONEY FROM THE APPROPRIATION

17 (III) IF AVAILABLE, THE NUMBER OF STUDENTS AWARDED FUNDS
18 PURSUANT TO THE PROGRAM WHO COMPLETED AN ELIGIBLE PROGRAM, IN
19 TOTAL AND DISAGGREGATED BY ANY FACTORS DETERMINED BY THE
20 BOARD;

21 (IV) IF AVAILABLE, EMPLOYMENT AND EARNINGS OUTCOMES FOR
22 STUDENTS AWARDED FUNDS PURSUANT TO THE PROGRAM, IN TOTAL AND
23 DISAGGREGATED BY ANY FACTORS DETERMINED BY THE BOARD; AND

24 (V) A DETAILED STATEMENT OF THE ALLOCATION OF FUNDS FOR
25 THE PROGRAM, INCLUDING COSTS INCURRED TO ADMINISTER THE
26 PROGRAM.

27 (b) BEGINNING IN 2024 AND EACH YEAR THEREAFTER, THE

1 COLORADO COMMISSION ON HIGHER EDUCATION SHALL SUBMIT A REPORT
2 COMPILING THE DATA COLLECTED PURSUANT TO SUBSECTION (7)(a) OF
3 THIS SECTION TO THE SENATE AND HOUSE OF REPRESENTATIVES
4 EDUCATION COMMITTEES, OR THEIR SUCCESSOR COMMITTEES, DURING THE
5 HEARINGS HELD PURSUANT TO THE "SMART ACT", PART 2 OF ARTICLE 7
6 OF TITLE 2.

7 (c) NOTWITHSTANDING SECTION 24-1-136 (11)(a)(I), THE
8 REPORTING REQUIREMENT IN THIS SUBSECTION (7) CONTINUES
9 INDEFINITELY.

10 (8) AS USED IN THIS SECTION, UNLESS THE CONTEXT OTHERWISE
11 REQUIRES:

12 (a) "ELIGIBLE EXPENSES" MEANS TUITION, FEES, BOOKS,
13 MATERIALS, OR SUPPLIES FOR ELIGIBLE PROGRAMS.

14 (b) "ELIGIBLE INSTITUTION" MEANS A COMMUNITY OR TECHNICAL
15 COLLEGE DESCRIBED IN SECTION 23-60-205, AN AREA TECHNICAL COLLEGE
16 DEFINED IN SECTION 23-60-103 (1), A LOCAL DISTRICT COLLEGE DEFINED
17 IN SECTION 23-71-102 (1), AND COLORADO MESA UNIVERSITY
18 ESTABLISHED PURSUANT TO SECTION 23-53-101.

19 (c) "ELIGIBLE PROGRAM" MEANS AN IN-DEMAND CREDENTIAL IN
20 EARLY CHILDHOOD, EDUCATION, LAW ENFORCEMENT, FIRE AND FORESTRY,
21 CONSTRUCTION, OR NURSING THAT IS TWO YEARS OR LESS IN DURATION.

22 (d) "PROGRAM" MEANS THE IN-DEMAND SHORT-TERM
23 CREDENTIALS PROGRAM DESCRIBED IN SUBSECTION (1) OF THIS SECTION.

24 (9) THIS SECTION IS REPEALED, EFFECTIVE JULY 1, 2027.

25 **SECTION 3.** In Colorado Revised Statutes, **add** part 7 to article
26 83 of title 8 as follows:

5 (1) (a) THERE IS CREATED IN THE OFFICE OF THE FUTURE OF WORK WITHIN
6 THE DEPARTMENT OF LABOR AND EMPLOYMENT THE CONSTRUCTION
7 REGISTERED APPRENTICESHIP GRANT PROGRAM TO PROVIDE GRANTS TO
8 REGISTERED APPRENTICESHIP PROGRAMS IN THE BUILDING AND
9 CONSTRUCTION TRADES THAT PROVIDE TRAINING AT NO COST TO
10 APPRENTICES.

11 (b) THE OFFICE SHALL CONSULT WITH THE OFFICE OF ECONOMIC
12 DEVELOPMENT, THE DEPARTMENT OF EDUCATION, THE DEPARTMENT OF
13 HIGHER EDUCATION, THE STATE BOARD FOR COMMUNITY COLLEGES AND
14 OCCUPATIONAL EDUCATION, LOCAL DISTRICT COLLEGES, THE WORK FORCE
15 DEVELOPMENT COUNCIL, AND AREA TECHNICAL COLLEGES IN THE
16 DEVELOPMENT AND ADMINISTRATION OF THE GRANT PROGRAM TO ENSURE
17 ALIGNMENT WITH, AND REDUCE DUPLICATION OF, RELATED PROGRAMS
18 AND INITIATIVES.

19 (2) (a) THE OFFICE SHALL CREATE A COMPETITIVE APPLICATION
20 PROCESS THROUGH WHICH IT SELECTS REGISTERED APPRENTICESHIP
21 PROGRAMS IN THE BUILDING AND CONSTRUCTION TRADES AS GRANT
22 RECIPIENTS. A GRANT RECIPIENT MUST SATISFY, AT A MINIMUM, THE
23 FOLLOWING CRITERIA:

24 (I) TRAIN APPRENTICES IN THE BUILDING AND CONSTRUCTION
25 TRADES;

26 (II) AS A PART OF ITS GRANT APPLICATION, DEMONSTRATE HOW IT
27 WILL USE THE GRANT AWARD TO PROVIDE TRAINING TO APPRENTICES AT

1 NO COST TO THE APPRENTICES;

2 (III) AS A PART OF ITS GRANT APPLICATION, DEMONSTRATE HOW
3 IT WILL USE THE GRANT AWARD TO DIRECTLY PROVIDE TRAINING, OR
4 REMOVE BARRIERS TO ACCESSING TRAINING, TO PERSONS FROM TARGET
5 POPULATIONS;

6 (IV) AS A PART OF ITS GRANT APPLICATION, COMMIT TO
7 DIVERSITY, EQUITY, AND INCLUSION IN ITS REGISTERED APPRENTICESHIP
8 PROGRAM; AND

9 (V) AS PART OF ITS GRANT APPLICATION, PROVIDE ANY OTHER
10 CRITERIA OR ADDITIONAL INFORMATION DETERMINED NECESSARY BY THE
11 DEPARTMENT OF LABOR AND EMPLOYMENT.

12 (b) THE OFFICE SHALL DEVELOP PERFORMANCE EXPECTATIONS FOR
13 GRANT RECIPIENTS. THE OFFICE OF THE FUTURE OF WORK MAY TERMINATE
14 A REGISTERED APPRENTICESHIP PROGRAM'S PARTICIPATION IN THE GRANT
15 PROGRAM IF THE REGISTERED APPRENTICESHIP PROGRAM FAILS TO SATISFY
16 THE PERFORMANCE EXPECTATIONS.

17 (c) THE OFFICE SHALL DEVELOP A SCALE FOR THE AMOUNT OF
18 MONEY TO BE AWARDED TO GRANT RECIPIENTS BASED UPON FACTORS
19 INCLUDING THE NUMBER OF APPRENTICES IN THE REGISTERED
20 APPRENTICESHIP PROGRAM AND THE LOCATION OF THE REGISTERED
21 APPRENTICESHIP PROGRAM.

22 (3) (a) THE OFFICE SHALL REQUIRE GRANT RECIPIENTS TO
23 ANNUALLY REPORT DATA TO THE OFFICE. AT A MINIMUM, THE GRANT
24 RECIPIENTS MUST REPORT:

25 (I) THE NUMBER OF APPRENTICES AWARDED FUNDS PURSUANT TO
26 THE GRANT PROGRAM, IN TOTAL AND DISAGGREGATED BY ANY FACTORS
27 DETERMINED BY THE OFFICE;

1 (II) IF AVAILABLE, THE NUMBER OF APPRENTICES AWARDED FUNDS
2 PURSUANT TO THE GRANT PROGRAM WHO COMPLETED A REGISTERED
3 APPRENTICESHIP PROGRAM, IN TOTAL AND DISAGGREGATED BY ANY
4 FACTORS DETERMINED BY THE OFFICE;

5 (III) IF AVAILABLE, EMPLOYMENT AND EARNINGS OUTCOMES FOR
6 APPRENTICES AWARDED FUNDS PURSUANT TO THE GRANT PROGRAM, IN
7 TOTAL AND DISAGGREGATED BY ANY FACTORS DETERMINED BY THE
8 OFFICE; AND

9 (IV) A DETAILED STATEMENT OF THE ALLOCATION OF FUNDS FOR
10 THE PROGRAM, INCLUDING COSTS INCURRED TO ADMINISTER THE
11 PROGRAM.

12 (b) BEGINNING IN 2025 AND EACH YEAR THEREAFTER, THE OFFICE
13 SHALL SUBMIT A REPORT COMPILING THE DATA COLLECTED PURSUANT TO
14 SUBSECTION (3)(a) OF THIS SECTION TO THE SENATE BUSINESS, LABOR,
15 AND TECHNOLOGY COMMITTEE AND THE HOUSE OF REPRESENTATIVES
16 BUSINESS AFFAIRS AND LABOR COMMITTEE, OR THEIR SUCCESSOR
17 COMMITTEES, DURING THE HEARINGS HELD PURSUANT TO THE "SMART
18 ACT", PART 2 OF ARTICLE 7 OF TITLE 2.

19 (4) FOR THE 2023-24 STATE FISCAL YEAR, THE GENERAL
20 ASSEMBLY SHALL APPROPRIATE TO THE DEPARTMENT OF LABOR AND
21 EMPLOYMENT FOR ALLOCATION BY THE OFFICE ONE MILLION FOUR
22 HUNDRED THOUSAND DOLLARS FROM THE GENERAL FUND FOR PURPOSES
23 OF THIS SECTION. ANY UNEXPENDED MONEY REMAINING AT THE END OF
24 THE 2023-24 STATE FISCAL YEAR FROM THE APPROPRIATION LISTED IN THIS
25 SUBSECTION (4):

26 (a) DOES NOT REVERT TO THE GENERAL FUND OR ANY OTHER
27 FUND;

3 (c) MUST NOT BE USED FOR ANY PURPOSE OTHER THAN THE
4 PURPOSES SET FORTH IN THIS SECTION.

5 (5) AS USED IN THIS SECTION, UNLESS THE CONTEXT OTHERWISE
6 REQUIRES:

7 (a) "GRANT PROGRAM" MEANS THE CONSTRUCTION REGISTERED
8 APPRENTICESHIP GRANT PROGRAM CREATED IN SUBSECTION (1) OF THIS
9 SECTION.

10 (b) "OFFICE" MEANS THE OFFICE OF THE FUTURE OF WORK
11 DESCRIBED IN SECTION 8-77-110.

12 (c) "REGISTERED APPRENTICESHIP PROGRAM" HAS THE SAME
13 MEANING AS DEFINED IN SECTION 8-15.7-101 (13).

14 (d) "TARGET POPULATIONS" HAS THE SAME MEANING AS DEFINED
15 IN SECTION 8-83-601 (13).

16 **8-83-702. Repeal of part.** THIS PART 7 IS REPEALED, EFFECTIVE
17 JULY 1, 2027.

18 **SECTION 4.** In Colorado Revised Statutes, 23-1-104, **amend**
19 **(1)(b)(I); and add (1)(c.5) as follows:**

20 **23-1-104. Financing the system of postsecondary education -**
21 **report.** (1) (b) (I) For the 2010-11 fiscal year and for fiscal years
22 beginning on or after July 1, 2016, the general assembly shall make
23 annual appropriations of general fund money, of cash funds received from
24 tuition income, and of money that is estimated to be received by an
25 institution, under the direction and control of the governing board, as
26 stipends, as defined in section 23-18-102, and through fee-for-service
27 contracts, as authorized in section 23-1-109.7 or 23-18-303.5, whichever

1 is applicable, as a single line item to each governing board for the
2 operation of its campuses; except that, if the general assembly
3 appropriates money, as described in subsection (1)(c) of this section, to
4 the Colorado state forest service, the agricultural experiment station
5 department of the Colorado state university, or the Colorado state
6 university cooperative extension service, OR TO THE STATE BOARD FOR
7 COMMUNITY COLLEGES AND OCCUPATIONAL EDUCATION AS DESCRIBED IN
8 SUBSECTION (1)(c.5) OF THIS SECTION, such money shall not be included
9 within the single line item appropriations described in this subsection

26 **SECTION 6.** In Colorado Revised Statutes, **add** 23-60-214 as
27 follows:

2 **appropriation - repeal.** (1) FOR THE 2023-24 STATE FISCAL YEAR, THE
3 GENERAL ASSEMBLY SHALL APPROPRIATE TO THE DEPARTMENT OF HIGHER
4 EDUCATION FOR ALLOCATION BY THE BOARD FIVE MILLION DOLLARS FROM
5 THE GENERAL FUND TO ESTABLISH TWO NEW SHORT-TERM DEGREE
6 NURSING PROGRAMS AT COMMUNITY OR TECHNICAL COLLEGES DESCRIBED
7 IN SECTION 23-60-205. THE FUNDS MUST BE USED FOR THE FOLLOWING
8 PURPOSES, AS APPLICABLE, TO SUPPORT THE EXPANSION OF SHORT-TERM
9 DEGREE NURSING PROGRAMS:

10 (a) NEW SHORT-TERM DEGREE PROGRAM CURRICULUM
11 DEVELOPMENT;

12 (b) NEW SHORT-TERM DEGREE PROGRAM EQUIPMENT AND
13 SUPPLIES;

14 (c) NEW SHORT-TERM DEGREE PROGRAM IMPLEMENTATION,
15 INCLUDING ACCREDITATION COSTS; AND

16 (d) NEW SHORT-TERM DEGREE ADMINISTRATION COSTS, INCLUDING
17 REPORTING ON AN ANNUAL BASIS UNTIL ALL FUNDS ARE EXPENDED.

18 (2) ANY UNEXPENDED MONEY REMAINING AT THE END OF THE
19 2023-24 STATE FISCAL YEAR FROM THE APPROPRIATION PURSUANT TO
20 SUBSECTION (1) OF THIS SECTION:

21 (a) DOES NOT REVERT TO THE GENERAL FUND OR ANY OTHER
22 FUND;

23 (b) MAY BE USED BY THE DEPARTMENT OF HIGHER EDUCATION IN
24 THE 2024-25 OR 2025-26 STATE FISCAL YEAR WITHOUT FURTHER
25 APPROPRIATION; AND

26 (c) MUST NOT BE USED FOR ANY PURPOSE OTHER THAN THE
27 PURPOSES SET FORTH IN THIS SECTION.

2 **SECTION 7.** In Colorado Revised Statutes, 25-1.5-102, **amend**

5 **duties of department - rules - definitions.** (1) The department has, in
6 addition to all other powers and duties imposed upon it by law, the
7 powers and duties provided in this section as follows:

8 (e) For fiscal year 2022-23, the general assembly shall appropriate
9 ten million dollars from the economic recovery and relief cash fund
10 created in section 24-75-228 to the department. The department shall use
11 this appropriation for recruitment and re-engagement efforts of workers
12 in the health-care profession with current or expired licenses and staffing.

13 ANY MONEY REMAINING AT THE END OF THE 2022-23 STATE FISCAL YEAR
14 FROM THIS APPROPRIATION IS FURTHER APPROPRIATED TO THE
15 DEPARTMENT FOR THE PURPOSES OF THIS SECTION. ANY MONEY THAT IS
16 NOT EXPENDED OR OBLIGATED BY DECEMBER 30, 2024, REVERTS TO THE
17 "AMERICAN RESCUE PLAN ACT OF 2021" CASH FUND CREATED IN SECTION
18 24-75-226 (2) IN ACCORDANCE WITH SECTION 24-75-226 (4)(d). ANY
19 MONEY OBLIGATED BY DECEMBER 30, 2024, MUST BE EXPENDED BY
20 DECEMBER 31, 2026.

21 **SECTION 8.** In Colorado Revised Statutes, 25-1.5-406, **amend**
22 (9) as follows:

23 **25-1.5-406. School nurse grant program - creation - eligibility**
24 **- award of grants - rules - report - legislative declaration - definitions.**

25 (9) The general assembly shall appropriate three million dollars from the
26 economic recovery and relief cash fund created in section 24-75-228 to
27 the department for the GRANT program. ANY MONEY REMAINING AT THE

1 END OF THE 2022-23 STATE FISCAL YEAR FROM THIS APPROPRIATION IS
2 FURTHER APPROPRIATED TO THE DEPARTMENT FOR THE PURPOSES OF THIS
3 SECTION. ANY MONEY THAT IS NOT EXPENDED OR OBLIGATED BY
4 DECEMBER 30, 2024, REVERTS TO THE "AMERICAN RESCUE PLAN ACT OF
5 2021" CASH FUND CREATED IN SECTION 24-75-226 (2) IN ACCORDANCE
6 WITH SECTION 24-75-226 (4)(d) . ANY MONEY OBLIGATED BY DECEMBER
7 30, 2024, MUST BE EXPENDED BY DECEMBER 31, 2026.

8 **SECTION 9. Appropriation.** (1) For the 2023-24 state fiscal
9 year, \$43,600,000 is appropriated to the department of higher education
10 for allocation to the state board for community colleges and occupational
11 education. This appropriation is from the general fund. To implement this
12 act, the board may use this appropriation as follows:

- 13 (a) \$38,600,000 for the in-demand short-term credentials program;
- 14 and
- 15 (b) \$5,000,000 for short-term degree nursing programs.

16 (2) For the 2023-24 state fiscal year, \$1,400,000 is appropriated
17 to the department of labor and employment. This appropriation is from
18 the general fund, and is based on an assumption that the department will
19 require an additional 1.2 FTE. To implement this act, the department may
20 use this appropriation for the construction registered apprenticeship grant
21 program administered by the office of the future of work.

22 **SECTION 10. Safety clause.** The general assembly hereby finds,
23 determines, and declares that this act is necessary for the immediate
24 preservation of the public peace, health, or safety.
