HOUSE JOINT RESOLUTION 23-1019

101 **CONCERNING THE RECOGNITION OF LATINO/A/E/X ADVOCACY DAY.**

1 WHEREAS, Latino/a/e/x Advocacy Day (LAD) celebrates
2 seventeen years of engaging Latinos from across Colorado to advocate for
3 change in state policy. LAD's legacy has amplified Latino voices across
4 the state of Colorado to speak on the structural inequities that have
5 historically plagued their communities. Their voices have been critical in
6 advancing policies to improve the lives and economic well-being of
7 current and future generations of all Coloradans; and

8 WHEREAS, Latinos are a key part of Colorado's constituency,
9 with communities hailing from Mexico, Central America, the Caribbean,
10 and South America. Latinos have persevered through adverse
11 experiences, making their presence revolutionary in itself. Their
12 organizing efforts have played a crucial role in building momentum
13 across various spectrums and all segments of society as educators, artists,

2 business owners, and farmers, among the many lives that contribute to our
3 vibrant and diverse Colorado communities; and

4 WHEREAS, Engaging Latinos in the political process ensures that
5 the voices and lived experiences of all Coloradans are respected and
6 honored, and helps create policies that impact the daily lives of people in
7 their communities across the state; now, therefore,

8 *Be It Resolved by the House of Representatives of the*
9 *Seventy-fourth General Assembly of the State of Colorado, the Senate*
10 *concurring herein:*

11 (1) That we, the members of the Colorado General Assembly,
12 recognize the achievements of the Latino/a/e/x community in politics and
13 honor their contributions to Colorado's long history of political
14 engagement and the policymaking process; and

15 (2) That we pay tribute to past and current Latino/a/e/x Advocacy
16 Day participants who have traveled to the Colorado State Capitol from
17 across Colorado to ensure representation and the just treatment of
18 Latino/a/e/x communities in Colorado.

19 *Be It Further Resolved*, that copies of this Joint Resolution be sent
20 to the Colorado Democratic Latino Caucus; the Colorado Organization
21 for Latina Opportunity and Reproductive Rights (COLOR); the Colorado
22 Latino Leadership, Advocacy, and Research Organization (CLLARO);
