### **HOUSE RESOLUTION 23-1006**

101	CONCERNING THE APPROVAL BY THE HOUSE OF REPRESENTATIVES OF
102	THE SPEAKER'S APPOINTMENT OF DANIEL WOLF TO THE
103	INDEPENDENT ETHICS COMMISSION.

WHEREAS, Section 5 (2)(a)(II) of article XXIX of the Colorado constitution provides that one member of the Independent Ethics Commission created in section 5 (1) of that article, hereafter referred to as the "Commission", shall be appointed by the House of Representatives, and section 24-18.5-101 (2)(a), Colorado Revised Statutes, provides that said appointment shall be made by the Speaker of the House of Representatives with the approval of two-thirds of the members elected to the House; and

WHEREAS, Pursuant to such authority, Speaker Julie McCluskie appoints Daniel Wolf to the Independent Ethics Commission to succeed Commissioner Amy Kao upon the conclusion of her term; and

WHEREAS, Mr. Wolf is a real estate, business, and commercial law attorney with over thirty years of diverse and wide-ranging experience, primarily practicing in Summit and Eagle Counties and surrounding mountain communities; and
