Current Appropriations Clause in Bill

The bill requires but does not contain an appropriation clause.

Description of Amendments in This Packet

J.001 Staff has prepared amendment **J.001** (attached) to add a provision appropriating \$2,000,000 cash funds from the Wildfire Resilient Homes Grant Program Cash Fund to the Department of Public Safety for FY 2023-24, which originates as a General Fund transfer to the cash fund in the bill. The cash fund is created in the bill and is subject to annual appropriation by the General Assembly.

L.002 and J.002

Bill Sponsor amendment **L.002** (attached) reduces the transfer in the bill from \$2.0 million to \$100,000 General Fund, and specifies that applicant income may be considered to prioritize grant awards. Staff has prepared amendment **J.002** (attached) to add a provision appropriating \$100,000 cash funds from the Wildfire Resilient Homes Grant Program Cash Fund to the Department of Public Safety in FY 2023-24.

If the Committee adopts **L.002**, it should **adopt J.002** and **not J.001**.

Points to Consider

General Fund Impact

The Joint Budget Committee has proposed a budget package for FY 2023-24 based on the March 2023 Office of State Planning and Budgeting (OSPB) revenue forecast. The budget package includes two set-asides for legislation outside of the package: (1) \$30.0 million General Fund for bills that create ongoing obligations; and (2) \$469.0 million for bills that create one-time obligations for FY 2023-24 (see table below).

The budget package accounts for the 15.0 percent reserve associated with the above placeholders (a total of \$74.9 million).

This bill creates a one-time obligation and requires a General Fund transfer of \$2.0 million for FY 2023-24, reducing the \$469.0 million set aside by that amount. If the Committee adopts **L.002**, the one-time obligation is reduced to \$100,000, reducing the \$469.0 million set aside by that amount.
