## Summary of Legislation

If the Colorado Commission on Higher Education (CCHE) enters into professional student exchange programs, the bill requires that the CCHE establish policies to maximize the benefit of this program to Colorado residents. These policies may include, but are not limited to, ensuring that optometry students provide services to Coloradans enrolled in Medicaid and incentivizing optometry graduates to serve in areas that have poor access to optometry services.

The bill also modifies state law regarding the Western Interstate Commission on Higher Education (WICHE) Professional Student Exchange Program to align with how the program currently operates. These exchange programs provide full or partial tuition waivers for Colorado students who enroll in out-of-state programs that are not available in the state or offer professional training in a high need subject area, and who agree to a post-education service commitment in Colorado.

## State Expenditures

The bill will increase workload for the CCHE to adopt policies that maximize the benefits of student exchange programs. This workload can be accomplished within existing resources.

## **Effective Date**

The bill was signed into law by the Governor and took effect on April 17, 2023.
