Bill Topic: PUBLIC SCHOOL FINANCE

This bill is the 2023 School Finance Act that sets funding levels for Colorado's 178 school districts. It also establishes a task force, modifies the funded pupil count calculation for CSI schools, and modifies several education-related programs. The bill increases state expenditures and school district funding, and makes state transfers.

Appropriation Summary: For FY 2023-24, the bill requires and includes an appropriation of \$266.6 million to the Colorado Department of Education.

Fiscal Note Status: This fiscal note reflects the enacted bill.

## **Summary of Legislation**

The bill makes changes to state law regarding the funding of public schools and associated programs within the Colorado Department of Education (CDE).

**Base per pupil funding.** The bill increases base per pupil funding for FY 2023-24 by \$598.25, to \$8,076.41. This reflects an 8.0 percent inflation increase.

**Budget stabilization factor.** The bill decreases the budget stabilization factor by \$180 million, from \$321.4 million in FY 2022-23 to \$141.2 million in FY 2023-24. Beginning in FY 2024-25, the bill eliminates the budget stabilization factor.

**Averaging for Charter School Institute schools.** Under current law, a school district's pupil count is the greater of the current budget year pupil count, or an average of the current year and up to four prior year counts. The bill provides the same averaging provision for each charter school authorized by the state Charter School Institute (CSI). Pupil counts used in averaging do not include students enrolled in multi-district online schools.

**Funding for rural schools.** The bill provides \$30 million in FY 2023-24 to CDE to be distributed to rural school districts and CSI schools. Of that amount, 55 percent must be allocated to rural districts and 45 percent must be allocated to small rural districts, based on CDE designation, and funding is distributed on a per pupil basis. The funding must be used for nonrecurring expenses for improving student learning and the educational environment, which may include initiatives attracting educators.

**At-risk measure.** House Bill 22-1202 established a new mechanism for counting at-risk students for the purposes of the school finance formula, to be used beginning in FY 2023-24. The bill delays implementation of the new measure for one year until FY 2024-25 and requires CDE to conduct pre-implementation data collection and modeling of the new measure. A report on the modeling, any issues, and any recommended legislative changes needed must be submitted to the General Assembly by January 5, 2024.

In addition, the bill specifies that for the FY 2023-24 budget year, a district's at-risk funding is the greater of the district's FY 2022-23 at-risk funding or the amount calculated for FY 2023-24.

**Special education preschool.** Under House Bill 22-1295, funding for preschool students enrolled in district or charter schools is distributed through the universal preschool program beginning in FY 2023-24, instead of through the school finance formula. The bill provides \$10.0 million in FY 2023-24, to be distributed to preschool providers that are school districts or charter schools to ensure that they are able to meet federal special education maintenance of effort requirements.

**Public School Finance Task Force.** The bill creates the Public School Finance Task Force in CDE to complete the following:

- make recommendations changes to the school finance formula for FY 2024-25, including eliminating the use of multiplicative factors, alternatives for or changes to the cost of living factor and size factor, funding for CSI mill levy override equalization, and changes that prioritize student needs; and

- developing the parameters for a study on the components and costs necessary to adequately provide public education. CDE must contract for two adequacy studies from independent entities with differing perspectives.

CDE must contract with a third-party entity to facilitate the task force and report to the General Assembly on formula changes by January 31, 2024. The contractors must submit the adequacy studies to the task force by January 3, 2025. The bill specifies the compensation of the task force, with 17 members and three non-voting members. The task force must meet up to nine times from July through December 2023. Members serve without compensation, but may be reimbursed for expenses.

**Charter school capital construction.** The bill modifies the matching requirements for charter schools that receive funding from the Building Excellent Schools Today (BEST) program and provides \$10.0 million for charter school capital construction.

**Mill levy override match.** On July 1, 2023, the bill transfers \$23.4 million from the State Education Fund to the Mill Levy Override Match Fund. The bill also specifies that beginning in FY 2022-23, CDE must not distribute funding to an eligible district if the sum of the district's override mills is greater than or equal to the district's override mill levy capacity.

**American Indian mascot compliance reimbursement.** Under the bill, a school that was in violation of the prohibition on American Indian mascots may apply to CDE for reimbursement of expenses incurred to comply with the prohibition. The bill provides \$300,000 for this purpose and specifies that CDE must distribute the funding proportionately, based on the expenses incurred by each school. Reimbursements may not cover any fines paid as a result of the violation.

**Gifted and talented screening.** Beginning in FY 2023-24, the bill requires that the General Assembly appropriate the amount of funding necessary to provide universal screening to identify gifted and talented students by FY 2027-28.

**Mill levy override equalization.** In FY 2023-24, the bill appropriates \$2.5 million from General Fund to the Mill Levy Equalization Fund, for allocation to CSI schools. Beginning in FY 2024-25, the bill specifies that the General Assembly must appropriate from the General Fund the amount required to fully fund mill levy equalization for CSI schools.

**Individualized education plan translations.** For FY 2023-24, the bill appropriates \$500,000 to CDE for communication and translation of student individualized education plans (IEP).

**Charter schools as public entities.** The bill specifies that charter schools are public entities, with limited exceptions. Within 90 days of the bill's effective date, the bill requires that charter schools must submit the information to the Department of Local Affairs that local governments are currently required to submit.

**Charter school report.** Under current law, CDE is required to report certain information on charter schools to the General Assembly every three years. The bill requires that the report occur annually beginning in FY 2023-24, and authorizes CDE to collect information as necessary to prepare the report.

**Other changes.** The bill also makes the following changes:

- makes lunches served to students in facility schools eligible for funding through the School Lunch Protection Program;
- exempts program evaluation costs from the 20 percent cap of administration costs for the Imagination Library Program; and
- allows CDE, districts, and CSI schools to consider life-cycle costs when reviewing and selecting contracts for technology products, for contracts executed on or after July 1, 2023.

## State Transfers

In FY 2023-24, the bill makes the following transfers:

- \$23,376,536 from the State Education Fund to the Mill Levy Match Fund; and
- \$2,500,000 from the General Fund to the Mill Levy Equalization Fund. The transfer to the Mill Levy Equalization Fund occurs through an appropriation.

In FY 2024-25, the bill requires that the General Assembly appropriate the amount required to fully fund mill levy equalization for CSI schools. This amount is estimated at \$24.3 million relative to current law. The fiscal note assumes funding for this purpose will be transferred via an appropriation from the General Fund to the CSI Mill Levy Equalization Fund.

## State Expenditures

In FY 2023-24, the bill increases state expenditures in CDE by \$266.6 million, including \$240.7 million from the State Education Fund and \$25.9 million from two cash funds. In FY 2024-25, the bill increases state spending by an estimated \$539.5 million, excluding changes to school finance funding as a result of enrollment, local share, and actual inflation. Expenditures are shown in Table 2 and detailed below.

**School Finance**

The bill sets total program funding for FY 2023-24 at \$9.1 billion. This represents a 1.6 percent (\$141.2 million) reduction from what funding levels would be without the budget stabilization factor. Compared to current law, the bill increases total program funding in FY 2023-24 by \$180.0 million.

Compared to actual funding in FY 2022-23, the bill increases total program funding by \$665.0 million. State expenditures for school finance will increase by \$21.5 million and the local share of funding will increase by \$643.5 million compared to FY 2022-23. State funding is from the General Fund, State Education Fund, and State Public School Fund. Table 3 shows an estimate of school funding under this bill, after the budget stabilization factor, compared to FY 2022-23.

**FY 2024-25 preliminary estimate.** For FY 2024-25, total program is estimated to be \$480.7 million more than FY 2023-24 funding levels; this amount does not include changes to school finance as a result of actual enrollment, local share, and inflation. The estimate was made by increasing the base per pupil funding in FY 2023-24 by 4.9 percent, Legislative Council Staff’s current projection for inflation in 2023, and then multiplying it by the current year funded pupil count, and then adding \$141.2 million, the cost to eliminate the budget stabilization factor.

**Other Funding and Program Changes**

**CSI averaging.** In addition to the school finance funding discussed above, the bill increases the state share of total program to cover the cost of allowing pupil count averaging for CSI schools on a per school basis. This cost is estimated at \$8.5 million for an estimated 878.5 additional funded pupils in FY 2023-24, based on enrollment in the current year and four prior years. Any adjustments based on actual enrollment will occur through the midyear adjustment bill, and the actual cost in out years will be based on actual enrollment.

**Rural schools funding.** The bill provides \$30.0 million to CDE in FY 2023-24, to be distributed on a one-time basis to rural and small rural school districts in FY 2023-24. The money is distributed outside the funding formula on a per pupil basis, with 55 percent allocated to rural districts (funded pupil count between 1,000 and 6,500) and 45 percent allocated to small rural districts (funded pupil count less than or equal to 1,000) as designated by CDE. Appendix B presents estimated allocations to eligible school districts based on projected funded pupil counts.

**Mill levy override match.** The bill provides \$23.4 million from the MLO Match Fund for the mill levy override match program, to be distributed by CDE to eligible school districts to match local money raised through voter-approved mill levy overrides. Funds are allocated based on the formula created in [Senate Bill 22-202](#), with the clarifications in this bill, and are expected to be distributed to 26 districts in FY 2023-24. Appendix C presents expected distributions to districts in FY 2023-24. The fiscal note assumes that amount is ongoing.

**American Indian mascot compliance.** The bill provides \$300,000 in FY 2023-24 to reimburse expenses incurred by schools that were required to change their mascots. CDE must distribute the funding proportionately, based on the expenses incurred by each school. The funding may be spent over two years, with reimbursements for costs incurred in FY 2021-22 and FY 2022-23 distributed in FY 2023-24 and reimbursements incurred in FY 2023-24 distributed in FY 2024-25.

**Gifted and talented universal screening.** The bill increases costs for CDE for five years for gifted and talented screening. Specifically, CDE requires \$1.1 million in FY 2023-24, and by an additional \$1.1 million each year through FY 2027-28. Beginning in FY 2027-28 when it is fully phased in, the \$5.3 million is expected to fully fund gifted and talented screening.

**CSI mill levy override equalization.** In FY 2023-24, the bill provides \$2,500,000 from the Mill Levy Equalization Fund for CSI mill levy equalization. In FY 2024-25, the bill requires that the General Assembly fully fund CSI mill levy equalization. This is estimated to cost \$49.2 million in FY 2024-25, an increase of \$24.3 million above the FY 2022-23 appropriation. This estimate is based on CSI enrollment and mill levy overrides from FY 2022-23, and forecasted assessed values for FY 2023-24. The actual amount will depend on actual assessed values, actual CSI enrollment, and any changes to mill levy overrides approved by school district voters. As a result, the impact in out years may be higher than estimated. These funds are distributed by the CSI to CSI schools that are geographically located in school districts that collect mill levy overrides.

**IEP translation.** The bill provides \$500,000 to CDE for translation of IEPs for students who are English language learners. This funding is assumed to be ongoing.

**Special education preschool.** In FY 2023-24 only, the bill provides \$10.0 million to CDE to be distributed to preschool providers that are school districts or charter schools to ensure they meet federal maintenance of effort requirements for special education. Districts and charter schools receive funding if they are projected to receive less funding through the universal preschool program in FY 2023-24 than they received for all preschool slots in FY 2022-23.

**Charter school capital construction.** The bill provides \$10.0 million for charter school capital construction through the BEST program. The fiscal note assumes that this is one-time funding and will be distributed through the current distribution process.

**Public School Finance Task Force.** The bill increases expenditures in CDE by \$422,191 in FY 2023-24 and \$32,598 in FY 2024-25 to administer and support the task force created by the bill. As shown in Table 4 below, CDE requires 0.7 FTE in FY 2023-24 and 0.3 FTE in FY 2024-25 to support the task force and contract with the vendors for the adequacy studies. CDE will incur costs to conduct two RFP processes (\$17,850 each) and to contract with a facilitator and two vendors to complete adequacy studies. Costs are estimated at \$100,000 for each contract. CDE will also incur meeting costs to hold two meetings in person and the fiscal note assumes all remaining meetings will occur remotely.

**At-risk measure.** The bill increases workload for CDE to conduct modeling and analysis of the new at-risk measure in FY 2023-24. The fiscal note assumes that CDE will utilize census block data collected on a voluntary basis from school districts. Workload is expected to be minimal; however, any costs incurred can be covered by unexpended appropriations for HB 22-1202.

In addition, the requirement that districts receive at least the same at-risk funding in FY 2023-24 as they received in FY 2022-23 may increase state expenditures in FY 2023-24. Any appropriation for this purpose will be handled through the school finance midyear adjustment process.

**Facility school meals.** The bill minimally increases costs in CDE for facility schools to participate in the School Lunch Protection Program. The additional cost can be accomplished within current appropriations.

**Other program changes.** The changes related to the Imagination Library program, IT procurement, and charter school report may impact workload for CDE, but do not require changes in appropriations.

**Centrally appropriated costs.** Pursuant to a Joint Budget Committee policy, certain costs associated with this bill are addressed through the annual budget process and centrally appropriated in the Long Bill or supplemental appropriations bills, rather than in this bill. These costs, which include employee insurance and supplemental employee retirement payments, are shown in Table 2.

### Other State Agencies

**Department of Local Affairs.** The bill increases costs for the Department of Local Affairs for charter schools to submit the information required by the bill. Costs are estimated at about \$6,800 in FY 2023-24 only and can be absorbed within current appropriations.

**Legislative Department.** The bill increases workload by a minimal amount for staff from Legislative Council Staff and the Joint Budget Committee Staff to sit on the task force as non-voting members. This may be accomplished within existing appropriations.

## **Other Budget Impacts**

**General Fund reserve.** Under current law, an amount equal to 15 percent of General Fund appropriations must be set aside in the General Fund statutory reserve. Based on this fiscal note, the bill is expected to increase the amount of General Fund held in reserve by the amounts shown in Table 1, decreasing the amount of General Fund available for other purposes.

## **School District**

**Total program.** Table 3 compares estimated FY 2023-24 school finance funding levels with actual funding in FY 2022-23. In FY 2023-24, the bill increases funding by \$1,018 per pupil and funds 21,701 fewer pupils statewide relative to FY 2022-23. Total program funding increases by \$665.0 million, from \$8.4 billion to \$9.1 billion. Of this amount, the state's share increases by \$21.5 million, from \$4.99 billion to \$5.01 billion, and the local share increases by \$643.5 million, from \$3.4 billion to \$4.1 billion.

**Rural schools funding.** As discussed in the State Expenditures section, the bill provides \$30.0 million to be distributed to rural and small rural schools. Rural districts receive 55 percent of the funding and small rural districts receive 45 percent of the funding, distributed based on each district's funded pupil count. Appendix B presents estimated district distributions.

**Other changes.** The programmatic and technical changes in the bill will impact some school districts. Districts may have increased workload to provide data to CDE for at-risk modeling and may receive additional revenue from funding for mill levy override match (see Appendix C), American Indian mascot compliance reimbursement, IEP translation, and gifted and talented screening.

## **Effective Date**

The bill was signed into law by the Governor and took effect on May 15, 2023. The appropriation for IEP translation only takes effect if House Bill 23-1263 becomes law; that bill was signed into law on May 25, 2023.

## **State Appropriations**

For FY 2023-24, the bill requires and includes the following appropriations from the State Education Fund to the Colorado Department of Education:

- \$188,490,019 for the state share of total program funding;
- \$30,000,000 for distributions to rural schools;
- \$300,000 for reimbursements related to compliance with the American Indian mascot prohibition;
- \$1,058,115 for gifted and talented screening;
- \$408,625 for task force and contracting costs, and 0.7 FTE;



- \$500,000 for IEP translation;
- \$10,000,000 for special education preschool; and
- \$10,000,000 for charter school capital construction.

For FY 2023-24, the bill requires and includes an appropriation of \$23,376,536 to CDE from the Mill Levy Override Match Fund.

The bill includes an appropriation of \$2,500,000 from the General Fund to the Mill Levy Equalization Fund, to be used by the state Charter School Institute in CDE.
