**A BILL FOR AN ACT**

101      **CONCERNING THE CREATION OF THE ARIE P. TAYLOR SICKLE CELL**  
102              **DISEASE OUTREACH PROGRAM TO PROVIDE SUPPORT TO**  
103              **INDIVIDUALS LIVING WITH SICKLE CELL DISEASE, AND, IN**  
104              **CONNECTION THEREWITH, MAKING AN APPROPRIATION.**

**Bill Summary**

The bill creates the Arie P. Taylor sickle cell disease outreach program (outreach program) in the department of public health and environment (department). To implement the outreach program, the bill

requires the department, subject to available appropriations, to contract with one or more community-based nonprofit organizations (outreach organizations) to provide outreach and support services in the community to individuals living with sickle cell disease and their families.

The department shall contract with a third-party entity (administrator) to solicit applicants and administer the outreach program. On or before January 1, 2025, the department shall select one or more outreach organizations to implement the outreach program and shall give priority to community organizations with experience in providing services and support to the sickle cell community and that meet other criteria in the bill.

The outreach program may include informal counseling and health guidance, direction and support to individuals and their families in locating and accessing services in the community, outreach concerning activities and programs available to individuals and families living with sickle cell disease, peer support and referrals, advocacy regarding the interests of the sickle cell disease community, referrals for screening, and other services and support identified by the department.

The department shall approve the services provided through a contract and may consult with the university of Colorado school of medicine's sickle-cell anemia treatment and research center to identify needed services and supports.

Prior to the expiration of a contract, the outreach organization, in conjunction with the administrator, shall prepare and submit a written report to the department describing the impact of the outreach program provided under the contract, and the department shall provide the report to certain committees of the general assembly.

The bill repeals the outreach program after 5 years.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2           **SECTION 1.** In Colorado Revised Statutes, **add** 25-1.5-121 as  
3 follows:

4           **25-1.5-121. Arie P. Taylor sickle cell disease outreach program**  
5 **- contracts - administration - report - legislative declaration -**  
6 **definitions - repeal.** (1) THE GENERAL ASSEMBLY FINDS AND DECLARES  
7 THAT:

8           (a) SICKLE-CELL ANEMIA IS A GENETIC DISORDER OF THE  
9 HEMOGLOBIN IN RED BLOOD CELLS THAT CAUSES RED BLOOD CELLS THAT

1 CARRY OXYGEN TO STICK TOGETHER AFTER THE OXYGEN IS RELEASED,  
2 CAUSING BLOCKAGES IN THE SMALL BLOOD VESSELS;

3 (b) THE MAIN SYMPTOMS OF SICKLE-CELL ANEMIA ARE ANEMIA  
4 ANDEPISODES OF SEVERE PAIN CAUSED BY THE BLOCKAGES IN THE SMALL  
5 BLOOD VESSELS; OVER TIME, PEOPLE WITH SICKLE-CELL ANEMIA ARE  
6 INCREASINGLY AT RISK OF OTHER HEALTH COMPLICATIONS, AND THE  
7 DISORDER DAMAGES THEIR ORGANS;

8 (c) ACCORDING TO THE 2022-23 "COLORADO SICKLE CELL STATE  
9 ACTION PLAN" PREPARED BY THE COLORADO SICKLE CELL TREATMENT  
10 AND RESEARCH CENTER AT THE UNIVERSITY OF COLORADO SCHOOL OF  
11 MEDICINE, APPROXIMATELY FOUR HUNDRED FIFTY PEOPLE IN COLORADO  
12 ARE LIVING WITH SICKLE-CELL ANEMIA, ALTHOUGH THIS NUMBER LIKELY  
13 UNDERCOUNTS THE POPULATION LIVING WITH SICKLE CELL DISEASE;

14 (d) DUE TO THE EFFECTS OF SICKLE CELL DISEASE, INCLUDING  
15 EPISODES OF DEBILITATING PAIN, MANY INDIVIDUALS LIVING WITH  
16 SICKLE-CELL ANEMIA AND THEIR FAMILIES NEED SERVICES AND SUPPORT  
17 IN THE COMMUNITY TO MANAGE THEIR HEALTH CONDITION AND DAILY  
18 LIVES;

19 (e) ARIE PARKS TAYLOR WAS THE FIRST AFRICAN AMERICAN  
20 WOMAN TO SERVE AS A WOMEN IN THE AIR FORCE, "WAF", CLASSROOM  
21 INSTRUCTOR AND OFFICER; TO BE ELECTED TO SERVE IN THE HOUSE OF  
22 REPRESENTATIVES OF THE COLORADO GENERAL ASSEMBLY; TO SERVE AS  
23 THE CLERK AND RECORDER FOR THE CITY AND COUNTY OF DENVER OR  
24 ANY COUNTY IN COLORADO; AND TO SERVE AS THE CHIEF CLERK OF THE  
25 DENVER ELECTION COMMISSION;

26 (f) PASSIONATE ABOUT THE CONCERNS OF INDIVIDUALS LIVING  
27 WITH SICKLE-CELL ANEMIA, DURING HER TIME IN THE GENERAL ASSEMBLY

1 REPRESENTATIVE TAYLOR SPONSORED LEGISLATION THAT CREATED THE  
2 SICKLE-CELL ANEMIA TREATMENT AND RESEARCH CENTER AT THE  
3 UNIVERSITY OF COLORADO SCHOOL OF MEDICINE, WHICH PROVIDES  
4 SUPPORT AND TREATMENT FOR INDIVIDUALS WITH SICKLE CELL DISEASE

14 SECTION.

21 (4) (a) THE DEPARTMENT SHALL SOLICIT APPLICATIONS FROM  
22 COMMUNITY-BASED NONPROFIT ORGANIZATIONS THAT ARE CAPABLE OF

24 (b) (I) ON OR BEFORE JANUARY 1, 2025, THE DEPARTMENT SHALL  
25 CONTRACT WITH ONE OR MORE COMMUNITY-BASED NONPROFIT  
26 ORGANIZATIONS \_\_\_\_\_ TO PROVIDE COMMUNITY-BASED SERVICES AND  
27 SUPPORT TO INDIVIDUALS LIVING WITH SICKLE CELL DISEASE AND THEIR

1 FAMILIES.

2 (II) THE GENERAL ASSEMBLY SHALL APPROPRIATE TWO HUNDRED  
3 THOUSAND DOLLARS FOR THE OUTREACH PROGRAM, WHICH AMOUNT  
4 SHALL INCLUDE ADMINISTRATIVE COSTS NOT TO EXCEED EIGHT PERCENT.

5 (c) THE DEPARTMENT SHALL DETERMINE THE INITIAL TERM OF A  
6 CONTRACT, NOT TO EXCEED TWO YEARS, AND SHALL APPROVE THE  
7 SERVICES AND SUPPORT TO BE INCLUDED IN A CONTRACT.

8 (d) IN AWARDING A CONTRACT, THE DEPARTMENT SHALL GIVE  
9 PRIORITY TO A COMMUNITY-BASED NONPROFIT ORGANIZATION THAT:

10 (I) HAS A MINIMUM OF TEN YEARS' EXPERIENCE IN PROVIDING  
11 SERVICES AND SUPPORT IN COLORADO TO INDIVIDUALS LIVING WITH  
12 SICKLE CELL DISEASE AND THEIR FAMILIES, SPECIFICALLY IN THE DENVER  
13 METROPOLITAN AREA OR COLORADO SPRINGS, WHICH AREAS OF THE  
14 STATE HAVE THE HIGHEST NUMBER OF INDIVIDUALS LIVING WITH SICKLE  
15 CELL DISEASE IN COLORADO;

16 (II) HAS EXPERIENCE PROVIDING THE SERVICES AND SUPPORT  
17 DESCRIBED IN SUBSECTION (5)(a) OF THIS SECTION; AND

18 (III) IS ENGAGED IN FUNDRAISING FOR AND RAISING AWARENESS  
19 OF THE NEEDS OF INDIVIDUALS LIVING WITH SICKLE CELL DISEASE AND  
20 THEIR FAMILIES AND MAINTAINS A NETWORK OF PERSONS ABLE TO  
21 PROVIDE PEER ASSISTANCE AND RESOURCES TO THOSE INDIVIDUALS.

22 (5) (a) DEPENDING UPON \_\_\_\_\_ THE NEEDS TO BE ADDRESSED  
23 THROUGH A CONTRACT, THE COMMUNITY-BASED SERVICES AND SUPPORT  
24 PROVIDED THROUGH THE OUTREACH PROGRAM MAY INCLUDE THE  
25 FOLLOWING SERVICES AND SUPPORT PROVIDED BY A COMMUNITY-BASED  
26 NONPROFIT ORGANIZATION OR BY COMMUNITY HEALTH WORKERS OR  
27 SOCIAL WORKERS EMPLOYED BY THE COMMUNITY-BASED NONPROFIT

1 ORGANIZATION:

2 (I) CULTURALLY APPROPRIATE HEALTH EDUCATION AND  
3 INFORMATION CONCERNING SICKLE CELL DISEASE AND LIVING WITH SICKLE  
4 CELL DISEASE;

5 (II) INFORMAL COUNSELING AND GUIDANCE ON HEALTH  
6 BEHAVIORS;

7 (III) DIRECTION AND SUPPORT TO INDIVIDUALS AND THEIR  
8 FAMILIES IN LOCATING AND ACCESSING SERVICES IN THE COMMUNITY TO  
9 ADDRESS THEIR NEEDS, INCLUDING NONMEDICAL NEEDS SUCH AS HOUSING,  
10 FOOD, EDUCATION, TRANSPORTATION, EMPLOYMENT, LEGAL SERVICES,  
11 AND OTHER SUPPORT;

12 (IV) OUTREACH TO THE SICKLE CELL DISEASE COMMUNITY  
13 CONCERNING ACTIVITIES AND PROGRAMS AVAILABLE TO INDIVIDUALS  
14 LIVING WITH THE EFFECTS OF SICKLE CELL DISEASE AND THEIR FAMILIES;

15 (V) PEER SUPPORT SERVICES AND REFERRALS FOR INDIVIDUALS  
16 AND FAMILIES LIVING WITH SICKLE CELL DISEASE IN THE LOCAL  
17 COMMUNITY;

18 (VI) ADVOCACY REGARDING THE INTERESTS OF THE SICKLE CELL  
19 DISEASE COMMUNITY THROUGH PARTNERSHIPS WITH THE GENERAL  
20 PUBLIC, STATE AND LOCAL GOVERNMENT ENTITIES, HEALTH-CARE  
21 PROVIDERS, AND OTHER COMMUNITY-BASED ORGANIZATIONS;

22 (VII) REFERRALS FOR SICKLE-CELL ANEMIA SCREENING; AND

23 (VIII) ANY OTHER SERVICES AND SUPPORT AS DETERMINED BY THE  
24 DEPARTMENT.

25 (b) IN DETERMINING THE SERVICES AND SUPPORT INCLUDED IN A  
26 CONTRACT, THE DEPARTMENT MAY CONSULT WITH THE SICKLE-CELL  
27 ANEMIA TREATMENT AND RESEARCH CENTER, CREATED IN SECTION

1 23-21-203, TO IDENTIFY THE COMMUNITY-BASED SERVICES AND SUPPORT  
2 THAT IS LIKELY TO HAVE THE GREATEST IMPACT ON THE INDIVIDUALS AND  
3 FAMILIES SERVED THROUGH THE OUTREACH PROGRAM GIVEN THE AMOUNT  
4 AND DURATION OF THE CONTRACT.

5 (6) (a) PRIOR TO THE EXPIRATION OF A CONTRACT, A  
6 COMMUNITY-BASED NONPROFIT ORGANIZATION IMPLEMENTING THE  
7 OUTREACH PROGRAM SHALL PREPARE AND SUBMIT A WRITTEN REPORT TO  
8 THE DEPARTMENT DESCRIBING:

9 (I) THE TYPE AND AMOUNT OF SERVICES AND SUPPORT PROVIDED  
10 TO THE COMMUNITY PURSUANT TO THE OUTREACH PROGRAM;

11 (II) THE NUMBER OF INDIVIDUALS AND FAMILIES IMPACTED  
12 THROUGH THE SERVICES AND SUPPORT;

13 (III) THE CHARACTERISTICS OF THE INDIVIDUALS RECEIVING  
14 SERVICES AND SUPPORT, INCLUDING WHETHER THE SERVICES OR SUPPORT  
15 WAS PROVIDED TO ADULTS OR CHILDREN WITH SICKLE CELL DISEASE OR  
16 THEIR FAMILY MEMBERS, BUT EXCLUDING PERSONALLY IDENTIFYING  
17 INFORMATION REGARDING THE INDIVIDUALS; AND

18 (IV) THE LOCATION WHERE THE SERVICES AND SUPPORT WAS  
19 PROVIDED.

20 (b) THE DEPARTMENT SHALL PROVIDE THE REPORT TO THE HOUSE  
21 OF REPRESENTATIVES HEALTH AND HUMAN SERVICES COMMITTEE AND  
22 THE SENATE HEALTH AND HUMAN SERVICES COMMITTEE, OR THEIR  
23 SUCCESSOR COMMITTEES. THE DEPARTMENT MAY INCLUDE WITH THE  
24 REPORT INFORMATION KNOWN TO THE DEPARTMENT CONCERNING THE  
25 OUTCOMES OF THE SERVICES AND SUPPORT PROVIDED, AS WELL AS OTHER  
26 RELEVANT INFORMATION CONCERNING THE IMPACT OF THE OUTREACH  
27 PROGRAM ON INDIVIDUALS LIVING WITH SICKLE CELL DISEASE AND THEIR

1 FAMILIES.

2 (7) THIS SECTION IS REPEALED, EFFECTIVE JULY 1, 2030.

3 **SECTION 2. Appropriation.** For the 2024-25 state fiscal year,  
4 \$200,000 is appropriated to the department of public health and  
5 environment for use by the division of administration and support. This  
6 appropriation is from the general fund and is based on an assumption that  
7 the division will require an additional 0.1 FTE. To implement this act, the  
8 division may use this appropriation for the Arie P. Taylor sickle cell  
9 disease outreach program.

10 **SECTION 3. Safety clause.** The general assembly finds,  
11 determines, and declares that this act is necessary for the immediate  
12 preservation of the public peace, health, or safety or for appropriations for  
13 the support and maintenance of the departments of the state and state  
14 institutions.
