A BILL FOR AN ACT

101 **CONCERNING INCLUDING CERTAIN SPECIES UNDER THE AUTHORITY OF**
102 **THE STATE AGENCIES THAT REGULATE PARKS AND WILDLIFE,**
103 **AND, IN CONNECTION THEREWITH, MAKING AN APPROPRIATION.**

Bill Summary

The bill adds rare plants and invertebrates to the species that may be studied and conserved under the current "Nongame, Endangered, or Threatened Species Conservation Act", which is renamed the "Nongame, Endangered, or Threatened Wildlife and Rare Plant Conservation Act". The general assembly is required to make a general fund appropriation to

study invertebrates.

Imperiled or potentially imperiled plants are added to the species conservation trust fund, and this addition allows the money in the fund to be spent for conservation of these plants.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1. Legislative declaration.** (1) The general assembly
3 finds and declares that:

4 (a) Colorado's policy is to protect and enhance biodiversity
5 because biodiversity is necessary for ecosystem health; supports
6 agricultural productivity by aiding pollination, pest control, and soil
7 fertility; and increases ecosystem resilience to drought and extreme
8 weather events;

9 (b) Healthy ecosystems underpin delivery of water supplies and
10 water quality and guard against water-related hazards and disasters;

11 (c) Studies show that 34% of plant species and 40% of animal
12 species may become extinct and 41% of ecosystems may collapse;

13 (d) Invertebrates provide vital ecosystem services, including
14 pollination, pest control, nutrient cycling, and sustenance for wildlife;

15 (e) Without conservation, invertebrates will continue to decline,
16 likely having profound effects on the environment, humans, and wildlife;

17 (f) Native rare plants are essential to both wildlife and humans,
18 and they contribute to clean air and water, carbon sequestration, food
19 sources, healthy ecosystems, and wildlife habitat;

20 (g) The state wildlife action plan identifies 75 invertebrates and
21 117 rare plants as species of greatest conservation need, over half of
22 which are endemic to Colorado;

23 (h) Information on habitats, threats, and conservation needs is

1 sorely lacking for Colorado's invertebrate and native rare plant species;

2 (i) With a few exceptions, Colorado parks and wildlife does not
3 have statutory authority over invertebrate species, nor does any state
4 agency have oversight of native rare plants;

5 (j) Lack of data limits Colorado's ability to assess the status of,
6 threats to, and conservation needs of invertebrates and rare plants;

7 (k) Creating programs designed to support conservation of native
8 rare plants and invertebrates can lessen the likelihood that the species will
9 be added to federal threatened or endangered lists;

10 (l) Addressing data gaps and creating voluntary conservation
11 programs for native rare plants and invertebrates can affect federal listing
12 decisions, which undercut private land management with regulations; and

13 (m) Authorizing surveys and investigations on these species
14 allows the state to fill data gaps; it does not grant the state the authority
15 to regulate the take of these species without further legislation.

16 (2) Therefore, the general assembly determines that the parks and
17 wildlife division should study and determine the conservation needs of
18 native rare plants and invertebrates and implement voluntary programs to
19 conserve and protect them.

20 **SECTION 2.** In Colorado Revised Statutes, 33-1-102, **add** (28.3)
21 and (37.5) as follows:

22 **33-1-102. Definitions.** As used in this title 33, unless the context
23 otherwise requires:

24 (28.3) "NATIVE PLANT" MEANS A PLANT SPECIES THAT IS
25 INDIGENOUS TO THE STATE OF COLORADO.

26 (37.5) "RARE PLANTS" MEANS NATIVE PLANTS THAT ARE AT RISK
27 OF EXTINCTION OR ELIMINATION ACROSS THE ENTIRETY OF THEIR

1 DISTRIBUTION DUE TO RESTRICTED RANGE, FEW POPULATIONS OR
2 OCCURRENCES, STEEP DECLINES, OR SEVERE THREATS.

3 **SECTION 3.** In Colorado Revised Statutes, **amend** 33-2-101 as
4 follows:

5 **33-2-101. Short title.** ~~This article shall be known and may be~~
6 ~~cited as~~ THE SHORT TITLE OF THIS ARTICLE 2 IS the "Nongame,
7 Endangered, or Threatened ~~Species~~ WILDLIFE AND RARE PLANT
8 Conservation Act".

9 **SECTION 4.** In Colorado Revised Statutes, **amend** 33-2-102 as
10 follows:

11 **33-2-102. Legislative declaration.** (1) The general assembly
12 finds and declares that:

13 (a) It is the policy of this state to manage all nongame wildlife,
14 recognizing the private property rights of individual property owners, for
15 human enjoyment and welfare, for scientific purposes, and to ensure their
16 perpetuation as members of ecosystems; ~~that~~

17 (b) Species or subspecies of wildlife indigenous to this state ~~which~~
18 THAT may be found to be endangered or threatened within the state should
19 be accorded protection in order to maintain and enhance their numbers to
20 the extent possible; ~~that~~

21 (c) This state should assist in the protection of species or
22 subspecies of wildlife ~~which~~ THAT are deemed to be endangered or
23 threatened elsewhere; and ~~that~~

24 (d) THE GENERAL ASSEMBLY SHOULD MAKE adequate funding ~~be~~
25 ~~made~~ available to the division annually by appropriations from the
26 general fund.

27 (2) THE GENERAL ASSEMBLY ALSO FINDS AND DECLARES THAT:

1 (a) RARE PLANTS AND INVERTEBRATES ARE NECESSARY ELEMENTS
2 OF HEALTHY AND RESILIENT ECOSYSTEMS;

3 (b) IT IS THE POLICY OF THIS STATE TO:

4 (I) PROTECT AND ENHANCE BIODIVERSITY AND RESILIENT
5 ECOSYSTEMS IN THE FACE OF POPULATION GROWTH, DEVELOPMENT, AND
6 CLIMATE CHANGE;

7 (II) PROTECT AND CONSERVE RARE PLANTS AND INVERTEBRATES
8 AS MEMBERS OF ECOSYSTEMS;

9 (III) SUPPORT THE WILDLIFE THAT DEPENDS ON RARE PLANTS AND
10 INVERTEBRATES; AND

11 (IV) PREVENT THE DECLINE OF RARE PLANTS AND INVERTEBRATES
12 BEFORE THEIR CONTINUED EXISTENCE IN THE STATE IS IMPERILLED;

13 (c) THE DIVISION SHOULD STUDY AND DETERMINE THE
14 CONSERVATION NEEDS OF RARE PLANTS AND INVERTEBRATES FOUND IN
15 THIS STATE AND IMPLEMENT VOLUNTARY PROGRAMS TO PROTECT THESE
16 SPECIES.

17 **SECTION 5.** In Colorado Revised Statutes, **add** 33-2-104.5 and
18 33-2-104.6 as follows:

19 **33-2-104.5. Investigations and surveys of rare plants - repeal.**

20 (1) THE DIVISION SHALL CONDUCT INVESTIGATIONS AND SURVEYS OF
21 RARE PLANTS TO OBTAIN INFORMATION ABOUT POPULATION,
22 DISTRIBUTION, LIMITING FACTORS, AND OTHER ECOLOGICAL DATA IN
23 ORDER TO DETERMINE APPROPRIATE CONSERVATION AND MANAGEMENT
24 MEASURES THAT ENSURE THE CONTINUED ABILITY OF RARE PLANTS TO
25 PERPETUATE THEMSELVES.

26 (2) THE DIVISION MAY UNDERTAKE VOLUNTARY PROGRAMS
27 DESIGNED TO CONSERVE, PROTECT, AND PERPETUATE RARE PLANTS.

1 (3) (a) BEGINNING IN JANUARY 2026, AND IN JANUARY EVERY
2 YEAR THEREAFTER, THE DEPARTMENT SHALL INCLUDE, AS PART OF ITS
3 PRESENTATION DURING ITS "SMART ACT" HEARING REQUIRED BY SECTION
4 2-7-203, INFORMATION CONCERNING THE INVESTIGATIONS CONDUCTED IN
5 ACCORDANCE WITH SUBSECTION (1) OF THIS SECTION.

6 (b) THIS SUBSECTION (3) IS REPEALED, EFFECTIVE JUNE 30, 2029.

7 **33-2-104.6. Investigations and surveys of invertebrates -**
8 **appropriation - repeal.** (1) WHEN THE DIVISION DETERMINES
9 APPROPRIATE, THE DIVISION SHALL CONDUCT INVESTIGATIONS AND
10 SURVEYS OF INVERTEBRATES TO OBTAIN INFORMATION ABOUT
11 POPULATION, DISTRIBUTION, HABITAT NEEDS, LIMITING FACTORS, AND
12 OTHER BIOLOGICAL AND ECOLOGICAL DATA IN ORDER TO DETERMINE
13 APPROPRIATE CONSERVATION AND MANAGEMENT MEASURES THAT ENSURE
14 THE CONTINUED ABILITY OF INVERTEBRATES TO PERPETUATE
15 THEMSELVES.

16 (2) THE DIVISION MAY UNDERTAKE VOLUNTARY PROGRAMS
17 DESIGNED TO CONSERVE, PROTECT, AND PERPETUATE INVERTEBRATES.

18 (3) (a) BEGINNING IN JANUARY 2026, AND IN JANUARY EVERY
19 YEAR THEREAFTER, THE DEPARTMENT SHALL INCLUDE, AS PART OF ITS
20 PRESENTATION DURING ITS "SMART ACT" HEARING REQUIRED BY
21 SECTION 2-7-203, INFORMATION CONCERNING THE INVESTIGATIONS
22 CONDUCTED IN ACCORDANCE WITH SUBSECTION (1) OF THIS SECTION.

23 (b) THIS SUBSECTION (3) IS REPEALED, EFFECTIVE JUNE 30, 2029.

24 (4) THE GENERAL ASSEMBLY SHALL APPROPRIATE SUFFICIENT
25 MONEY TO IMPLEMENT THIS SECTION FROM:

- 26 (a) THE GENERAL FUND; OR
- 27 (b) THE WILDLIFE CASH FUND CREATED IN SECTION 33-1-112;

1 EXCEPT THAT MONEY FROM THE SALE OF HUNTING AND FISHING LICENSES
2 IS NOT AVAILABLE FOR APPROPRIATION TO IMPLEMENT THIS SECTION.

4 **SECTION 6.** In Colorado Revised Statutes, 33-2-106, **amend** (1)
5 and (2) as follows:

6 **33-2-106. Management programs.** (1) The division shall
7 establish ~~such~~ programs, including acquisition of land or aquatic habitat,
8 ~~as~~ THAT are deemed necessary for management of nongame, endangered,
9 or threatened wildlife OR RARE PLANTS.

10 (2) In carrying out programs authorized by this section, the
11 division may enter into agreements with federal agencies or political
12 subdivisions of this state or with private persons for administration and
13 management of any area established under this section or utilized for
14 management of nongame, endangered, or threatened wildlife OR RARE
15 PLANTS.

16 **SECTION 7.** In Colorado Revised Statutes, 24-33-111, **amend**
17 (1), (3)(b) introductory portion, (3)(b)(II)(C), and (3)(b)(II)(D) as follows:

18 **24-33-111. Conservation of native species - fund created.**

19 (1) **Legislative declaration.** The general assembly ~~hereby~~ recognizes the
20 importance of conserving native WILDLIFE AND PLANT species that have
21 been listed as threatened or endangered under state or federal law or are
22 candidate species or are likely to become candidate species as determined
23 by the United States fish and wildlife service. The general assembly
24 ~~hereby~~ declares and determines that the Colorado department of natural
25 resources and the division of parks and wildlife are responsible for the
26 development, implementation, or approval of appropriate programs to
27 address the conservation of ~~such~~ THE species and for negotiating

1 agreements with federal agencies and other states to avoid regulatory
2 conflicts pursuant to section 24-33-103.

3 **(3) Species conservation eligibility list and annual report.**

4 (b) ~~Funding shall be distributed by~~ The executive director of the
5 department of natural resources SHALL DISTRIBUTE FUNDING among
6 projects included in the species conservation eligibility list for the
7 following purposes:

8 (II) Studies and programs established or approved by the division
9 of parks and wildlife and the executive director of the department of
10 natural resources regarding:

11 (C) Scientific research relating to listing or delisting any WILDLIFE
12 OR PLANT species; or

13 (D) If a WILDLIFE OR PLANT species that is not on the federal
14 endangered or threatened species list is proposed to be added to the state
15 endangered or threatened species list, the evaluation of the species
16 pursuant to this ~~sub-subparagraph (D)~~ SUBSECTION (3)(b)(II)(D) shall
17 include: Scientific evaluation of genetic data that proves the species is a
18 separate and distinct species in the ecosystem; evaluation of the species
19 habitat that encompasses the entire geographic area of the species habitat,
20 not just portions of ~~such~~ THE habitat; and the reliable scientific baseline
21 data used to ascertain that the number of the species in the habitat is
22 rapidly declining over time.

23 **SECTION 8. Appropriation.** For the 2024-25 state fiscal year,
24 \$774,788 is appropriated to the department of natural resources for use
25 by the division of parks and wildlife. This appropriation is from the
26 wildlife cash fund created in section 33-1-112 (1)(a), C.R.S., and is based
27 on an assumption that the division will require an additional 4.0 FTE. To

1 implement this act, the division may use this appropriation for wildlife
2 operations.

3 **SECTION 9. Act subject to petition - effective date.** This act
4 takes effect at 12:01 a.m. on the day following the expiration of the
5 ninety-day period after final adjournment of the general assembly; except
6 that, if a referendum petition is filed pursuant to section 1 (3) of article V
7 of the state constitution against this act or an item, section, or part of this
8 act within such period, then the act, item, section, or part will not take
9 effect unless approved by the people at the general election to be held in
10 November 2024 and, in such case, will take effect on the date of the
11 official declaration of the vote thereon by the governor.
