1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, 2-3-1203, **repeal**
3 **(15)(a)(II); and add (25)(a)(III)** as follows:

4 **2-3-1203. Sunset review of advisory committees - legislative**
5 **declaration - definition - repeal.** (15) (a) The following statutory
6 authorizations for the designated advisory committees are scheduled for
7 repeal on September 1, 2024:

10 (25) (a) The following statutory authorizations for the designated

15 **SECTION 2.** In Colorado Revised Statutes, **amend 33-33-113** as
16 **follows:**

17 **33-33-113. Legislative review - termination.** (1) The council
18 terminates on September 1, ~~2024~~ 2034, unless the general assembly votes
19 to renew the legislative mandate of this ~~article~~ ARTICLE 33. Absent a vote
20 to renew the legislative mandate of this ~~article~~ ARTICLE 33, the council
21 shall cease all operations within a twelve-month period after September
22 1, ~~2024~~ 2034.

23 (2) Prior to the termination, the department of regulatory agencies

1 shall review the advisory committee as provided for in section 2-3-1203.

3 **SECTION 3. Act subject to petition - effective date.** This act
4 takes effect at 12:01 a.m. on the day following the expiration of the
5 ninety-day period after final adjournment of the general assembly; except
6 that, if a referendum petition is filed pursuant to section 1 (3) of article V
7 of the state constitution against this act or an item, section, or part of this
8 act within such period, then the act, item, section, or part will not take
9 effect unless approved by the people at the general election to be held in
10 November 2024 and, in such case, will take effect on the date of the
11 official declaration of the vote thereon by the governor.
