**A BILL FOR AN ACT**

101 **CONCERNING PRICE GOUGING IN HOUSING RENTAL PRICES DURING A**  
102 **DECLARED DISASTER.**

**Bill Summary**

The bill prohibits price gouging in the provision of housing during a declared disaster.

1           **SECTION 1.** In Colorado Revised Statutes, **add 6-1-735** as  
2 follows:

3           **6-1-735. Rental price gouging during declared disaster**  
4 **prohibited**      - **definitions.** (1) A PERSON ENGAGES IN AN UNFAIR AND  
5 UNCONSCIONABLE ACT OR PRACTICE WHEN, DURING A DISASTER PERIOD  
6 AND WITHIN THE DESIGNATED AREA IF A DISASTER DECLARATION  
7 SPECIFICALLY DECLARES A MATERIAL DECREASE IN RESIDENTIAL HOUSING  
8 UNITS, THE PERSON ENGAGES IN PRICE GOUGING IN THE PROVISION OF OR  
9 OFFER TO PROVIDE RENT-BASED HOUSING.

10           (2) (a) A VIOLATION OF THIS SECTION MAY BE ENFORCED BY THE  
11 ATTORNEY GENERAL OR THE DISTRICT ATTORNEY WITH JURISDICTION  
12 OVER THE CONDUCT AT ISSUE OR BY AN AGGRIEVED PARTY.

13           (b) NOTWITHSTANDING SECTION 6-1-113, A TENANT AFFECTED BY  
14 A VIOLATION OF THIS SECTION MAY BRING A CIVIL ACTION TO RESTRAIN  
15 FURTHER VIOLATIONS AND TO RECOVER DAMAGES, COSTS, AND  
16 REASONABLE ATTORNEY FEES. IF A COURT OR JURY FINDS THAT A  
17 VIOLATION OCCURRED, THE TENANT MUST BE AWARDED STATUTORY  
18 DAMAGES EQUAL TO THE TENANT'S ACTUAL DAMAGES, ATTORNEY FEES,  
19 AND COSTS THAT MAY BE OWED.

20           (3) AS USED IN THIS SECTION:

21           (a) "DESIGNATED AREA" MEANS A SPECIFIC GEOGRAPHIC AREA  
22 IDENTIFIED IN A DISASTER DECLARATION.

23           (b) "DISASTER" HAS THE SAME MEANING AS SET FORTH IN SECTION  
24 24-33.5-703 (3).

25           (c) "DISASTER DECLARATION" MEANS A DECLARATION OF ONE OF  
26 THE FOLLOWING, WHICH RESULTS IN A MATERIAL DECREASE IN  
27 RESIDENTIAL HOUSING UNITS:

1 (I) A NATIONAL EMERGENCY BY THE PRESIDENT OF THE UNITED  
2 STATES PURSUANT TO THE "NATIONAL EMERGENCIES ACT", 50 U.S.C.  
3 SEC. 1601 ET SEQ., AS AMENDED; OR

4 (II) A DISASTER EMERGENCY BY THE GOVERNOR PURSUANT TO  
5 SECTION 24-33.5-704 (4).

6 (d) "DISASTER PERIOD" MEANS THE DATE A DISASTER  
7 DECLARATION BEGINS AND CONTINUING FOR ONE YEAR AFTER THE DATE  
8 OF THE INITIAL DISASTER.

9 (e) "PRICE GOUGING" MEANS:

10 (I) FOR DWELLINGS THAT WERE ON THE MARKET IMMEDIATELY  
11 PRECEDING THE DISASTER, AN INCREASE IN RENT FOR AN INDIVIDUAL  
12 DWELLING IN A DESIGNATED AREA THAT IS MORE THAN THE GREATER OF  
13 THE PERCENTAGE OF THE RENT INCREASE FOR THE IMMEDIATELY  
14 PRECEDING YEAR OR TEN PERCENT COMPARED TO THE RENT FOR THE  
15 INDIVIDUAL DWELLING IMMEDIATELY PRECEDING THE DISASTER; OR

16 (II) FOR DWELLINGS THAT WERE NOT ON THE MARKET  
17 IMMEDIATELY PRECEDING THE DISASTER, RENT FOR AN INDIVIDUAL  
18 DWELLING IN A DESIGNATED AREA THAT IS MORE THAN THE GREATER OF  
19 THE PERCENTAGE OF THE RENT INCREASE FOR THE IMMEDIATELY  
20 PRECEDING YEAR OR TEN PERCENT HIGHER THAN RENT FOR SIMILAR  
21 DWELLINGS LOCATED IN THE DESIGNATED AREA AND THAT WERE ON THE  
22 MARKET IMMEDIATELY PRECEDING THE DISASTER.

23 **SECTION 2. Safety clause.** The general assembly finds,  
24 determines, and declares that this act is necessary for the immediate  
25 preservation of the public peace, health, or safety or for appropriations for  
26 the support and maintenance of the departments of the state and state  
27 institutions.
