A BILL FOR AN ACT

101 CONCERNING THE CONTINUATION OF THE COLORADO COMMISSION  
102 FOR THE DEAF, HARD OF HEARING, AND DEAFBLIND, AND, IN  
103 CONNECTION THEREWITH, IMPLEMENTING THE  
104 RECOMMENDATIONS CONTAINED IN THE 2023 SUNSET REPORT  
105 BY THE DEPARTMENT OF REGULATORY AGENCIES.

Bill Summary

of regulatory agencies' 2023 sunset review and report on the Colorado commission for the deaf, hard of hearing, and deafblind (commission) by:

- Continuing the commission for 7 years, until 2031;
- Establishing a permanent state auxiliary services program; and
- Changing the name of the deafblind citizens council to the deafblind advisory council.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2           **SECTION 1.** In Colorado Revised Statutes, 26-21-108, **amend**  
3 (1) as follows:

4           **26-21-108. Repeal of article - sunset review.** (1) This article  
5 ARTICLE 21 is repealed, effective September 1, ~~2024~~ 2031.

6           **SECTION 2.** In Colorado Revised Statutes, 24-34-104, **repeal**  
7 (25)(a)(XII); and **add** (32)(a)(XI) as follows:

8           **24-34-104. General assembly review of regulatory agencies**  
9 **and functions for repeal, continuation, or reestablishment - legislative**  
10 **declaration - repeal.** (25) (a) The following agencies, functions, or both,  
11 are scheduled for repeal on September 1, 2024:

12           (XII) ~~The Colorado commission for the deaf, hard of hearing, and~~  
13 ~~deafblind created in article 21 of title 26;~~

14           (32) (a) The following agencies, functions, or both, are scheduled  
15 for repeal on September 1, 2031:

16           (XI) THE COLORADO COMMISSION FOR THE DEAF, HARD OF  
17 HEARING, AND DEAFBLIND CREATED IN ARTICLE 21 OF TITLE 26.

18           **SECTION 3.** In Colorado Revised Statutes, 26-21-103, **amend**  
19 (1); **repeal** (2); and **add** (1.5) as follows:

20           **26-21-103. Definitions.** As used in this article 21, unless the  
21 context otherwise requires:

22           (1) ~~"Auxiliary services" means those aids and services that assist~~

1 ~~in effective communication with a person who is deaf, hard of hearing,~~  
2 ~~or deafblind, including but not limited to:~~

3 ~~(a) The services of a qualified interpreter as defined by section~~  
4 ~~13-90-202 (8);~~

5 ~~(b) The provision of a qualified communication access realtime~~  
6 ~~translation (CART) reporter;~~

7 ~~(c) The provision of an assistive listening device; or~~

8 ~~(d) The acquisition or modification of equipment or devices to~~  
9 ~~assist in effective communication with a person who is deaf, hard of~~  
10 ~~hearing, or deafblind. "ADVISORY COUNCIL" MEANS THE COLORADO~~  
11 ~~DEAFBLIND ADVISORY COUNCIL APPOINTED BY THE COMMISSION IN~~  
12 ~~ACCORDANCE WITH SECTION 26-21-105 (2)(f).~~

13 (1.5) "AUXILIARY SERVICES" MEANS THOSE AIDS AND SERVICES  
14 THAT ASSIST IN EFFECTIVE COMMUNICATION WITH A PERSON WHO IS DEAF,  
15 HARD OF HEARING, OR DEAFBLIND. "AUXILIARY SERVICES" ARE ALSO  
16 KNOWN AS "COMMUNICATION ACCESS SERVICES" AND MAY INCLUDE BUT  
17 ARE NOT LIMITED TO:

18 (a) THE SERVICES OF A QUALIFIED INTERPRETER AS DEFINED IN  
19 SECTION 13-90-202 (8);

20 (b) THE PROVISION OF A QUALIFIED COMMUNICATION ACCESS  
21 REALTIME TRANSLATION (CART) REPORTER;

22 (c) THE PROVISION OF AN ASSISTIVE LISTENING DEVICE; OR

23 (d) THE ACQUISITION OR MODIFICATION OF EQUIPMENT OR DEVICES  
24 TO ASSIST IN EFFECTIVE COMMUNICATION WITH A PERSON WHO IS DEAF,  
25 HARD OF HEARING, OR DEAFBLIND.

26 (2) ~~"Citizens council" means the Colorado deafblind citizens~~  
27 ~~council appointed by the commission in accordance with section~~

1 ~~26-21-105 (2)(f).~~

2 **SECTION 4.** In Colorado Revised Statutes, 26-21-105, **amend**  
3 (2)(e), (2)(f)(I), (2)(f)(II), and (2)(f)(III) introductory portion as follows:

4 **26-21-105. Appointment of commission director - commission**  
5 **procedures - advisory council - creation.** (2) (e) The commission shall  
6 encourage development and coordination of public and private agencies  
7 providing assistance to deaf, hard-of-hearing, and deafblind ~~citizens~~  
8 PERSONS.

9 (f) (I) There is ~~hereby~~ created the Colorado deafblind ~~citizens~~  
10 ADVISORY council consisting of seven members.

11 (II) The ~~citizens~~ ADVISORY council ~~will~~ SHALL advise the  
12 commission, state and local governments, and other relevant entities on  
13 how to increase competitive integrated employment as defined by IN  
14 section 8-84-301, enlarge economic opportunities, enhance independence  
15 and self-sufficiency, and improve services for deafblind persons.

16 (III) The commission shall appoint initial members to the ~~citizens~~  
17 ADVISORY council by July 1, 2019. The commission shall designate four  
18 members to serve an initial four-year term and three members to serve an  
19 initial six-year term. After the initial terms, all subsequent appointees ~~will~~  
20 serve four-year terms. The commission shall appoint a qualified person  
21 to fill any vacancy on the ~~citizens~~ ADVISORY council for the remainder of  
22 any unexpired term. The ~~citizens~~ ADVISORY council ~~must have~~ HAS the  
23 following appointees:

24 **SECTION 5.** In Colorado Revised Statutes, 26-21-106, **repeal**  
25 (5); and **add** (5.5) as follows:

26 **26-21-106. Powers, functions, and duties of commission -**  
27 **auxiliary services program - community access program - report -**

1 **rules - definitions.** (5) ~~On or before January 1, 2019, the commission~~  
2 ~~shall establish a one-year pilot program to provide auxiliary services to~~  
3 ~~state departments and agencies. The commission may continue the pilot~~  
4 ~~program in subsequent years if the commission has adequate funding to~~  
5 ~~provide auxiliary services through the pilot program. The commission~~  
6 ~~shall:~~

7 (a) ~~Identify at least two state departments or agencies to~~  
8 ~~participate in the pilot program during calendar year 2019;~~

9 (b) ~~Create a process for participating state departments or agencies~~  
10 ~~to request auxiliary services from the commission;~~

11 (c) ~~Collect data on the utilization of auxiliary services through the~~  
12 ~~pilot program; and~~

13 (d) ~~Hire an independent contractor to evaluate the pilot program~~  
14 ~~and make recommendations regarding whether to expand the program to~~  
15 ~~additional state departments and agencies. The evaluation must be based~~  
16 ~~on utilization data from the first year of the program. The evaluation must~~  
17 ~~be included in the September 1, 2020, annual report required by section~~  
18 ~~26-21-106 (1)(c).~~

19 (5.5) (a) THE COMMISSION SHALL ESTABLISH AND MAKE  
20 PERMANENT THE OPERATIONS OF THE STATE AUXILIARY SERVICES  
21 PROGRAM CREATED IN SUBSECTION (5) OF THIS SECTION AS IT EXISTED  
22 PRIOR TO THE EFFECTIVE DATE OF THIS SUBSECTION (5.5). THE  
23 COMMISSION SHALL:

24 (I) ARRANGE FOR THE PROVISION OF AUXILIARY SERVICES FOR  
25 STATE DEPARTMENTS AND AGENCIES, INCLUDING THE GOVERNOR'S OFFICE,  
26 THAT EMPLOY OR SERVE INDIVIDUALS WHO ARE DEAF, HARD OF HEARING,  
27 OR DEAFBLIND BY PERFORMING THE FOLLOWING FUNCTIONS:

1 (A) COORDINATING, ON A STATEWIDE BASIS, THE DAILY  
2 SCHEDULING OF AUXILIARY SERVICES PROVIDED TO STATE DEPARTMENTS  
3 AND AGENCIES;

4 (B) CREATING AND MANAGING EFFICIENT AND CONSISTENT  
5 PROCESSES THROUGH WHICH AN AUXILIARY SERVICES PROVIDER MAY  
6 SUBMIT REQUIRED DOCUMENTATION AND RECEIVE PAYMENT FOR  
7 AUXILIARY SERVICES PROVIDED;

8 (C) CREATING AND MANAGING A PROCESS FOR THE INTAKE AND  
9 FULFILLMENT OF REQUESTS BY STATE DEPARTMENTS AND AGENCIES FOR  
10 AUXILIARY SERVICES, INCLUDING THE IDENTIFICATION, COORDINATION,  
11 AND APPOINTMENT OF AUXILIARY SERVICES PROVIDERS TO MEET THE  
12 NEEDS OF ALL PARTIES INVOLVED IN THE PROCEEDING, EVENT, OR  
13 CIRCUMSTANCE FOR WHICH A REQUEST IS MADE;

14 (D) RESOLVING ANY ISSUES THAT MAY ARISE WITH REGARD TO  
15 AUXILIARY SERVICES IN THE STATE DEPARTMENT OR AGENCY FOR WHICH  
16 AUXILIARY SERVICES ARE PROVIDED PURSUANT TO THIS SUBSECTION (5.5);

17 (E) COMMUNICATING WITH AUXILIARY SERVICES USERS,  
18 AUXILIARY SERVICES PROVIDERS, AND APPOINTING AUTHORITIES, AS  
19 DEFINED IN SECTION 13-90-202, IN THE STATE DEPARTMENT OR AGENCY  
20 FOR WHICH AUXILIARY SERVICES ARE PROVIDED PURSUANT TO THIS  
21 SUBSECTION (5.5);

22 (F) ESTABLISHING, MONITORING, AND PUBLISHING A LIST OF CART  
23 PROVIDERS AND QUALIFIED INTERPRETERS, AS DEFINED IN SUBSECTIONS  
24 (4)(g)(II)(A) AND (4)(g)(II)(B) OF THIS SECTION, ON THE COMMISSION'S  
25 PUBLIC WEBSITE; AND

26 (G) GATHERING DATA ON THE FUNCTIONS DESCRIBED IN  
27 SUBSECTIONS (5.5)(a)(I)(A) TO (5.5)(a)(I)(F) OF THIS SECTION; AND

1           (II) CREATE AN ADVISORY COUNCIL TO MAKE RECOMMENDATIONS  
2 TO THE COMMISSION CONCERNING THE PROVISION OF AUXILIARY SERVICES  
3 TO STATE DEPARTMENTS AND AGENCIES.

4           (b) THE EXECUTIVE DIRECTOR SHALL PROMULGATE RULES FOR THE  
5 IMPLEMENTATION OF THIS SUBSECTION (5.5) IN CONSULTATION WITH, OR  
6 AS PROPOSED BY, THE COMMISSION AND THE DEAF, HARD OF HEARING, AND  
7 DEAFBLIND COMMUNITY.

8           (c) THE COMMISSION SHALL INCLUDE DATA GATHERED PURSUANT  
9 TO SUBSECTION (5.5)(a)(I)(G) OF THIS SECTION IN ITS ANNUAL REPORT  
10 REQUIRED BY SUBSECTION (1)(e) OF THIS SECTION.

11           **SECTION 6. Act subject to petition - effective date.** This act  
12 takes effect at 12:01 a.m. on the day following the expiration of the  
13 ninety-day period after final adjournment of the general assembly; except  
14 that, if a referendum petition is filed pursuant to section 1 (3) of article V  
15 of the state constitution against this act or an item, section, or part of this  
16 act within such period, then the act, item, section, or part will not take  
17 effect unless approved by the people at the general election to be held in  
18 November 2024 and, in such case, will take effect on the date of the  
19 official declaration of the vote thereon by the governor.
