CONCERNING THE DEADLINE FOR THE DEPARTMENT OF CORRECTIONS TO SUBMIT A REQUEST FOR AN APPROPRIATION RELATED TO CHANGES IN CASELOAD.

*Be it enacted by the General Assembly of the State of Colorado:* 

**SECTION 1.** In Colorado Revised Statutes, 2-3-208, **amend** (3)(b)(I) as follows:

**2-3-208.** Budget requests - amendments - supplemental appropriation requests - deadlines - definitions. (3) (b) (I) The department of education shall submit a request for a supplemental appropriation pursuant to section 22-54-106 (4)(b) to the joint budget committee by ON OR BEFORE January 15. The department of corrections and the division of youth services in the department of human services shall each submit a request for a supplemental appropriation related to changes in caseload to the joint budget committee by ON OR BEFORE January 15. The DEPARTMENT OF CORRECTIONS SHALL SUBMIT A REQUEST FOR A SUPPLEMENTAL APPROPRIATION RELATED TO CHANGES IN CASELOAD TO THE

## JOINT BUDGET COMMITTEE ON OR BEFORE JANUARY 10.

**SECTION 2.** Act subject to petition - effective date. This act takes effect at 12:01 a.m. on the day following the expiration of the ninety-day period after final adjournment of the general assembly; except that, if a referendum petition is filed pursuant to section 1 (3) of article V of the state constitution against this act or an item, section, or part of this act within such period, then the act, item, section, or part will not take effect unless approved by the people at the general election to be held in

November 2024 and, in such case, will take effect on the date of the official declaration of the vote thereon by the governor.
